IRS FORM 990

All subordinate Lodges of the Grand Lodge of Texas must file either IRS Form 990, 990 EZ, or 990-N with the U.S. Internal Revenue Service in a timely manner. It is the responsibility of the Worshipful Master to ensure that a completed IRS Form 990, 990-N, or 990 EZ, or such other form as may be hereafter defined by the IRS, in order to preserve the tax-exempt status of Lodges. The form must be filed every year on or before the 15th day of the 5th month after the close of the tax year. For example, if a Lodge tax year ends in June, its Form 990, 990-N, or 990-EZ is due by November 15 of that tax year.

It is also the responsibility of the Worshipful Master to provide the Grand Secretary's office with a copy of the Form 990, 990-N, or 990-EZ that is filed with the IRS, on or before November 15 of the tax year, and the Grand Lodge Finance Committee is directed to monitor the completion of the Forms required herein. **Please be aware that the Grand Secretary's office no longer has the ability to file 990s on your Lodge's behalf.**

MASONIC MINUTE - THE LEGEND, THE LORE, THE LAW

The Legend of the Texas Ranger begins by divine providence, in the year of 1823, Stephen F. Austin and the 'Old 300' settled an untamed land, to prosper and be free. Ten civilian soldiers called RANGERS, to protect Texas from Indian raiding parties, Each man with boundless courage, all tougher than a boot, resilient and hearty. The last brave patriots who rode into the Alamo, we call the 'Immortal 32,' Texas Rangers they were, all giving their life with Bowie, Crockett and Travis, too. The Legend bears all their names, etched in blood and tempered with hot lead, They made Texas a Republic, proud and independent, for their price of falling dead. The Lore was rooted through Jack Coffee Hays, Ben McCullough and Rip Ford, All who fought the deadly Comanche arrows and the mighty Mexican sword. Samuel Walker and Ad Gillespie gallantly surrendered their lives in Mexico, Carrying the righteous banner of freedom for Texas against the enemy and foe. Then came men cut from the same leather through and beyond the Civil War, Leander McNelly, Lee Hall, Sul Ross, Lam Sieker and many, many more. Then came the Four Great Captains, Hughes, Brooks, McDonald and Rogers. They thwarted the efforts of villains, robbers, banditos and dodgers. Through the oil patch riots, family feuds, thievery and labor strikes, They always got the job done, the kind of a thankless job no man ever likes. In modern times he has adapted but the might and mold of the Ranger never changed, Like his leather-skinned cronies of days gone by, his duty was to protect Texas as he ranged. Stan Guffey, Glenn Elliott, Joaquin Jackson, and all the endless names cast into glory, Remain a part of Texas history, like all who came before, each an integral part of the story. Surely, as long as there's a Texas there will always be Texas Rangers, no doubt, They've led us through the toughest of times and without them we can't do without. They've proved their grit and resolve with solemnity, earning their plaudits on high, Seeking no attention or adulation, their duty and honor are to what they must comply.

Courage, Determination, Dedication, Integrity, Respect, all traits of the Ranger, so true, These, the earmark of his profession, they live as few men ever could, or seldom ever do. Salute these men with dignity and gratitude, as they are the best one has ever saw,

For they are the Texas Rangers, The Legend ... The Lore ... The Law. – Duke Davis

While not all Rangers mentioned in this poem were Masons, many of them were. The strong ties between the Texas Rangers and Masons are well documented and lead to the formation of Major John B. Please remember to follow the instructions before submitting. Lodges that are applying for the Vanguard Award must have their application submitted to their District Deputy Grand Master no later than 8/31/2024. District Deputy Grand Masters must have the application submitted to the Grand Secretary's Office no later than 9/15/2024.

MONTHLY LAW READING

Article 318a. Throughout Texas, Masons volunteer to serve this great fraternity. Volunteer organizations sometimes make mistakes. The important thing is to correct those mistakes. One was recently brought to the Grand Lodge's attention.

Article 318a(4)(c)(1) reads this way in the law book:

The value of the "units" shall be valued each year at their full market value. A distribution of 5% of the value of these units shall be made to the respective Lodges.

Resolution 26, which updated Art. 318a, actually reads:

The value of the "units" shall be valued each year at their full market value. A distribution of 5% of *the average value of these units at the end of the last three years* shall be made to the respective Lodges.

Taking the average value over a three-year period makes more sense from a fiscal standpoint. In any event, the language in the law book was incorrect and has been changed in the digital version as well as the version currently at the printers. Sometimes I have to be the bearer of bad news. Here it is: this will result in a slight decrease in the endowment distribution. However, this is what the Grand West voted to do.

LAWBOOK

The 2024 version of the Law Book is now available digitally in the app and for the WM, SW, JW and Secretaries in Grand View. The printed version will be available for sale later this month. The Grand Secretary's office will be mailing out the supplemental 'Law Updates' packet to the constituent Lodges when they are received from the printer.

ENDOWMENT DISTRIBUTION

This year, the distribution amount per mature unit is **\$4.66.** The mature units are those units your lodge owned before 6/24/2023. The 6/30/2024 value per unit is **\$104.42**. Total units are the units your Lodge purchased before 6/23/2024. You will be able to compare these numbers with your Lodge's endowment amounts by generating an endowment report on Grandview. If you have issues accessing this report, please call the Grand Secretary's Office for assistance. When filling out your Lodge's Form 71, the equation you should use is the total number of endowment units owned at 6/23/2024 times the endowment unit value (total units X \$104.42). Your check amount will be the mature units times the distribution amount per mature unit (mature units X \$4.66)

A MESSAGE FROM THE GRAND TREASURER CONCERNING ANNUAL ENDOWMENT DISTRIBUTIONS

Following Bro. Choat's recent notice concerning this year's distribution from the Grand Lodge Membership Endowment Trust, I and others who are involved in making the determination have received communications from individuals and lodges expressing understandable concern over the amount which the trust will distribute. Because those concerns arise from misunderstandings, I felt that it was important to address them and in that way the concerns of the Brethren.

Virtually all the concerns that have reached me refer to Art. 318a, and more particularly, subparagraph 4 of that article which specifies how each year's distribution must be calculated. As it reads, the law would require the Membership Endowment Trust to distribute five percent of the value of the trust's assets as of June 30 of the year the distribution is made (the trust's year runs from July 1 to June 30). Were the law correctly stated the amount of the distribution for 2024 would be incorrect. Because the law isn't correctly stated in Art. 318a, the numerous letters and emails I and others have received are certainly understandable.

Because of the hard lessons learned through experience, in 2022 the Grand West passed a resolution I and then Grand Secretary, R:W: Justin Duty proposed which changed the way in which annual distributions were calculated. The change was offered as Resolution 26. I have copied a part of Resolution 26 and emphasized the relevant portion of it as follows:

Art. 318a. Endowed Membership.

- 1. Unchanged
- 2. Unchanged
- 3. Unchanged
- 4. Unchanged
- (a) Unchanged.
- (b) Unchanged.

(c) Annually, not later than the first day of August, Endowed Lodges shall receive a distribution from the Endowed Membership Fund computed as follows:

1. The value of the "units" shall be valued each year at their full market value. <u>A distribution of 5%</u> of the average value of these units at the end of the last three years shall be made to the respective Lodges. Provided the distribution does not reduce the value after distribution to below \$100.

As is clear, the change was made in 2022 from an annual distribution calculation to a three-year average. Unfortunately, as sometimes happens, the change was not incorporated into the changes to the Grand Lodge lawbook that year and the error carried over.

The reason Bro. Duty and I proposed Resolution 26 in 2022 was that experience taught that changes in economic conditions which occurred in a one-year cycle occurred too quickly and caused an outsized effect on the trust. Calculations based on short-term events had the potential to damage the trust's ability to pay distributions over the long haul. To put it another way, because the Membership Endowment Trust was intended to be a long-term investment vehicle, operating it on a short-term basis was counterproductive to its mission. Importantly, we also found that distributions based on short-term cycles would result in swings in the amount of distributions year by year which would be violent enough to cause whiplash in the finances of all but the richest lodges.


I appreciate the concerns many of you have expressed and recognize the source of the confusion which has led to them. Despite all these things, the distribution from the Grand Lodge Membership Endowment Trust for 2024 was correctly calculated in accordance with our Grand Lodge Law. I appreciate the opportunity to address your concerns and look forward to continuing to serve the Masons of Texas as your Grand Treasurer.


2024 LODGE OFFICER ANALYSIS

Brethren, this month we're looking at the new slate of officers for the coming Masonic year. I only have Grandview data, and to date, only 94% of the lodge Secretaries have entered their election and installation data into Grandview, so note that the numbers herein will change slightly as the remaining 42 lodge Secretaries enter their data.

Figure 1 shows the age of our new Worshipful Masters, divided into generations. As has been the case since 2022, the majority (now 52%) are Gen X or younger, and I expect that will continue as 57% of the Junior Wardens are Gen X or younger. As shown in Figure 2, we have 352 first-time Worshipful Masters, 175 have served once before, and the remaining have previously served two or more times.



Figures 3 and 4 show the experience of our Secretaries and Treasurers. We have 103 first-time Secretaries and 107 first-time Treasurers. Secretaries average 7 years of experience, while Treasurers average 6 years of experience in those positions. Chaplains, not shown, are our next most experienced office having served an average of 4.4 times previously.



Figures 5-8 show the Masonic experience of our Worshipful Masters, Secretaries, Treasurers, and Chaplains in terms of the number of years since they were raised. 40% of our Worshipful Masters have 8 years or less years since being raised, while our three most experienced officers average 24 years for Secretaries, 26 years for Treasurers, and 29 years for our Chaplains since being raised. We have more of the Greatest Generation serving as Chaplain than any other office.

Figure 5. Worshipful Master Years Since Raised




Figure 8. Chaplain Years Since Raised






Figure 9 shows who is serving in their first office ever. Yes, we do have a few Secretaries, one of which was raised just a year ago, serving in that office as their first ever office. We have a few serving as Senior Warden and Treasurer for their first office as well. Most, however, are starting off in the Stewards, Deacons, or Tiler roles.



Finally, a note about the Stewards. Last year, we had 378 Senior Stewards and 280 Junior Stewards installed into office. This year, on July 17th when the Grand Master sent out a Special Communication Regarding Article 278, we had 326 Senior Stewards and 254 Junior Stewards installed, and those numbers would have likely come up to last year's by the end of Installation Season. As of now, two weeks since the Special Communication, we have 496 Senior Stewards and 462 Junior Stewards entered into Grandview for this year. That's an increase of 170 and 208 installed in just

the last two weeks, and there will likely be a few more entered by Secretaries for late second installation events. Still, that's roughly 500 out of 747 lodges. Please note than a Resolution has been submitted for consideration in January to make the Stewards optional. - Zachary Haston

SECRETARY INSTRUCTIONS

The following information is intended primarily for the Secretary but may be meaningful to many of your members.

Lodge Suspense System:

Suspense Dates – Lodge Secretaries should create a suspense system (a reminder system) to alert the Lodge that certain documents are due. This list is offered as a "starter kit' for your consideration:

- **a.** January The Worshipful Master should appoint a Committee on Members in Arrears (Article 319a).
- **b.** May 31 W. B. and Brandon Carrell Award nominations may be submitted to the Grand Lodge Committee on Public Education for evaluation and recommendation to the Grand Lodge Trustees (Article 14b).
- c. Mid-June Look for the Annual Returns Format from GL. (Downloaded from the Grand View System after June 24th. Notify the GS staff if you need the returns mailed as a printout).
- **d.** June 23 Lodge elections must be completed at the last stated meeting prior to midnight of June 23 (Art. 292). Notify us of the new Lodge Officers immediately so they can be printed in the Directory of Constituent Lodges (do not wait for installation). Submission will be available on the Grand View System from May 24 through midnight June 23.
- e. June 23 Endowed Membership checks must be in the Office of the Grand Secretary by June 23 to start earning interest in order to receive returns by the next year (Art. 318a). Changes to the amount of endowments must be voted on at the same meeting as the Lodge elections, and notification to the Grand Lodge must be before June 24th. Endowed Membership applications received at the Grand Lodge on or after June 24 must be for the amount that the Lodge reported.
- f. July 15 Statements of Availability due GS Office. (6a).
- g. July 31 Lodge installations must be performed from June 24 to prior to midnight July 31 (Art. 298).
- h. August 15 Annual Returns Report due to Grand Lodge (Art. 493).
- i. August 15 Resolutions due in GS Office (Art. 172).
- j. September 15 Lodge Minimum Audit Report 71 is due to the GS Office NLT September 15 (Art. 284).
- **k.** August 31 & September 15 Vanguard Applications are due to the DDGM NLT September 15 and to the Grand Secretary NLT September 30 (refer to Vanguard Application Instructions).
- I. October 1 Lodge By-Laws that must be reviewed by the GL Committee on By-Laws due the GS Office NLT October 1 (Art. 219).
- m. Nov 15 Form 990-N, Electronic Notice (e-Postcard), must be filed with the IRS by Lodges that have gross receipts of \$50,000 or less or do not meet the requirements for filing the IRS 990 or IRS 990EZ. (Lodges must file the appropriate Form 990 no later than the 15th day of the fifth month following the close of the organization's fiscal year.)
- **n.** Dec. 28 Proxy Certificates are due the GS Office NLT December 28 (Art. 4). You should always appoint a Proxy (in case of an emergency) but he would not vote if any of the top three officers were available. Remember, each brother can have no more than four votes. Therefore, a sitting Worshipful Master cannot be a proxy for another Lodge.
