GRAND SECRETARY OFFICE UPDATES

Suspension for Non-Payment of Dues

PLEASE ACT NOW - The deadline for members' suspensions is midnight June 23 per Art.319. No suspension will be made after the deadline of June23 per GRAND LODGE LAW.

Art. 319. Automatic Suspension.

Lodge dues are due and payable one year in advance on January 1st of each year (unless otherwise exempt) and if not paid on or before that date a member shall be in arrears for his dues; and on or before thirty days before the last stated meeting of the Lodge held before June 24th of each year, it shall be the duty of the Secretary to notify each member, in writing, who may be in arrears for any dues, and if such member fails to pay such dues on or before June 23rd of such year, he shall stand automatically suspended for non-payment of dues without action by the Lodge, and such suspension shall be recorded in the minutes at the first subsequent stated meeting of the Lodge.

MASONIC MINUTE

The following is an excerpt from R:.W:. Jim Rumsey's 2016 paper entitled "The Final Degree in Freemasonry: The Masonic Burial Service" found in Volume XLIX of the *Transaction Texas Lodge of Research*. The Masonic Burial Service has evolved with time, much like the other degrees of the Order. In 1717, when the Grand Lodge of England and Westminister was formed, there was but one single degree. By 1721, the second degree had emerged. By 1730, the third degree was being conferred. The higher degrees followed.⁴¹ The burial service, however, seems to have a stronger effect. It is written about in newspapers without threat of an expose. It is observed by the Mason and the profane, and the theme and meanings speak to both. It stopped a battle of the Civil War for a time, so that it could be conferred and officiated with the solemnity it deserves. It is truly an honorarium, but must be both earned and requested.

The Grand Lodge of Texas recognizes the significance of the Masonic Burial Service. Title III, Chapter 3 of the *Laws of the Grand Lodge of Texas* authorizes subordinate Lodges to perform Masonic burial services. The burial is extended to all Masons in good standing, including Entered Apprentices and Fellowcrafts. ⁴² Texas joins twenty-five other Grand Jurisdictions in the United States that allow for Entered Apprentice Masons and Fellowcraft Masons to be honored with the Burial Service. ⁴³

The Grand Lodge of Texas has approved seven separate rituals to be used to conduct a Masonic Burial Service in the Grand Jurisdiction of Texas; and has procedures for a funeral processions and public appearances. ⁴⁴ There are regulations governing when regalia and aprons should be worn and when they should not, much like the Constitutions of 1792. ⁴⁵

While there are seven approved variations, the theme of the service is consistent among them. The focus is not on the accomplishments or life of the deceased, but a solemn reminder to the observer of the certainty of death. It speaks to the observer that death will sooner or later overtake us all, and those who survive the deceased (whether familial, fraternal, or friend) should be prepared to leave the vanity of life without notice. The theme of the approved Masonic burial service for other Grand Jurisdictions (Louisiana, Oklahoma, New Mexico, and Alabama) is similar.

Therefore, the ritual of the Masonic burial service is fairly uniformed. Much like the Hiramic Legend; it may vary slightly among Grand Jurisdictions regarding the words, but the theme remains constant. It is bestowed upon a worthy brother, who has asked for it of his own free will and accord, at the discretion of the Lodge. This theme is very similar to the other degrees of our fraternity.

"The word *degree*, in its primitive meaning, signifies a step." ⁴⁶ "The three steps usually delineated upon the Master's carpet are emblematical of the three principal stages of human life, namely: Youth , Manhood, and Age" ⁴⁷ in the explanations of these steps, we read with regard to the third step, "... so that, in Age, as Master Masons, we may enjoy the happy reflection consequent upon a well-spent life, and die in the hope of a glorious immortality" ⁴⁸ Thus, a degree of Freemasonry may be identified and compared to the steps as outlined herein. However, the definition of a degree that is adopted by the Grand Lodge of Texas is "a step in a series, as of rank or dignity" ⁴⁹ A candidate for the degrees takes a step and achieves the rank of Entered Apprentice Mason; who then takes a second step and achieves the rank of Fellowcraft Mason; who then takes a third step and achieves the rank of Master Mason. Then, said Master Mason may take a fourth step and achieve the rank and dignity of Past Master. But any Mason, whether an Entered Apprentice or Master Mason, may (and eventually will) take the final step in the series of life and be dignified by the conferral of the Masonic Burial Service.

It is therefore, offered, that the Masonic Burial Service is indeed the final Degree in Freemasonry. It is offered as such, not to make an innovation in Freemasonry, but to recognize it as the final step in the series of our Masonic journeys. It is the pinnacle of Masonic Dignity. Like the other Degrees: It is officiated by a Lodge of Freemasons; the Lodge has to open a Lodge for the purpose of the Burial service; it requires certain principal officers to perform the ritual and ceremony; the ritual and ceremony are scripted and have a central theme that spans Grand Jurisdictions; it is bestowed upon a worthy brother; and it must be asked requested by the brother or by his family. The Masonic Burial Service is the final Degree of Freemasonry.

Therefore, the topic of the Masonic Burial Service will be concluded with a final thought, an excerpt from Claudy's *Old Tiler Talks*;

The effect Masonry has on a man's heart is aided by the mechanics of Masonry; temple, lodge room, dignity of the order, its public appearance, the respect it shows to its dead, its educational work, appeal to the general public, its secrecy, its reputation of being above party and politics, its alliance with all religion and its participation in none. These make Masonry objective, but they are the outward semblance of the inward and spiritual Masonry. These you ought to know for yourself: charity, relief, brotherly love, truth, knowledge, self-sacrifice, tolerance. ... We make lodge work dignified, well done, impressive, to express to ourselves our sense of the dignity of the truths we teach. We conduct the funeral of a deceased brother, not to make a show before the world, but to express to ourselves our regret that a brother has departed and our conviction that he has but traveled upward to that Temple Not Made with Hands, where the Supreme Architect waits for all who have been builders upon Earth. ⁵⁰

MONTHLY LAW READING

This month presents one of those anomalies in the law book. Again, you must read the law as well as the Grand Master's Decisions to properly interpret the law. For example, **Grand Master's Decision (1965) No. 12** interpreting Article 292 provides:

QUESTION: When an ineligible Brother is elected to office and the fact of his ineligibility is discovered subsequently, can another election be held to fill such office? ANSWER: No, the office must remain vacant until the next regular election and must be filled pro tempore at each meeting of the Lodge until such time. Articles 292 and 306, Laws of The Grand Lodge of Texas.

This appears straight forward. But it is wrong. In 2020 after the 1965 GM's Decision), the Grand West revised Article 292 to provide the following:

Art. 292. Time of Election.

b. Notwithstanding the provisions set forth above, if an officer, elected or appointed who has not been installed is found to be disqualified, dies, or becomes unable to perform his duties by reason of sickness, relocation to another city, state, or country, or other legitimate extenuating circumstances, the Worshipful Master shall have the option to hold a called meeting, upon reasonable notice to the Lodge membership, for the specific purpose of electing a qualified Lodge member to fill the open position. The election and installation of such officer must take place before July 31, as provided in Art. 298. (Revised 2020)

Thus, if the lodge discovers the ineligibility or the brother dies BEFORE INSTALLATION, the Worshipful Master CAN hold a called meeting to elect another brother provided the newly elected officer can be installed before July 31. The 1965 GM's Decision no longer controls because the law has changed.

Be sure to check the dates of GM's Decisions to see if a change in the law has superseded the GM's Decision.

The Board of Directors are most pleased with the overwhelming success of the new online payment system (Melio) for the 2024 grant cycle. We are optimistic that next year's cycle will be even more seamless allowing us to deliver matching funds to you quicker and cheaper than ever before.

To further improve our capabilities, the Board of Directors are pleased to announce that we are expanding our online presence by offering a new donation platform through a partnership with GiveButter.com. 

LODGE OFFICERS

Brethren, as we approach the elections and appointments of officers, we're going to take a look at some Texas officer statistics. As we do so, you'll notice in many places a distinct difference between what tends to happen at large lodges compared to smaller lodges.

Figure 1 shows that the percentage of Master Masons who eventually take an office has been increasing. This is a natural result of the number of lodges in Texas not decreasing in proportion to the number of Masons. There's simply less people to fill a set number of offices. In 1990, only 40% of new Masons would ever take an office. Now it's nearly 70.

Please note that the dip at the end of Figure 1 is simply because those recent Masons haven't taken one yet, but some will. For those who will take an office, Figure 2 shows that most of them do so in their first year after being raised, and almost all within a few years. We do have a small number who take their first office much later in their Masonic careers, but it's less than 2%. For the most part, if they're going to take an office, they start doing so within their first few years.



It should also be noted that if they do not take an office, they are much more likely to go suspended for nonpayment of dues. Of the 8155 Masons raised from 2010 to 2015, only 771 have gone suspended after taking an office compared to 1222 who have gone suspended without taking any office. If they do take an office, which office they take depends heavily upon if they are in a small lodge or a large lodge.




Figure 3 shows the first office taken by Masons raised 2007 to date. Lodges with less than 50 members are much more likely to start someone at Junior Warden or Junior Deacon. If they're in a larger lodge, they're more likely to start at Junior Steward.

Additionally, people are much more likely to repeat in a chair in the smaller lodges.





Figure 5 is redepicted in Figure 6 for the larger lodges, where you should look to the East wall for the most years in Masonry, although not necessarily in the Worshipful Master's chair itself. While leadership is not one of the core principles we tout in Masonry, if you love your Brothers and love your lodge, it's natural to want to help out where needed. At the same time, traveling to the East undoubtedly helps you grow. It also gets you involved in the lodge and aids at retention. You're there for the degrees. You're there for the education. You're there learning the ritual and strengthening the bonds of Fraternal love, gaining trust, and figuring out things you can do to help the Fraternity improve. A wise new Worshipful Master will take his appointments seriously, both for the benefit of those people and the lodge.

Finally, Figure 5 (right) shows the median years in Masonry for each of the stations and places. Again, smaller lodges have more people repeating in those chairs and more tenure. Larger lodges tend to have newer masons in the chairs, especially in the Deacon and Steward roles. Large lodge Worshipful Masters average 7 years in Masonry before taking an office, and more of them started at Junior Steward than anywhere else (Figure 3).

Figure 4 (left)

Figure 4 shows that in larger lodges only about 1 in 3 have previously served as Worshipful Master, Warden, Deacon, or Steward before taking that chair, while in smaller lodges the average person has served nearly twice before in those very same stations and places. That's not the case though with Secretary or Treasurer. Large lodge or small, you'll find the most tenure in your Secretary and Treasurer, as it should be.

SECRETARY INSTRUCTIONS

The following information is intended primarily for the Secretary but may be meaningful to many of your members.

Lodge Suspense System:

Suspense Dates – Lodge Secretaries should create a suspense system (a reminder system) to alert the Lodge that certain documents are due. This list is offered as a "starter kit' for your consideration:

- **a.** January The Worshipful Master should appoint a Committee on Members in Arrears (Article 319a).
- **b.** May 31 W. B. and Brandon Carrell Award nominations may be submitted to the Grand Lodge Committee on Public Education for evaluation and recommendation to the Grand Lodge Trustees (Article 14b).
- c. Mid-June Look for the Annual Returns Format from GL. (Downloaded from the Grand View System after June 24th. Notify the GS staff if you need the returns mailed as a printout).
- **d.** June 23 Lodge elections must be completed at the last stated meeting prior to midnight of June 23 (Art. 292). Notify us of the new Lodge Officers immediately so they can be printed in the Directory of Constituent Lodges (do not wait for installation). Submission will be available on the Grand View System from May 24 through midnight June 23.
- e. June 23 Endowed Membership checks must be in the Office of the Grand Secretary by June 23 to start earning interest in order to receive returns by the next year (Art. 318a). Changes to the amount of endowments must be voted on at the same meeting as the Lodge elections, and notification to the Grand Lodge must be before June 24th. Endowed Membership applications received at the Grand Lodge on or after June 24 must be for the amount that the Lodge reported.
- f. July 15 Statements of Availability due GS Office. (6a).
- g. July 31 Lodge installations must be performed from June 24 to prior to midnight July 31 (Art. 298).
- h. August 15 Annual Returns Report due to Grand Lodge (Art. 493).
- i. August 15 Resolutions due in GS Office (Art. 172).
- j. September 15 Lodge Minimum Audit Report 71 is due to the GS Office NLT September 15 (Art. 284).
- **k.** August 31 & September 15 Vanguard Applications are due to the DDGM NLT September 15 and to the Grand Secretary NLT September 30 (refer to Vanguard Application Instructions).
- I. October 1 Lodge By-Laws that must be reviewed by the GL Committee on By-Laws due the GS Office NLT October 1 (Art. 219).
- m. Nov 15 Form 990-N, Electronic Notice (e-Postcard), must be filed with the IRS by Lodges that have gross receipts of \$50,000 or less or do not meet the requirements for filing the IRS 990 or IRS 990EZ. (Lodges must file the appropriate Form 990 no later than the 15th day of the fifth month following the close of the organization's fiscal year.)
- **n.** Dec. 28 Proxy Certificates are due the GS Office NLT December 28 (Art. 4). You should always appoint a Proxy (in case of an emergency) but he would not vote if any of the top three officers were available. Remember, each brother can have no more than four votes. Therefore, a sitting Worshipful Master cannot be a proxy for another Lodge.
