I plan to have at least three Grand Master's Recommendations for your consideration at our next Grand Communication. One will propose a path forward to preserve our Grand Lodge building. The second will propose an amendment to Article 508. The third one will address Endowed Memberships.

The rules and guidelines of the Honesty and Integrity Award as specified in Article 14f provides the opportunity for each lodge to recognize two outstanding high school juniors for their honesty and integrity. The identification of these students begins with the onset of school this fall. Your lodge should already have received materials for this wonderful program in the coming 2020/2021 school year.

The online merchandising is now operational on the Grand Lodge website located at the top under the dropdown menu label "Shop". https://grandlodgeoftexas.org/ shop/. On this user-friendly link you can see pictures of all the items with pricing and easy ordering and payment. I hope you will visit it and consider purchasing available items, including the First Lady merchandise from the same link.

The Grand Secretary and Grand Treasurer have taken steps to modernize the accounting systems for Grand Lodge. The actual processing of most accounting transactions has been outsourced to a local CPA firm with electronic approval by both officers. It has reduced our overall accounting costs and improved information access for the Trustees.

The Trustees are already meeting on plans for our Grand Session in January. A Special Committee has been formed to develop and explore what alternatives exist if the COVID-19 pandemic does not permit us to meet as usual in January. Any sound business operation should always have a Plan B.

It is my hope you will continue to keep our families and brethren safe, as well as "Create Excitement" within our fraternity and within the community about all the ways Masonry is integral to our society. God Bless you.

# A WORD FROM THE Deputy Grand Master



It is an honor and privilege to serve Texas Freemasonry. So many memories of things past and so many hopes for things future! 2021 is rapidly approaching with anticipation and worries. This has been a difficult year for Texans and Texas Masonry; yet what does not destroy, strengthens. We just must work and enjoy. Following are some thoughts on the coming year if tradition prevails and I am elevated.

Appreciation: First and foremost, our Most Worshipful Grand Master, Paul D. Underwood, deserves our thanks and praise. He was catapulted into a new world when the pandemic closed our society and altered how we relate and interact with others. The pandemic forced a halt to many of his activities and programs. Throughout the ordeal of the last few months M. W. Underwood led us with determination, compassion, and a majestic love for our Fraternity. Please take time to personally thank him for his leadership.

**Need and fulfillment:** As we travel our journey in this life, from time to time we hear people say things which strikingly affect us, words that take on paramount importance as they sink into our subconscious. At a Grand Master Conference in Houston, a Brother vocalized that the real problem with our Fraternity is that we do not treat our Brothers very well. My Brothers, Jeff King of Palo Duro Lodge No. 1239, and Ernie Gandy of Plainview Lodge No. 709, voiced that lodges must focus on the needs of their members and then fulfill those needs.

In most Masonic Lodges the mindset is, "What can a member do for the Lodge?" Rarely, if ever, does the Lodge leadership think about what does the member need from the Lodge. Does a member have a need for attendance at a stated meeting? Does a member have a need to listen to the Secretary read minutes? The simple answer is that the member does not have a need to do those things. Lodges push meeting attendance, paying bills, and filling the chairs. Those are all needs of the Lodge. What are the needs of the member? Does the Brother need help paying bills or finding a job? Does the Brother need someone to console him or offer him kind words of support? Does he need fellowship outside of that monthly stated meeting dinner, or does he need someone to listen to his joys and concerns? Does he need time with good men, or does his family need time with good people? What is it that the Brothers of your lodge need?

Take the time to create a playing card for each member who participates in your lodge, those whom you have seen in the past year. On that card put information such as job and education, conditions of health, when he joined the lodge, who signed his petition, how old he is, where he works, who is in his immediate family, does he have young children or grandchildren. Then on the back of his playing card write down what he needs from the Lodge. I came back to Masonry to learn the ritual work. I did this because the DeMolay ritual guided and gave order to my life as a youth. As an adult I needed the teachings and directions of our Masonic ritual. My son, with a beautiful and vibrant wife and three small boys and a precious girl on the way, does not need to attend a meeting. His need is comradeship and family support, people to go fishing with on Saturday morning, and some activity at the lodge for his and other Brothers' children. Once you have listed the needs of the Brother then go about deciding how you are going to fulfill those needs.

Bring back a brother. Typical lodges will see fifteen percent or so of their membership during a typical year. Thirty five percent of their members may be too infirmed by age or illness, or otherwise unable to attend lodge because of job or family considerations. That means roughly fifty percent of our members are content to be card carrying Texas Masons and not be active in a lodge although they pay dues or are endowed members. These are men who took the obligations, were judged proficient and probably tried to be active for a year or two. Some lodges actively reach out to these Brothers, but most do nothing beyond a phone call. If we are to survive, our lodges must determine why it is their members are not active and what changes the lodge must make to bring

them back. The 2021 Planning Team and the Membership Committee will promote a BRING A BROTHER BACK workbook to lodges who care about those missing Brothers beyond seeing their dues or endowments.

**Conference with the Grand Master.** There will be 28 Conferences with the Grand Master across the state. These conferences will differ from the past in that they feature a speaker on the Bring Back a Brother Program, remarks by the Grand Master, and a questions and answers session with the Grand Master and other Grand Officers present. They will be open to all Masons, their friends, and families.

**District Service Team.** The District Service Teams, consisting of the District Deputy Grand Master, the District Instructor, District Education Officer and District Communication Officer, are tasked with proactively working with their district's lodges and to plan district wide activities. The Service Team is expected to lead the district and be accepted as Brothers and friends in each lodge in their district.

Volunteers. I am asked how Brothers become active in Grand Lodge. It is a sad statement that positions are only offered to those good and able Brothers we meet along the way and that there is nothing which identifies and pushes up good and able Brothers with special and necessary competence or interests. We need to identify a member's occupations and areas of competence in Grandview. We need to list all committees and their members on the membership portal of Grandview. After reviewing the list of Committees, any Brother that is willing, able and can, should offer to work with the committee on a volunteer basis. This will form a pool from which to select future committee members. We are in the process of reconstituting the Insurance Advisory Committee. We need volunteers who have a background in insurance and claims handling. If that is you, please email me through the Grand Secretary.

These are some of the initiatives for next year. Remember Need and Fulfillment.

Again, thank you for the many memories and the many hopes. Stay safe, and "Let's be careful out there!"

# 2020-2021 Summary of Proposed Resolutions and Recommendations

**Resolution No. 1:** This Resolution would amend Art. 172 and require all portions of Committee reports proposing any change in Grand Lodge or Grand Lodge law to be filed with the Grand Secretary on or before November 15 of each year and included in the copies of proposed Resolutions forwarded to the secretaries of the subordinate Lodges by the Grand Secretary

**Resolution No. 2:** This Resolution would amend Art. 83 and would change the date for filing DDGM reports on the status of the Lodges in his District from September 15 to December 31 of each year.

**Resolution No. 3:** This Resolution would amend numerous Articles in both the Constitution and laws with regard to certain action dates. The requested date changes are requested in light of the movement of the date of commencement of the Grand Annual Communication from the 1st Thursday in December to the 3rd Thursday in January.

**Resolution No. 4:** This resolution would amend Art. 338 regarding the safekeeping of the minutes of Constituent Lodges to permit the digital storage of Lodge minutes in the "Cloud" which would allow Lodge members to review Lodge minutes "on-line" in a secure environment.

**Resolution No. 5:** This resolution would delete Art. 629, 631, 632, 638 and 639 and would amend Art. 630 by requiring a suspended or expelled Mason, except for those suspended for nonpayment of dues, to file a written petition for reinstatement of restoration with the Grand Secretary of the Grand Lodge of Texas. The petition would be considered by the Grievances and Appeals Committee and, after certain action, its findings and proposed action would be forwarded to the Grand Master for approval. The actions would be included in the Grievances and Appeals Annual Report.

**Resolution No. 6:** This resolution would create a new Art. 22(a) and would give the Grand Master authority, with the approval of the Grand Lodge Trustees, to suspend or modify any law of the Grand Lodge of Texas (a) during the period of a world, national or state emergency; or (b) to conform with any lawful Federal or State directive that would affect the operations of the Grand Lodge of Texas and/or its constituent Lodges.

**Resolution No. 7:** This resolution would amend Art. 316 by adding Endowed Members to the list of those Masons who are exempt from paying dues and their Lodges to be exempt from paying per capita to the Grand Lodge.

**Resolution No. 8:** This resolution addresses the proposed realignment of Masonic Districts 26A, 26B and 26C in Southeast Texas.

**Resolution No. 9:** This resolution would create a new Art. 224c which would modify the position of the Grand Lodge of Texas regarding consumption and possession of alcoholic beverages on Lodge premises.

**Resolution No. 10:** This resolution would change the name of Fort Hancock – Fort Bliss Lodge No. 1297 to Taft-Diaz Lodge No. 1297.

**Resolution No. 11:** This resolution requests the realignment of Lodges in District 30.

**Resolution No. 12:** This resolution would create a new Art. 74b and would require the Grand Secretary, with approval of a majority of the Grand Lodge Trustees, to annually review, revise, add or delete Masonic forms as may be necessary for compliance with Grand Lodge laws and to provide the Masonic Jurisprudence Committee and written report for that committee's action pursuant to Art. 107.

**Resolution No. 13:** This resolution would amend Art. 163a and would require each Lodge to pay an annual assessment of \$40.00 for each member on its rolls until a total assessment of \$200.00 per Lodge member has been paid. The monies would be first placed in the Grand Lodge General Fund and then transferred to a Reserve Fund, in trust, to be solely used for structural maintenance, renovation, remodeling and repair of the Memorial Masonic Grand Lodge Building.

**Resolution No. 14:** This resolution would amend Art. 4, Sec. 8 of the Constitution and would permit the Grand Master to appoint District Deputy Grand Masters from either a Lodge in that District, or from a Lodge in an adjoining District.

**Resolution No. 15:** This resolution would amend Art. 75 by adding that if a Masonic District is not composed of three or more Lodges, the Masonic District shall have one year to submit a plan for redistricting. If no plan for redistricting is submitted, the Grand Lodge shall redistrict accordingly.

**Grand Master's Recommendation No. 1:** This recommendation would amend Art. 508 by making it a Masonic offense to make any negative reference, or take any negative action, in regard to a petitioner's or member's faith, creed or race at any time.

**Grand Master's Recommendation No. 2:** This recommendation would permit the Grand Master to allow the participating Lodges to participate in a "Join the Move" program during his Masonic year. The program would be designed to advance those Entered Apprentices and Fellowcrafts who did not complete their degrees within the prescribed time to become Master Masons. The specific provisions of the program are included in the published Recommendation.

**Grand Master's Recommendation No. 3:** This recommendation would delete Art. 163b, 163e and 318a in their entirety and would create a new Art. 318a regarding Endowed Memberships. The minimum amounts for an endowment would be set at an amount not less than 20 times the Lodge's current annual dues, if under age 65; or 10 times annual dues if over age 65. All monies presently in the Delaware Trust, the current holder of the endowment assets, would be returned to the Lodges who would be required to establish and manage an Endowed Membership Fund. Only the income from the fund could be withdrawn and used by the Lodge for its operations.

**Grand Master's Recommendation No. 4:** This recommendation would amend Art. 163(11) by increasing the amount from \$1.00 to \$9.00 to be remitted by the Lodge for the Grand Lodge Library and Museum with its Annual Return for each member on the rolls of the Lodge.

# On the Masonic Road

David Dibrell Ceremony

On October 24, 2020, a cold and windy day, our Most Worshipful Grand Lodge of Texas Officers; Most Worshipful Grand Master, Paul D. Underwood, Right Worshipful Deputy Grand Master, Kenneth C. Curry, Right Worshipful Grand Senior Warden, Bradley S. Billings, Right Worshipful Grand Junior Warden, G. Clay Smith, and Right Worshipful Grand Marshall, Don O. Angell met solemnly and sincerely, in a personal and official capacity, to recognize and memorialize three of our most recently deceased Past Grand Masters.

It was a day "On the Masonic Road" that required emotional and professional discipline on the part of the attendees, as those present and those deceased were very good friends and Brothers in the Craft. Many or most of the attendees had deep personal and or professional relationships with the deceased Past Grand Masters and their family members. The day carried the "fog" of bitter-sweetness and deep remembrance.

Earlier this year, our Grand Master sensed a need to "re-set" a "near dormant" 1961 Grand Lodge remembrance and memorial program, that placed Masonic grave markers near the headstone of the graves of our Past Grand Masters, and elevated it once again to a worthy priority.

The responsibility for identifying and marking the graves of Past Grand Masters was first adopted by the Grand Lodge of Texas Committee on Masonic Education and Service in 1961, by recommendation of then, Grand Master William G. Proctor, and under the leadership of Chairman and Past Grand Master Randall E. Briscoe.

According to the 1961 Grand Lodge of Texas Proceedings, a bronze plate was designed and approved for use in marking the graves. Unfortunately, a sample of the design was not preserved in Grand Lodge records. Since that time, many of the deceased Past Grand Masters graves have been identified, but after reviewing the Grand Lodge Proceedings it appears that many may still need to be marked.







The Grand Lodge of Texas, Committee on Masonic Education and Service, recreated the design for the Masonic marker plate with information that was available, and secured a quote for the production of seven markers. The Committee then obtained the necessary funds to allow for placement of the markers in the coming year, and finally, replicated and updated the 50-year-old Grand Lodge, Past Grand Master, Marker Dedication Ceremony that will be used for all Past Grand Masters future grave marking ceremonies.

Saturday, October 24, 2020 began with a sense of duty and a call to remembrance. Our Grand Lodge of Texas Officers met at Richardson Masonic Lodge No. 1214, at 9:00 AM, to open a representation of the Most Worshipful Grand Lodge of Texas. This began the morning activities of traveling to the burial sites for the Past Grand Masters to be recognized. The schedule of events was as follows:

- 9:00 AM Opening of Representation of the Most Worshipful Grand Lodge of Texas at Richardson Masonic Lodge No. 1214
- 9:30 AM Arrive at Restland Cemetery
- 10:00 AM Marker for Past Grand Master, R. W. R. H. "Bob" Waters (Served 1984) Ceremony – M. W. Grand Master, Paul D. Underwood
- 10:30 AM Marker for Past Grand Master, R. W. Leonard P. Harvey (Served 1989) Ceremony – R. W. Grand Senior Warden, Brad S. Billings
- 11:00 AM Marker for Past Grand Master, R. W. David B. Dibrell (Served 2001) Ceremony – R. W. Past Grand Master, Tommy Griffin

 11:45 AM Arrive at Richardson Lodge, close representation of the Grand Lodge Of Texas

With the recent passing of the aforementioned Past Grand Masters, and R. W. Orville L. O'Neill (2010), R. W. J.M. Willson (1982), R. W. Graham H. Childress (1988) R. W. Fred E. Allen (1991), and R. W. James F. Brumit (2012), a renewed effort has begun to research past records of the Grand Lodge proceedings to determine which other Past Grand Master's graves may not have received special Past Grand Master Masonic markers.

In the wake of the pandemic interruption to our Masonic practice and fellowship, it is significantly important to our Grand Master, that he and the Brothers of the lodges in Texas, place a high priority on the remembrance of our diseased Brothers, particularly Past Grand Masters. This ceremony memorializing three deceased Past Grand Masters is the recent first in a series of the Most Worshipful Grand Lodge of Texas ceremonies, recognizing and marking the graves of our Past Grand Masters.

The Grand Lodge of Texas will replicate this memorial ceremony and placing of the Masonic Markers annually until all of the Past Grand Masters graves are marked as allowed by the cemeteries and approved by their families.

# **Grand Lodge of Texas Committee on Texas Masonic History**

For next installment on Grand Lodge committees, let's quickly review the Grand Lodge of Texas, Grand Lodge Permanent Committees structure, as an introduction to learning more about the Committee on Texas Masonic History.

The laws of The Grand Lodge of Texas, Chapter 16 – Title I, Articles 105 through 126k of The Laws of The Grand Lodge of Texas, A.F. & A.M. lists the Permanent Committees, each committee's organization, and assigned duties and responsibilities. Currently there are 21 Permanent Committees.

The Committee on Texas Masonic History is one of the 21 Permanent Committees aforementioned and is directly answerable to the Grand Master of Texas, and Grand Lodge of Texas Trustees.

The term of office of each member of each of these 21 Permanent Committees is seven years. Each year, on the last day of each Annual Communication, the incoming Grand Master shall appoint a successor to the member(s) of each Committee whose term(s) expire at that Communication. No member shall be eligible for reappointment to succeed himself who has served a full term of seven years on a Committee, and no member shall be eligible to serve on more than one Permanent Term Committee or Board elected by Grand Lodge concurrently.


Chapter 16, Article 126j as follows, lists the duties and responsibilities for the Committee on Texas Masonic History:

"Art. 126j. Texas Masonic History. The Committee on Texas Masonic History shall be responsible for (i) the promotion of Texas Masonic Historical activities; (ii) the improvement of the Masonic image in historical activities and celebrations; (iii) the investigation and reporting of significant historical events to be celebrated; and, (iv) advising the constituent Lodges as to the conservation and preservation of historically significant artifacts, documents and records in the care of said Lodges." (Revised 2007)

The Committee on Texas Masonic History has overall responsibility and or assistance for all (Grand Lodge and/or constituent lodge) planning and promoting of historical events and activities, seeking opportunities for and to improve our Texas Masonic image in our communities, identifying and reporting on significant Masonic opportunities for celebration and providing counsel and guidance on the identification and preservation of Masonic items of "legacy" value and historical evidence.

The Chairman and members of the Committee on Texas Masonic History are very proud of the committee's hard work and would add; "This year our aim is to celebrate and emphasize Masonic stories, histories, and individuals. This 2020 year, we have penned over a dozen articles ranging in topics from our local lodges' histories to the creation of the Texas flag."

The Committee on Texas Masonic History is a great place to go for help when discovering the legacy of old Masonic documents, articles and regalia. # **Texas Masonic Cemeteries**

The cemetery is sometimes confused with The Masonic Cemetery in neighboring Chappell Hill which is often mistakenly referred to as Brenham Masonic Cemetery in Chappell Hill. The oldest grave in the Brenham Old Masonic Cemetery dates from 1841. Mrs. M A Graham was laid to rest there four-to-five years prior to other graves on site and the founding of the city of Brenham.

BRENHAM MASONIC CEMETERY MEROUS GRAVESTONES DATING FROM THE 18405 INDICATE THAT THIS BURIAL GROUND IN USE WELL SEFORE DECEMBER OF 1847, IT WAS FORMALLY DEEDED TO THE GRAHAM NIC LODGE #20 SY CHAUNCEY & SHEPARD ONES HERE IN THE LATTER PART OF 1867 AS TOPMIC SWEPT THROUGH THE AREA, THE SITE SEEN COMMONLY KNOWN AS THE YELLOW CEMETERY EVER SINCE LAID TO REST HERE PIONEERS, VETERANS OF THE WAR OF TB12, EXAS REVOLUTION AND THE CIVIL WAR, STATE TOCAL LAWMAKERS AND OFFICIALS; XTORS, AND MANY OTHERS WHO FORMED

STORIC TEXAS CEMETERY - 2002

Old Masonic Cemetery obtained the Yellow Fever Cemetery name during the epidemic which ripped its way through Texas in 1867. Brought in through the port town of Indianola in June, the fever spread to Galveston. Shortly thereafter the mosquito-borne infection was carried to Huntsville, LaGrange, Brenham and Chappell Hill, Hempstead, Goliad, Navasota, Victoria, Montgomery, and Houston.

By November's first frost, nearly 4000 Texans had perished. Losses were heavy in Brenham

as 21 tombstones and two mass graves holding an estimated 200 plus individuals each were added to the cemetery in September and October. All told, the site holds approximately 128 individual graves as well as two mass graves though numbers cannot be accurately known as the cemetery has many stones removed from their original locations due to heavy vandalism over the years. Between them, the Brenham cemeteries hold over 550 victims of the Yellow Fever Epidemic.

Historically, Masonic Cemetery holds pioneers from European countries, settlers from both eastern and southern states, veterans of the 1812 war, Texas Revolution, and Civil War. Important state and local lawmakers, officials and educators since the early days of the Republic are also interned there.

The first restored grave belonged to Patrick H Lusk buried in 1851. Lusk was one of 176 men recaptured following an escape attempt during a march from Mier to Mexico City. The attempted escape at Salado, Tamaulipas in February of 1843 lead to the infamous Black Bean Episode. Mexican Colonel Domingo Huerta, originally ordered to kill all participants, decided to execute every tenth man. A jar holding 17 black and 159 white beans was passed among the prisoners. Commissioned officers were ordered to draw first. Lusk drew a white bean and was saved. The 17 men marked for death were shot at dusk on March 25, 1843 after being allowed to write letters to their families back home. Their bodies were returned from Mexico in 1848 and buried at Monument Hill near LaGrange.\*\*

Lusk's father, Sam Lusk is also buried at Masonic Cemetery. He served in the battle of San Jacinto and was a member of the Constitutional Convention that passed the Declaration of Independence of Texas and later a member of the Congress of the Republic which ratified the

The story of Texas cannot be told without mention of the town of Brenham. And the story of Brenham cannot be told without knowing the history of Old Masonic Cemetery. Old Masonic Cemetery, also known as Wilderness Cemetery and, later, Yellow Fever Cemetery, literally plots the history of this vital Washington County city in early Texas.

Located in Brenham off HWY 36N (Loop 283) just northwest of Brenham High School adjacent to Dupree Drive on Old Masonic Drive, the cemetery dates back to the early 1840s. It was founded by the Shepard family and then deeded to Graham Masonic Lodge No. 20 by Chauncey B Shepard in December 1847.

Graham Lodge No. 20 was granted a charter January 13, 1845 by the Grand Lodge of Texas, AF & AM during the period of the Republic of Texas. A gate entering the property and a large Texas Historical Marker 17065, were added in 2002.

Graham Lodge, 175 years old, was the home lodge of two former Past Grand Masters of Texas Masons – John Sayles (1853) and J D Giddings (1865). Sayles' brother-in-law Barry Gillespie (PGM 1846 and member of Matagorda Lodge No. 7) and Giddings are buried in the Prairie Lea Cemetery, also in Brenham, which opened in 1874-75. It is not officially known if Gillespie ever attended Graham Lodge since the first 21 years of Graham's history were lost when the lodge building and records were destroyed in September 1866 when tensions between locals and occupying union troops during post-war Reconstruction led to the burning of

annexation of Texas into the United States. He also served as mayor of Brenham 1859-61 and was a long-time Washington County Clerk.

Civil War veterans include Confederate office Hugh A McPhaill, a native of Arkansas who moved to Washington County from Fannin County in 1860. McPhaill joined the Fifth Texas Cavalry at the beginning of the war and was commissioned as a captain in command of Company E. Following combat in the battle of Valverde he was promoted to major and led his troops in battle throughout Louisiana in 1863 and 64. He was buried in Old Masonic Cemetery in 1865. \*\*\*

Various individuals have been involved with and independent of Graham Lodge No. 20 in the restoration of the cemetery over the years.

Ms. Janis Kmiec, spurred into action by Bob Hasskarl's book *Brenham Texas 1844-1958*, organized a children's cleanup of the cemetery. A teacher in the area, Kmiec applied to the Texas Historical Commission for Historic Texas Cemetery designation for the cemetery approximately 15 to 18 years ago.

Graham Lodge member Keith Twiggs started an out-of-pocket maintenance of the facility over a two-year period beginning in 2016. He hired two men to mow and remove brush as well as organized Boy Scout projects several times.

Lowell Herzog, a retired history teacher, restoration specialist, and owner of Texas Gravestone Conservation, has been working with the lodge to restore the Shepard stone and other markers throughout the cemetery. The Shepard family as afore mentioned donated the cemetery to Graham Lodge No. 20. Herzog specializes in gravestone and restoration of monuments in cemeteries throughout the region.

Dr. Robert Stark, family medical specialists in Brenham, has been a Graham Lodge No. 20 member for near 40 years. He says there are still 55-to-60 sunken, covered, fallen, and broken graves still in need of conservation at the site. Several prominent area families probably had deceased members removed to Prairie Lea when it opened.



Graham Lodge formed a committee to oversee the repairs and renovation in June of 2015 consisting of Dr. Stark and Brothers Glen Grantom, John Fuller, and Kirby Simmons. They have been working on obtaining information from relatives of the interred as well as overseeing the restoration and maintenance efforts.

Indications are that the cemetery was not always accessed from the country road but that it was entered from the south near or at the site of the Lusk lot. The location of the mass graves in the current front of the cemetery with the better-known family named plots toward the rear are indicative of this assumption. - *hoffpauir*
