

WATERMELON EATING CONTEST

Sandoval County Fair

1st Annual Watermelon Eating Contest Saturday, August 5th| Contest begins at 3PM

OFFICIAL CONTEST RULES

Eligibility: Participants less than 18 years old must have a legal guardian present. The three general age categories are:

Group 1: Ages 8 to 12 years (\$3 entrance fee) **Group 2:** Ages 13 to 17 years (\$7 entrance fee) **Group 3:** Ages 18+ years (\$10 entrance fee)

To Enter: All contestants must complete an entry form in order to participate. Only 20 contestants will be allowed per age category, and contestants will be accepted on a first come, first serve basis. Registration will begin June 5th and will continue until all spots are filled or the contest is about to start, whichever occurs first. Entrance fee is determined by age category of contestant.

Contest Rules: Contestants will compete against each other. The object is to finish a set amount of watermelon, to be determined at time of contest, in the shortest amount of time (2 minutes max). Watermelon must be eaten down to the rind and no hands may be used. Contestants must place their hands behind their backs while eating the watermelon. All the watermelon must be consumed and not regurgitated or spit up (this will result in ejection from the contest) prior to the completion of the contest. Contestants must not begin to eat the watermelon until the starting signal. Completion of the watermelon eating is to be decided by a judge, not the contestant. Judges will be on hand to assure adherence to the contest rules and to time the contestants. The winner will be the person who consumes the entire portion of eating, or other tie breaker, will occur, depending on the age category. The judges have the final authority regarding all contest related matters and may cancel the contest at any time. A waiver MUST be signed by each contestant prior to the contest.

Prize Awards: Prizes will be awarded to the first person in each age group who consumes the most watermelon in the allotted time. Prizes will be awarded at the discretion of the judges at the completion of the contest.
