-Farmers market booths are encouraged and welcome. Food must be grown locally and represented by the grower or an employee of the grower:

-Flea market booths are available. All items must be in good overall working condition unless items are antique, vintage, or collectables.

-Arts & Crafts must be unique and represented by the artist or an employee of the artist.

-Commercial Products will be accepted on a case-by-case basis, based on the quality of the product and its appropriateness to the audience.

-Promotion of Services, Business, Politics, & Religion will be accepted on a case-by-case basis and its appropriateness to the audience. No cat calling to the crowds. You can pass out information, & printed gifts.

-Food Concession Vendors must submit a typed menu, duplication of menu items is limited and discouraged. You may be asked to remove or replace an item/items from your menu if another vendor is already signed up to serve said menu item. A health permit from the Environment department, & proof of insurance, must be submitted to ensure the safety of our audience. Mobile vending units & food trailers must also submit the exact dimensions (including tongue) & a photograph of the unit inside & out. Units must be fully self-contained. Food concession booths are

\$400+\$50 gate pass (includes entry for up to 6 people per day). If more than 6 gate passes are needed, you can purchase more as needed. Limited

number of booths available. Limited amount of fully self-contained unit spaces available.

-Exhibitors must provide booth structure (unless renting the limited fair booth spaces), tables, table covers, & chairs. You must set up and take down your display every day as there is no overnight security to watch your booth or displays. If you leave items on the grounds, it is at your own risk.

-Fair booths are covered by a commercial canvas half hoop barn. (Approximately 12' x 20') \$25 for each day + Gate Passes for yourself and employees. You can either purchase gate passes by the day or opt for the discounted vendor \$50 Family Pass (includes entry for up to 6 people per day from July 31st-August 6th, 2023). If you need more entry passes you can purchase more as needed. Food concession booths can not be set up in these booth spaces.
