### CONSENT AND RELEASE PROVISIONS:

This consent and release is given for the purpose of participating in the activities at the Northeast GA Youth Camp, a youth camp held at the Union Grove Campground in Cleveland, Georgia. The Northeast Georgia Youth Camp (NGYC) is an activity sponsored by Pastor Mark Stroud as an Outreach Ministry of Wahoo Baptist Church, Inc. in Murrayville, GA. This camp is in partnership with Preachin' Time Ministries (PTM) and Evangelist Duane Moore which is a ministry of White Oak Springs Baptist Church, Inc. in Dallas, GA. NGYC activities will be held from July 1 to July 12, 2019. I certify that my child (or myself if adult) is able to participate in these activities: including sports, swimming, and other camp related activities unless indicated in the medical information section of this application. If there are any activities that I do not want my child (or myself as an adult) to participate in, I have listed them below my signature. If my child (or myself adult) has a medical condition which may be relevant to a physician in the event of an emergency, I have listed them above in the medical section of the application. (For Minors) In the event of an emergency, I may be reached at the telephone number listed above in this application. If I cannot be reached within a reasonable period of time, I hereby authorize Mark Stroud or Duane Moore, camp directors or the designated adult assistant to make emergency medical decisions for my child (or myself if adult). I authorize camp personnel to administer basic first aid and over the counter medications if need-ed. My consent includes days prior to camp and after camp if I request my child (or myself if adult) to arrive early or stay later. I agree to the use of photos and videos taken of my child by the camp for promotion or other uses (including internet postings) without compensation.

**OFF CAMPUS CLAUSE:** I understand that camp activities scheduled for this camp may include activities away from the campus. These activities may include swimming, river tubing, skating, bowling and other activities determined by the camp staff.
