SEWER/WASTEWATER TREATMENT PLANT – NEW BUSINESS

Sewer Infiltration Project

Sewer Line Replacement- Bailey Lakes Ridge Road and McClain Road

John Benshoff discussion with council about the results from the smoke test revealed an area at Bailey Lakes Ridge Road and McClain Road there are manholes and the sewer line heading towards St. Rt. 250 stopping at the Country Roads Vet Clinic and Dog Kennel/Groomers need to be replaced. The cost of a new sewer line of 164' of 4" SDR-35 pipe with stone at a total cost for this project is \$5,800.00. The concrete manholes will not be replaced at this time and anything inside the manholes will be addresses at that time. Estimated cost to replace a concrete manhole is \$3,000.00.

Jeff Ling moved to approve the sewer line repair project at a cost of \$5,800.00 for material and labor.

Lagoon Cleaning Project
