SEPTEMBER 8th REGULAR COUNCIL MEETING SYNOPSIS:

The meeting was called to order at 6:00 PM and began roll call.

Meeting was held via Facebook live

- August 25, 2025 regular meeting minutes were discussed and approved. Approved meeting minutes
 are available to download on the Village website: baileylakes.org
- Council received a noise complaint that was sent to the solicitor.
- Resolution 08-25-2025A: "A resolution accepting the amounts and rates as determined by the budget commission and authorizing the necessary tax levies and certifying under the county auditor." passed.
- Council discussed Resolution 08-25-2025B: "A resolution adopting a social media and comment policy for the Village of Bailey Lakes." Not passed. Removed from further discussion.
- Council passed a motion to discontinue Facebook live-streaming of the meetings. Council will retain live-streaming equipment for future use.
- Meeting/agenda procedure ordinance tabled.
- Village Administrator Tabled. Information was presented regarding candidates that have been
 interviewed in the past and current candidates interested. Dottie Scott requested a maximum amount
 council could afford to pay the Village Administrator. Leighanna Cawrse recommended that council
 hold an executive session to discuss details of employing a Village Administrator. Executive session
 was set for October 13, 2025.
- Meter reading: A motion was passed by council to have Cody Pitsenbarger continue meter readings through September 2025.
- In light of resident complaints/questions received regarding recent tree trimming in the Village right-ofway, Leighanna Cawrse recommended improved communication/written notification between the Village and residents.
- Vacating First Street pending. September 22, 2025 Regular Meeting location will be held on site at First Street and Boulevard to better evaluate this request.
- Catch basin at Friendly Express, Culvert on McClain, and depression on Indian Drive estimates tabled.







Sheet Pan Breakfast Pizza

Course: Breakfast **Cuisine**: American

Keyword: Breakfast Pizza, Easy Breakfast Recipe

Servings: 8 people

Ingredients

- (2) 6.5 oz packages of Martha White Pizza Crust + oil and water
- White Gravy (3 tbsp butter, 3 tbsp flour, and 2 cups of milk)
- 8-10 pieces of bacon
- 4 eggs
- Shredded cheddar cheese
- Shredded mozzarella cheese
- Salt and pepper



Instructions

- 1) Cook 8-10 pieces of bacon however you'd like! I prefer to bake it in the oven at 400 degrees F on a sheet pan lined with parchment paper. Bake for 20-25 minutes.
- 2) Mix Martha White Pizza crust following the directions on the package. Spread the pizza crust out over a large sheet pan. Poke holes in the pizza crust and prebake following the directions on the package.
- 3) Scramble at least 4 eggs, season with some salt and pepper, and set aside.
- 4) Make the gravy by melting 3 tbsp of butter in a large skillet over medium high heat. Add 3 tbsp of flour and stir together. Let flour and butter cook for one minute. Add 2 cups of milk and stir continuously until gravy reaches your desired consistency seasoning with salt and pepper.
- 5) After prebaking the pizza crust, spread some of the gravy over the top (I didn't quite use all the gravy I made). Top with both kinds of shredded cheese, eggs, and chopped bacon.
- 6) Bake at 475 degrees F for about 10 minutes or until all the cheese is melted. Enjoy!

Notes

This recipe freezes and reheats well. Freeze in gallon size zip lock bags and separate the slices with parchment paper, so they don't stick together. To reheat from frozen I put it in the air fryer at 400 degrees F for 5-7 minutes.
