#### **ORDINANCE # 2025-02**

# ORDINANCE AMENDING ORDIANCE 3-72 PROHIBITING THE DISCHARGE OF FIREARMS WITHIN THE VILLAGE OF BAILEY LAKES

WHEREAS, Council desires to clarify the circumstance under which firearms and bow and arrows and similar devices can be discharged, shot, or thrown within the Village and provide penalties for their violation.

**NOW, THEREFORE, BE IT RESOLVED**, by the Council of the Village of Bailey Lakes, Ohio, that Ordinance 3-72 is hereby repealed and amended as follows:

### SECTION 1. REPEAL OF ORDINANCE 3-72.

Ordinance 3-72 which reads as follows is hereby repealed in its entirety:

- Sec. 1. It shall be unlawful for any person to discharge any firearms within the corporate limits of the Village of Bailey Lakes, ,Ashland, .county, Ohio.
- Sec. 2. Penalty. Whoever violates this ordinance shall be guilty of a misdemeanor and shall be fined not exceeding \$100.

## SECTION 2. DISCHARGING FIREARMS.

- (a) No person shall discharge any air gun, rifle, shotgun, revolver, pistol or other firearm within the Village of Bailey Lakes.
- (b) This section does not apply when firearms are used in self-defense, in the discharge of official duty or when otherwise lawfully authorized.
- (c) This section does not apply where the discharge of firearms is conducted within an indoor or outdoor facility dedicated for commercial or nonprofit purposes as a firing range or gun club, provided the facility has been lawfully established and received appropriate permits.
  - (d) Whoever violates this section is guilty of a misdemeanor of the fourth degree.

#### **SECTION 3. THROWING OR SHOOTING ARROWS.**

- (a) No person shall throw, shoot or propel an arrow, missile, pellet, stone, metal or other similar substance capable of causing physical harm to persons or property, in or on any public place, in or on the property of another, or from any private property into or onto any public place or the property of another. This section does not apply to supervised archery ranges or instruction nor when otherwise lawfully authorized.
  - (b) Whoever violates this section is guilty of a misdemeanor of the fourth degree.
