



Hello and welcome to Act 2 Rescue support. We are thankful you contacted us for help with this animal. If you are a rescuer who found an animal needing help, or have reached out to us in a hard time and have a pet that needs rehoming, we are here to assist you.

Please know that rescue is a very expensive undertaking and we are constantly juggling many responsibilities to be able to do what we do. We understand that times are hard financially for many people but we cannot help animals out without some assistance. We ask for a one time donation of \$110 in order to be able to give your animal and others vital care needed. Our staff is completely volunteer at this time and many also contribute their own funds to animals that come in. Due to this, it is only fair to ask you to contribute in some way. If you're unable to do this please fill out the additional scholarship form to waive the donation requirement. We don't want an animal left out in the cold due to a lack of financial ability but we also hate to be unable to help animals who get ill due to overextended financial responsibilities.

Thank you for understanding. These are the steps to our intake process.

1. Complete and return this form
2. Send clear pictures and personality descriptions of the animal to help us in finding the right adopter
3. \$110 donation\* in cash or Zelle (Act2Rescue@gmail.com)
4. If you are fostering your own cat, complete our [foster contract](#) and support us in rehoming by making sure to meet us at all medical and intake appointments, send updated pictures and descriptions, and be available for meet and greets with adoptive families. \*\*

We are happy to assist you and look forward to working with you to help make a difference in this animal's life. Transition is often hard on animals and many unexpected expenses arise. Your support financially and time are greatly appreciated as they are crucial to our ability to continue this work.

\*\*If unable to foster until a family is found, special arrangements need to be made when a space is available. Due to the lack of fosters, we usually have to turn people away so please don't take a space if you can hold an animal in a safe location. We are happy to help you figure this out or even find your own foster support person and train them. If we are able to find a foster, you must transport them within a 2-day period unless other arrangements are agreed upon.

### Owner Relinquishment Agreement

**ATTACHMENT B (Relinquishment Policy & Procedures)** I have determined that I am no longer able to care for my dog/cat and agree to relinquish ownership of that animal to Act 2 Rescue. I understand that in doing so I agree to the following conditions: Please initial each section upon reading

\_\_\_\_ 1. I relinquish all interest in this animal to Act 2 Rescue and I release the Rescue, its officers, volunteers and employees from all claims, present and future relating to the disposition of this animal.

\_\_\_\_ 2. I certify that, to the best of my knowledge and belief, this animal has not bitten any animal or person within the past ten (10) days.

\_\_\_\_ 3. I understand and agree that if this animal, at any time, is deemed unadoptable by Act 2 Rescue after a minimum of two calendar days (48 hours) that I will retrieve this animal.

\_\_\_\_ 4. I understand and agree that I may not rehome, euthanize, let loose or do anything to the animal without the written expressed permission of A2R.

\_\_\_\_ 5. Legal actions will be taken to recover fees of medical and time invested in helping your animal if control of the animal is not given over to A2R for the adoption within 48 hours of an adopter being found.
