**GENERAL NOTES
SECTION FOUR CHERRY BRANCH SOUTH**

1. PORTIONS OF THIS SUBDIVISION LIES WITHIN THE 100 YEAR FLOOD HAZARD BOUNDARY, ACCORDING TO THE FEDERAL EMERGENCY MANAGEMENT AGENCY FLOOD INSURANCE RATE MAP COMMUNITY - PANEL NUMBER 370072-0415B EFFECTIVE DATE MAY 4, 1987. THE BASE FLOOD ELEVATION IS 9.0 NGVD.
2. STREETS IN THIS SUBDIVISION SHALL BE CONSTRUCTED TO PUBLIC STANDARDS AS REQUIRED BY CRAVEN COUNTY SUBDIVISION REGULATIONS. STREETS SHALL BE OWNED AND MAINTAINED BY THE PROPERTY OWNERS ASSOCIATION. THE FOLLOWING RESTRICTIONS SHALL ALSO APPLY:
 - A. PAVEMENT WIDTH SHALL BE A MINIMUM OF 20.00 FEET.
 - B. RIGHTS-OF-WAY AT INTERSECTIONS SHALL HAVE A RADIUS OF 20.00 FEET.
 - C. RIGHTS-OF-WAY AT CUL-DE-SACS SHALL HAVE A RADIUS OF 50.00 FEET, WITH A RETURN RADIUS OF 25.00 FEET.
 - D. STOP SIGN AND ROAD NAME MARKERS SHALL BE INSTALLED IN ACCORDANCE WITH COUNTY AND STATE STANDARDS.
3. DRAINAGE AND UTILITY EASEMENTS ARE AS FOLLOWS:
 - A. 10 FOOT EASEMENTS ALONG RIGHTS-OF-WAY.
 - B. 15 FOOT EASEMENTS CENTERED ALONG ALL SIDE LOT LINES.
 - C. 20 FOOT EASEMENTS CENTERED ALONG ALL REAR LOT LINES.
 - D. OTHER EASEMENTS AS SHOWN ON PLAT.
4. THIS SUBDIVISION TO BE SERVED BY INDIVIDUAL WELLS AND INDIVIDUAL SEPTIC SYSTEMS.
5. MINIMUM BUILDING SETBACKS ARE AS FOLLOWS:
 - A. 10 FOOT SIDE SETBACKS.
 - B. 25 FOOT REAR SETBACKS.
 - C. 30 FOOT FRONT SETBACKS.
 - D. 75 FOOT MINIMUM LOT WIDTH AT SETBACK LINE.
6. TOTAL ACREAGE IN CHERRY BRANCH SOUTH SECTION FOUR IS 32.858 ACRES.
7. FIGURES IN PARENTHESES () DENOTE LOT SIZE IN SQUARE FOOTAGE.
8. ■ DENOTES CONTROL CORNERS.
9. THE TOTAL NUMBER OF LOTS IN CHERRY BRANCH SOUTH SECTION FOUR IS 34 LOTS.
10. THIS SUBDIVISION IS NOT IN A ZONE CONTROLLED BY ZONING REGULATIONS.
11. THE TOTAL LENGTH OF STREETS IS 1956 LINEAR FOOT.
12. ALL CORNERS ARE TO BE MARKED WITH IRON PIPES.
13. APPROVAL OF THIS SUBDIVISION PLAT BY THE CRAVEN COUNTY BOARD OF COMMISSIONERS DOES NOT ADDRESS THE ISSUE OF THE EXISTENCE OR NONEXISTENCE OF WETLANDS WITHIN THE SUBDIVISION. THE ENFORCEMENT OF WETLAND REGULATIONS UNDER THE SECTION 404 OF THE CLEAN WATER ACT OF 1977 IS WITHIN THE JURISDICTION OF THE U.S. ARMY CORPS OF ENGINEERS. INQUIRIES CONCERNING THAT MATTER SHOULD BE ADDRESSED TO THAT AGENCY.
14. ANY PRIVATE WATER SUPPLY SOURCE SHALL BE LOCATED A MINIMUM HORIZONTAL DISTANCE OF 100 FEET FROM ANY OBVIOUS SOURCES OF CONTAMINATION.
15. PLOT PLANS FOR ANY GIVEN LOT WILL BE REQUIRED BY THE CRAVEN COUNTY HEALTH DEPARTMENT.
16. REFERENCE IS MADE TO THE U.S. ARMY CORPS OF ENGINEERS "WETLANDS CERTIFICATION" DATED SEPTEMBER 23, 1991 AS SHOWN ON CERTAIN MAP ENTITLED "404 WETLANDS MAP - CHERRY BRANCH WEST - PHASES ONE, TWO & THREE" AS PREPARED BY THOMAS ENGINEERING CONSULTANTS, P.A.
17. THE CRAVEN COUNTY ENVIRONMENTAL HEALTH SECTION SHALL BE CONTACTED PRIOR TO ANY LAND DISTURBING ACTIVITIES FOR INSTRUCTIONS ON SITE PREPARATION FOR THE WASTE WATER TREATMENT DISPOSAL SYSTEM FOR EACH LOT.



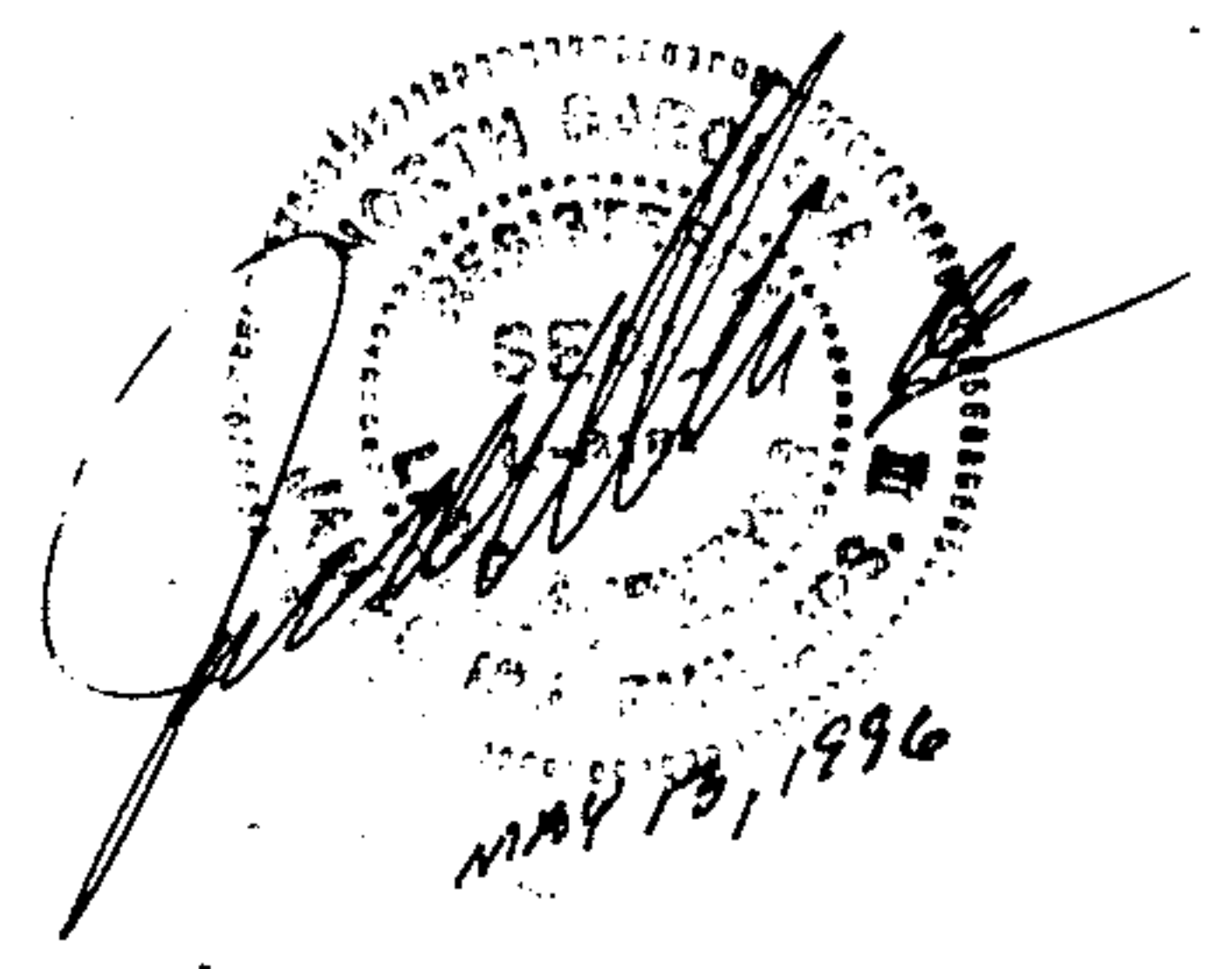
