### OFFICE MEMORANDUM

**Sub:- Clarification regarding whether deductions towards commutation are required to be made from family pension for the remaining period in cases where the pensioner dies before the restoration of commuted pension-reg**

In accordance with Rule 5 of CCS (Commutation of Pension) Rules, 1981, a Government servant can commute for a lump-sum payment of an amount not exceeding 40 per cent of his pension. Further, in accordance with Rule 10-A of CCS (Commutation of Pension) Rules, 1981 the commuted amount of the pension shall be restored on completion of fifteen years from the date of reduction of pension on account of commutation becomes operative in accordance with Rule 6.

2. References/representations have been received in this Department seeking clarification whether deduction towards commutation are required to be made from family pension for the remaining period in cases where the pensioner dies before the restoration of commuted pension.

3. It is clarified that in such cases monthly commuted amount of pension is not required to be deducted from family pension and family pension shall be paid in full without any deduction in this regard.

### FRAUDSTER'S AIM: TO REPLACE YOUR REGISTERED MOBILE NUMBER WITH THEIRS

#### HOW THEY TRAP YOU

- You receive a call/SMS offering "faster processing of your PPO" or stating "verification pending for your PPO". They threaten to block or not to release your pension if not acted immediately.
- Do not click on the link sent by the fraudster and do not disclose your personal information.
- Bank never asks for PPO verification through phone, SMS, links or ATM visits.

#### HOW TO STAY SAFE

- Never share personal/financial information - Username, Password, ATM PIN, OTP with anyone.
- Download/update Banking Apps only through Google Play Store/ App store.
- For any doubt/query always contact your Home/Nearest Branch or call our customer care at 18001234/18002100.
- To report a cybercrime: Call Cybercrime helpline number 1930 or visit [cybercrime.gov.in](https://cybercrime.gov.in).
- Always read SMS / email alerts carefully and don't click on any suspicious / unknown links received through SMS / WhatsApp.
- Your registered mobile number is the key to your bank account. Keep it safe, keep it secure and protect your account from fraud.

### CORRESPONDENCE FOR ISSUES RELATED TO AIR VETERANS

1. The Indian Air Force is ever committed towards welfare of our Air Veterans and their family pensioners. With the aim of synergising and synchronising the functioning of various elements/formations working towards pension and welfare of Air Veterans, Directorate of Air Veterans (DAV) was formed on 17 Sep 12 at Subroto Park New Delhi. Consequently, the role of Pension & Welfare Wing at AFRO was transferred to DAV. This Directorate is mandated to deal with pensionary matters/benefits, resettlement, documentation and grievances / representation of IAF veterans and their dependents.
2. The directorate is entrusted with the following major responsibilities:-
  - 2.1. Processing / Settlement of pensionary benefits including service pension, family pension, gratuity, commutation and related entitlements.
  - 2.2. Management of Ex-Servicemen Contributory Health Scheme (ECHS) related matters.
  - 2.3. Handling of grievances / representations.
  - 2.4. Maintenance of veteran records and liaise with O/o PCDA (P), JCDA(AF) and other agencies for smooth settlement of issues.
  - 2.5. Coordination for resettlement, reemployment and welfare measures for IAF veterans.
3. It has been observed that despite DAV being fully functional, a substantial volume of correspondence from ex-servicemen continues to be addressed to AOC, AFRO. This practice results in duplication of work, unnecessary delays in addressing grievances and diversion of resources from AFRO's primary role of serving personnel record management.

**Sub:-** Engagement of Ex-Servicemen as Pointsman on contract basis against vacancies until availability of regularly appointed candidates.

**Ref:-** Railway Board's letter No. E(NG)II/2021/RC-4/I dated 06.11.2024 (RBE No. 104/2024).

Attention is invited to Board's letter under reference above. Keeping in view the operational requirements, the issue regarding contract engagement of Ex-Servicemen as Pointsman in Railways against short term vacancies in the Pointsman category of posts, as an interim measure pending availability of regularly appointed candidates has been under consideration of the Board for some time.

2. The matter has been examined and accordingly Board (MoBD, MF & CRB) have decided that Ex-Servicemen may also be allowed to be engaged as Pointsmen in terms of Board's letter No. E(NG)II/2021/RC-4/I dated 06.11.2024 (RBE No. 104/2024) subject to following conditions as applicable for the category of Pointsman only :-

(i) In case of shortfall and if there is urgent requirement of filling up of vacancies of the Pointsman category for operational requirements in absence of a regularly appointed Pointsman, then Ex-Servicemen may be engaged as Pointsmen by the Zonal Railways on contract basis directly through Ex-Servicemen Welfare Boards under the Central/State Governments.

(ii) Prior to being put on a working post, the said Ex-Servicemen so engaged will first be subjected to the full initial training prescribed for the post of Pointsman on payment of contractual remuneration and on successfully passing the prescribed course be put to the working post. The candidates who do not pass in the prescribed training or otherwise are not found suitable to work as Pointsmen, will be discharged forthwith after making due payment as per terms & conditions of the contract for the period spent on training.

(iii) Total number of such engagements will be 5058 (Five Thousand and Fifty eight only) over all the Railways as per the zone-wise requirements indented already in the

current recruitment or the number of actual vacancies in the category of Pointsman, whichever is lower. Such engaged Ex-Servicemen will be terminated on joining of regularly appointed persons from open market through RRCs. This aspect should be closely monitored at the Zonal level and the terms and conditions of the said contract must have a clause to this effect.

(iv) The permission for engagement of Ex-Servicemen as Pointsmen in the above mentioned manner would initially be valid upto 31.12.2026. Their further extension will be permitted depending on vacancy position at that time, for which ZRs should specifically obtain prior approval of Board.




