### STANDARD OPERATING PROCEDURE FOR POST RETIREMENT OCCURRENCES: OFFICERS RETIRED WITH PENSIONARY BENEFITS

#### INTRODUCTION

1. There are various occurrences after retirement i.e. birth of child, change of NoK due to marriage / re-marriage / divorce / death of spouse, change of name of self / spouse / children, correction of date of birth of self / spouse / children etc, in which necessary amendment to Certificate of Service(CoS) is required to be issued by this Dte/ Dte of PO as per the directions of ACAS (PO) vide letter Air HQ/21901/3496/PO-2(C) dated 16 Feb 12. In addition, for occurrences like change of correspondence / present address, change of Pension Disbursing Authority (PDA), deletion of name of family pensioner in case of death etc, necessary action is required at various agencies for updation of records.

#### <u>AIM</u>

2. The aim of this SOP is to lay down procedure for actions related to post retirement occurrences as mentioned in Para 1 above in respect of officers and their NoK /dependents.

#### **PROCEDURE**

3. There are two types of occurrences post retirement of an officer i.e. occurrences requiring amendment to Certificate of Service (CoS) and occurrences not affecting Certificate of Service. Occurrences affecting CoS are those occurrences in which amendment to CoS is mandatory and is to be issued by concerned authorities. On the other hand, there are some occurrences which do not affect Certificate of Service but updation of the records is required for future reference / action by various agencies.

#### Occurrences in which Amendment to Certificate Of Service (CoS) to be Issued

- 4. Amendment to Certificate of Service (CoS) is required to be issued in following cases: -
  - (a) Change of name of the retired officer or his/her spouse and children.
  - (b) Correction of date of birth of the retired officer or his/her spouse and children.
  - (c) Birth / adoption of child.
  - (d) Addition / deletion of spouse details on marriage / re-marriage / divorce / death.
  - (e) Any other case in which amendment is required in the details mentioned in Certificate of Service issued at the time of retirement.
- 5. On receipt of information of any post retirement occurrence from the officer / NoK, the following actions will be taken for issue of amended certificate of service: -
  - (a) Pensioner/NoK of the Veteran will be required to submit documentary proof in original for the said occurrence.
  - (b) Existing details of the pensioner/family members will be checked from the records available with this Dte/Dte of PO.
  - (c) If copy of CoS is not available in the records held with this Dte, the same will be sought from Dte of PO.
  - (d) Wherever legal implications are involved, Legal opinion will be obtained before issue of amended certificate.
  - (e) After due verification of the existing details, the amended CoS will be issued with the approval of Air Cmde AV.

- 6. On receipt of applications from the retired officer / NoK along with required documents, the case in which amendment / correction / endorsement in CoS is required to be issued, actions will be initiated for issuance of amended CoS. Thereafter, the amended CoS with other necessary documents will be forwarded to Jt CDA (AF) or PCDA (P) Prayagraj, as the case may be, for issuance of PPO / corr PPO, if required.
- 7. <u>Correction / Change of name</u>. The criteria for 'correction in' or 'change of' name for the purpose of this SOP will be as under: -
  - (a) <u>Correction of name</u>. The following actions would be construed as 'Correction of name' for the categories given below: -
    - (i) <u>Self.</u> If the name in the service records of a pensioner is not recorded as in the documents submitted by him/her at the time of joining the service, the same would be construed as an error in the name warranting correction of name. Such corrections may be owing to incorrect filling of forms at the time of joining or wrong annotation by the IAF staff in the records of the individual (AFO 64/2015 refers). In all such cases the name as reflected in the documents then submitted will be relied upon for effecting correction of service records. The same will be corrected by the P-Branch based on documents held. No action by the pensioner other than bringing to notice the said error by way of an application with self-attested matriculation or any other documents produced at the timing of commissioning/enrolment (as applicable) is envisaged.
    - (ii) <u>Spouse/dependent</u>. In respect of spouse/dependent who is also a government pensioner the procedure and documents required would be the same as in the self-category.
  - (b) <u>Change of name</u>. In all cases where the spouse/dependent are other than government employees, changes in any measure or manner will be construed as falling in 'change of name' category. Specifically the following cases would come in the ambit of the 'Change of name' category: -
    - (i) Inclusion or deletion of a single alphabet or more.
    - (ii) Inclusion/ deletion of First Name, Middle Name and Surname.
    - (iii) Inclusion/ deletion of any part of the Name for change in respect of village, father's name, caste etc.
    - (iv) Change in Name on change of Marital Status.
    - (v) Split/ merger of any part/ parts (First Name, Middle Name and Surname) of the Name.

- (vi) Any changes which alter the first name and/or the middle name and/or the surname in any form and for any purposes.
- (vii) Any change that is not as recorded in the documents submitted to the IAF.
- (c) <u>Documents required</u>. The requirement of documents in respect of 'Self' and 'spouse/ dependent' category would be as given below: -
  - (i) <u>Self.</u> In case of a pensioner the following documents would have to be submitted: -
    - (aa) Application from pensioner/retired officer.
    - (ab) Self attested copy of Gazette Notification.
    - (ac) Advertisement in Newspaper (in English) as per Appendix 'E'.
    - (ad) Proof like Matriculation certificate/ Aadhaar / PAN card etc.
  - (ii) Spouse / Child / dependent. In case of a spouse/ dependent following documents would have to be submitted:-
    - (aa) Application from pensioner/ family pensioner/ retired officer.
    - (ab) Self attested copy of Gazette Notification/ Notarised Affidavit (on non-judicial stamp paper of minimum Rs 10/-) as per format given at **Appendix 'A' I 'B' I 'C' I 'D'** (as applicable). <u>Gazette Notification is mandatory in case of spouse is a retired/ released Government Employee</u>.
    - (ac) Advertisement in Newspaper (in English) as per Appendix 'E'.
    - (ad) Matriculation certificate/ Aadhaar / PAN card etc.
    - (ae) Latest pension account details (A/c No., IFSC, Bank address).
    - Note 1. In case of change/ correction of name and DOB/ age both, Gazette Notification is mandatory.
    - Note 2. DoB of spouse along with change of name will be endorsed in case his/ her DoB has not been endorsed in CoS.

- 8. <u>Addition of Children Details on Birth After Retirement</u>. Following documents are required to be submitted to DAV for addition of details of child on birth after retirement of an officer: -
  - (a) Personal application by retired officer.
  - (b) Affidavit / declaration on non-judicial stamp paper of minimum Rs 10/- by adult child as per **Appendix** 'K' or by pensioner in case of minor child declaring his/her correct DoB as per **Appendix** 'L'.
  - (c) Birth certificate issued by Registrar of Births and Deaths (to be self attested by retired officer in case photocopy is being attached) or Self attested copy of matriculation certificate (containing information regarding date of birth) and Passport/ PAN Card/ ECHS Card/ Driving License (if contains date of birth)/ Election ID Card/ Aadhaar Card.
- 9. <u>Addition of Children Details on Adoption After Retirement</u>. Following documents are required to be submitted to DAV for addition of details of child on adoption after retirement of an officer: -
  - (a) Personal application by retired officer.
  - (b) Adoption deed in original or Certified True Copy (CTC) of adoption deed from the Hon'ble court where the adoption deed took place.
  - (c) Birth certificate of child issued by Registrar of Births and Deaths. To be self attested by retired officer in case photocopy is being attached.
- 10. <u>Endorsement / Addition Of Spouse Details On Marriage / Re-Marriage / Divorce / Death</u>. Following documents are required to be submitted to DAV for endorsement / addition of spouse details on marriage / re-marriage / divorce / death in service records as well as in pension payment order(PPO): -
  - (a) Personal application by retired officer. Following details also to be mentioned in the personal application: -

(b) Marriage certificate issued by Registrar of Marriage. To be self attested by retired officer in case photocopy is being attached or in old cases where marriage certificate is not available then proof of marriage such as Passport/ Electoral Identity Card/ Succession certificate issued by court/certificate issued by Executive Magistrate.

- (c) In case of marriage/re-marriage with widow / widower, death certificate of former spouse issued by Registrar of Births and Deaths. To be self attested by retired officer in case photocopy is being attached.
- (d) In case of marriage/re-marriage with divorcee, divorce decree (Absolute) from former spouse in original or self attested copy.
- (e) Affidavit (on non-judicial stamp paper of minimum Rs 10/-) by retired officer / spouse as deponent declaring maiden name of spouse, name of his/ her parents, date & place of birth, nationality, date & place of marriage, rites under which marriage was solemnized and marital status before marriage i.e un-married/ widow/ widower/ divorcee and if married, details of children from previous marriage (self as well as spouse) and children whether being adopted or not. If adopted, copy of adoption deed duly attested by issuing court of law is to be submitted.
- (f) Endorsement of family pensioner entitlement Appendix 'A' (**Appendix 'F'**). (in triplicate, all ink signed) duly signed by Bank Manager (where pension account is being operated) in Part-II.
- (g) Particulars of spouse (in triplicate, all ink signed) (as per Appendix 'G').
- (h) Three joint photographs duly attested by Bank Manager (where pension account is being operated).
- (j) Cancelled Cheque/ copy of front page of Passbook/ Bank certificate (as per **Appendix 'H'**).
- (k) Self attested copy of proof of DoB of spouse i.e. birth certificate/matriculation certificate/ passport/ PAN/ Aadhaar.
- 11. <u>Deletion of Spouse Details on Divorce / Death</u>. Following documents are required to be submitted to DAV for deletion of details of spouse on divorce or death after retirement of an officer: -
  - (a) Personal application by retired officer.
  - (b) Self attested Divorce decree (Absolute) to be attached.
  - (c) In case of death of spouse, Death certificate issued by Registrar of Births and Deaths. To be self attested by retired officer in case photocopy is being attached.
- 12. <u>Corrections/ endorsement of Date of birth (Spouse, Children and Dependents)</u>. Occurrence like correction/ endorsement of date of birth of spouse, children and dependents which is already endorsed in records of the retired officer, following documents are required to be submitted to DAV for the same: -
  - (a) Personal application by retired officer.

- (b) Affidavit / declaration on non-judicial stamp paper of minimum Rs 10/- by **spouse** as deponent declaring his/ her correct DoB (as per **Appendix 'J'**). In case of child, Affidavit by adult child as per **Appendix 'K'**, by pensioner in case of minor child declaring his/her correct DoB as per **Appendix 'L' and** by dependents as per **Appendix 'M'**.
- (c) Birth certificate issued by Registrar of Births and Deaths (to be self attested by retired officer in case photocopy is being attached) or Self attested copy of matriculation certificate (containing information regarding date of birth) and Passport/ PAN Card/ ECHS Card/ Driving License (if contains date of birth)/ Election ID Card/ Aadhaar Card.
- (d) Latest pension account details (A/c No., IFSC, Bank address).
- 13. Addition of Dependents other than Spouse and Children. Following documents are required to be submitted to DAV for declaring entitled family members i.e. Father / Mother / Sister / Brother as dependents: -
  - (a) Personal application giving details of dependent and their relationship.
  - (b) Income certificate stating that their combined monthly income is not more than Rs 9000/month including DR issued by District Revenue authority along with details of moveable and immoveable property.
  - (c) A Certificate from Tehsildar / Magistrate stating the details of retired officer's family members i.e. Father / Mother / Sister / Brother, their relationship and the fact that they are wholly dependent on Air Veterans and residing with him.
  - (d) Self Declaration by pensioner as per **Appendix 'N'**.
  - (e) Copy of proof of Date of birth of dependent (in DD/MM/YYYY format)

### Occurrences in which Amendment to Certificate of Service (CoS) not to be Issued

- 14. Apart from the occurrences mentioned above in Para 7 to 12, there are certain occurrences post retirement of an officer which does not affect Certificate of Service(CoS) but the records held at DAV and Pension Sanctioning Authority (PSA) needs to be changed and updated for future action. Such cases are elaborated in succeeding paragraphs.
- 15. Change of Communication Address after Retirement. DAV only maintains record of address after retirement for the purpose of communication with the officer retired with pensionary benefits. Following documents are required to be submitted to DAV for the same:-
  - (a) Personal application by the retired officer mentioning complete address including PIN code, Mobile number & E-mail ID.

- (b) Proof of address i.e House Property papers / water bill / electricity bill / Aadhaar card / Voter ID card / Passport etc.
- 16. Change/ Transfer of Pension Account / Bank / Branch after Retirement. Change/ Transfer of pension account is to be done by the bank on the basis of the request from the account holder in accordance with Defense Pension Payment Instructions 2013 (DPPI) (Para No 93). Further, an intimation for the same is to be sent to DAV for records after the pension account has been changed / transferred to new account / branch and first pension is getting disbursed in the new pension account / bank. Following documents are required for subject intimation for updation of records in respect of officers retired with pensionary benefits:
  - (a) Personal Application from the retired officer mentioning A/c No., IFSC, Bank address.
  - (b) Copy of cancelled cheque / passbook of new pension account/bank.

#### **Short Service Commissioned (SSC) Officers**

17. Short Service Commissioned (SSC) Officers are non-pensioners and hence there records are not held with AV (Officers) i.e. Service Pension Officers Section at DAV. But, in some cases, there are occurrences post retirement of an SSC officer which are required to be added in service records. Since, Certificate of Service is not issued for SSC officers, a certificate containing the service details as well as family details is being issued by Dte of PO-2(C) in such cases. Further, on request/application from SSC officer, a new certificate is issued by DAV on the basis of certificate issued by DPO-2(C) after endorsing post retirement occurrences. The documents required for endorsement of post retirement occurrences which require issuance of certificate by this Dte/ Dte of PO for SSC officers are same as in case of pensioners.

#### Issuance Of Service Book Officers(SBO)

- 18. IAF officers are being issued with a "Certificate of Service (Booklet)" on Retirement/ Premature Retirement/ Release since 1975. The format of CoS (Booklet) has been revised and it has been renamed as "SERVICE BOOK: OFFICERS (SBO)" vide Air Force Order 41/2015. It is to serve as an authentic record of an officer's service and encapsulates major occurrences of his/ her service, as on the date of retirement/ release from the IAF.
- 19. Subsequently, as per Air Force Order 35/2017 dated 13 Dec 17, retired officers who are not issued with Service Book Officers (SBO) are to approach any nearest Air Force unit / station for issuance of the same.

#### CONCLUSION

- 20. The above procedure will help out in simplification and uniformity of procedures as envisaged by Government of India in this regard. This would facilitate retired officers for smooth and hassle free processing of their cases within stipulated timeframe.
- 21. This SOP supersedes all the previous procedures issued vide Air HQ/99797/Pen-Pol/RP/O/DAV dated 28 Jun 21 and will come into effect from the date of issuance.
