



MEMORANDUM OF UNDERSTANDING

AND

Air Force Association, Odisha Branchan organisation established for the welfare of air veterans and their families in the state of Odisha and having its registered office at Plot No. 2612, Leelakunj, Near Sangtoshi Maa Mandir, Patrapada, Bhubaneswar, Khorda, Odisha – 751019 (hereinafter referred to as AFA) represented by Veteran Group Captain J Brahma, President which expression shall whenever the context so require or admit, mean and include its successors and assigns) of the SECOND PART

WHEREAS

- A. BRIDGE is in the business of promotion of Atmanirbharta in Defence Sector by involving its member MSMEs and Academia spread across the nation, wherein they engage military veterans to guide, mentor and support the industry and academia to understand the operational and quality requirements besides the challenges of the end-users at field units, while undertaking Make in India Projects. To handle such a responsibility, the veterans are provided with training and skill development to understand the needs of industry, corporate culture and the defence procurement procedure.
- B. AFA Branchis engaged in working for welfare of ex-servicemen under the guidance of AFA Head Office, New Delhi.
- C. BRIDGE is desirous of developing a pool of industry ready veterans through imparting requisite skill training and placement related campaigns. Further BRIDGE is also developing an exclusive portal for creating a professional database for domain experts from military background who have acquired a very high degree of skills which can be effectively employed by the industry & academia in the Defence and Civil Sector (including MSMEs, Service Industries, Colleges and other business entities affiliated to it). AFAOdisha and BRIDGE intend to collaborate on their mutual goal of helping ex-servicemen from military background to pursue their careers in corporate as well as academia.

NOW THEREFORE IN CONSIDERATION OF THE MUTUAL CONVENANTS AND UNDERSTANDING HEREIN CONTAINED THE PARTIES HERETO AGREE AS FOLLOW:

- BRIDGE and AFA may from time to time collaborate to create a platform to help exservicemen with opportunities to work at or engage with industry/academia subject to compliance with upskilling & selection process and policies in respect of such engagement.
- 2. Non-Binding MoU: This MoU, by itself is non-binding in nature and no definite rights and obligations arise between the parties pursuant to this MoU.

Confidentiality: BRIDGE and AFA agree that the parties may exchange confidential information regarding bio-data/resume of ex-servicemen, skills developed, positions offered and candidates sponsored, with each other during the course of the parties' collaboration under this MoU and the same will not be used by either party in connection with the subject matter of this MoU, or will not be disclosed to any other third party without the prior written consent of the other party.
- 4. <u>Public Announcements:</u>The form, content and timing of any press release or disclosure regarding any aspect of the collaboration of the parties under this MoU shall be made jointly by BRIDGE and AFAOdisha upon signing of this MoU.
