How can I change or update my login password?

You can update your password as applicable.
Go to: My Profile > Change Password, and update as applicable.

I have forgotten my login password. What should I do?

- 1. You can change your forgotten password. Click on Forgot Password on the Login Screen, and update as applicable
- 2. You can call the SPARSH Helpline, provide necessary details and access using temporary password provided
- 3. You can visit the nearest Service Center, provide necessary details and access using temporary password provided

Will login in portal available 24*7 hours?

Yes. You can access the SPARSH portal anytime & anywhere

Where can I find out the list of service centres in my area?

The list of active Service Centers is available on SPARSH.

How can I avail services through Service Center?

You can view & download your pension payment order (PPO) in SPARSH. Log in to your SPARSH account, and go to: My Documents > Pension Slip

Where can I find the current & previous rates of DR applicable?

The table of Dearness Relief (DR) rates applicable till date is available on SPARSH.

How can I view the deduction of commutation amount from my pension?

You can view & download your monthly pension payments & deductions in SPARSH. Log in to your SPARSH account, and go to: My Documents > Pension Slip

How can I view the date of restoration of the deduction of commutation amount?

You can view your commutation details in SPARSH.

Log in to your SPARSH account, and go to: My Documents > Entitlements

Alternatively, you can access your PPO via My Documents > PPO

How can I view that benefit of broadbanding has been given to me?

You can view your pension details in SPARSH.

How can I view my projected tax details of the financial year?

You can view your pension details in SPARSH.

Where can I find the latest rates of Gallantry applicable?

The details for Gallantry Awards along with the applicable rates till date is available on SPARSH. Go To: Pension Orders & Information > Common Problems > Gallantry Awards

Where can I find the current & previous rates of Fixed Medical Allowance applicable?

The details for Fixed Medical Allowance (FMA) along with the applicable rates till date is available on SPARSH. Go To: Pension Orders & Information > Common Problems > Fixed Medical Allowance

C) PENSIONER DATA VERIFICATION

What is Pensioner Data Verification?

Pensioner Data Verification (PDV) aims at enabling the retiree to verify his/her own details before sanction of pension. Applicable only for Service Pensioners. This activity should be completed within 15 days of notification via SMS/Email sent to your Registered Mobile Number/Email ID

D) PENSIONER IDENTIFICATION

The SOP on identification is at stage of finalization and will be shared to all concerned shortly.

My annual identification is due. How can I identify myself in SPARSH?

You can identify yourself using Aadhar, or provide life certificates issued by designated authorities to have the entitled pension credited to your bank account. For identification using Aadhar (Digital Life Certificate): Go To: Services > Identification > Digital Life Certificate

For identification using Manual Life Certificate: Go To: Services > Identification > Manual Life Certificate

How can I view my next idenification date?

Go To: Services > Identification, and view details of your identification completed, including last identification date & next identification due date

How can I obtain a blank form of Manual Life Certificate?

You can identify yourself using Aadhar, or provide life certificates issued by designated authorities to have the entitled pension credited to your bank account. For identification using Manual Life Certificate:

- 1. Go To: Services > Identification > Perform Identification
- 2. Generate your MLC Number & download the blank form for Manual Life Certificate

Is there a time limit for uploading of Manual Life Certificate after download on Portal?

No. Manual Life Certificate can be uploaded anytime on SPARSH

Can a last year downloaded form be used this year for Manual identification?

No. Manual Life Certificate once submitted for identification cannot be reused.

Whether I would be able to receive all my pensionary arrears on delayed identification?

Yes. Upon delayed identification, all applicable pensionary arrears shall be paid.

Life Certificates can be issued/signed by one or other of the following authorities.

- (i) Any person exercising the power of a Magistrate under the Criminal Procedure Code, 1898 (5 of 1898).
- (ii) A Registrar or Sub-Registrar under the Registration Act, 1908 (16 of 1908).
- (iii) Any pensioned Officer who before retirement exercised the powers of a Magistrate.
- (iv) Any Gazetted Officer of Government.
- (v) A Munsif.
- (vi) A Post Master.
- (vii) A Departmental Sub Post Master.
- (viii) An Inspector of Post Offices.
- (ix) A Class I Officer of the Reserve Bank of India.
- (x) An Officer of the State Bank of India.
- (xi) An Officer of a subsidiary Bank of the State Bank of India.
- (xii) Head of a Village Panchayat, Gram Panchayat or Gaon Panchayat.
- (xiii) Head of an Executive Committee of a village.
- (xiv) An officer of a bank included in the second Schedule to the Reserve Bank of India Act, 1934 (2 of 1934) in respect of pensioner drawing his/her pension through that Bank.
- (xv) A Police Officer not below the rank of Sub-Inspector-in-Charge of a Police Station.
- (xvi) A member of Lok Sabha/Rajya Sabha/Vidhan Sabha/Vidhan Parishad or a Corporator of Municipal Corporation or a Councilor of a Municipality.
- (xvii) In the case of pensioners reemployed a life certificate furnished by the pensioner signed by the Head of the office, where he is re-employed.
- (xviii) A District Sainik Welfare officer- (DSWO).

E) SERVICE REQUEST

How do I report death of a family member in SPARSH?

Go To: Services > Report Event > Death, and provide required details along with copy of Death Certificate

How do I report about a missing family member in SPARSH?

Go To: Services > Report Event > Missing, and provide required details along with copy of FIR

How do I report about a convicted family member in SPARSH?

Go To: Services > Report Event > Conviction, and provide required details along with copy of Judgement

What is Initiate Family Pension?

You can request for your share of pension via Initiate Family Pension

Go To: Services > Report Event > Initiate Family Pension, and provide required details alongwith necessary documents as applicable

How do I update my basic details (Mobile Number, Bank Account Number, PAN etc.) in SPARSH?

After the identification process is complete and approved, you can manage & update your profile details like personal details, service details, family details etc. by logging in to your SPARSH account. Log in to your SPARSH account, and go to: My Profile > Manage Profile

How do I add/remove family details (Spouse/Dependents) in SPARSH?

After the identification process is complete and approved, you can manage & update your profile details like personal details, service details, family details etc. by logging in to your SPARSH account. Log in to your SPARSH account, and go to: My Profile > Manage Profile

My annual identification is due. How can I identify myself in SPARSH?

You can identify yourself using Aadhar, or provide life certificates issued by designated authorities to have the entitled pension credited to your bank account.

For identification using Aadhar (Digital Life Certificate): Go To: Services > Identification > Digital Life Certificate

For identification using Manual Life Certificate: Go To: Services > Identification > Manual Life Certificate

How can I declare my investments or proof of savings for tax purposes in SPARSH?

You can declare & manage your investments in SPARSH by logging into your SPARSH account.

Log in to your SPARSH account, and go to: Service Requests > Investment Declarations

How can I apply for commutation in SPARSH?

You can apply for commutation by logging into your SPARSH account.
Log in to your SPARSH account, and go to: Service Requests > Commutation Requests

I have registered a Service Request in SPARSH. How can I track it?

You can raise a payment related grievance for the same by logging into your SPARSH account Log in to your SPARSH account, and go to: Grievances > Payment Related > Deduction

How can I report or update re-employment details including discharge from re-employement?

After the identification process is complete and approved, you can report your employment/re-employment details by logging in to your SPARSH account. Log in to your SPARSH account, and go to: My Profile > Employment/Re-Employment

How can I report my marriage/re-marriage?

After the identification process is complete and approved, you can report your marriage/remarriage details by logging in to your SPARSH account. Log in to your SPARSH account, and go to: My Profile > Report Remarriage

How can I request to stop my Fixed Medical Allowance for availing ECHS facility?

For Indian resident pensioners: If you don't wish to continue availing Fixed Medical Allowance (FMA), you need to update the FMA option in your personal profile by logging in to your SPARSH account.

Go to: My Profile > Manage Profile > Personal Details > Fixed Medical Allowance

How to draw Fixed Medical Allowance if I am not availaing any ECHS facility?

For Indian resident pensioners: if you wish to opt for Fixed Medical Allowance (FMA), you need to update the FMA option in your personal profile by logging in to your SPARSH account. Note: Your address should be part of the districts eligible for FMA. Please verify your address before applying for FMA.

Go to: My Profile > Manage Profile > Personal Details > Fixed Medical Allowance

How can I claim death gratuity of my late husband?

The demise of the deceased member needs to be reported first

CHECK LIST FOR WIDOW AFTER DEATH

STEPS TO BE TAKEN BY YOUR WIFE (WIDOW)/NEXT OF KIN (NOK) AFTER DEATH OF HUSBAND (ESM):

Step-1: Collect very Initial Death Certificate from Authorised Doctor/ Hospital, in which personal and address details (as per Aadhaar card) and "Cause of Death" is clearly written.

Note: In case of Unnatural death(Suicide or Accident), collect copies of Medical Report, FIR, Postmortem Report, Police Investigation Report also.

Step-2: Inform relatives and finalise funeral formalities. Call 1904 (Army exchange to connect to dependent Stn HQ for laying wreath and paying homage by Army personnel to the mortal remains of Veteran).

Note for AF: In case of funeral of Air Veteran is planned near any AF Stn, then immediately inform Stn authority about the death of veteran, along with location and time of funeral. AF Stn will send a contingent to lay wreaths and pay homage to the mortal remains of Air Veteran.

Step-3: After funeral completed, collect Temporary Death Certificate from Burning ghat/ Burial ground/ Cremation ground.

Step-4: Apply for ORIGINAL and permanent Death Certificate (DC) preferably within 15 days of Death at the Registrar of Births & Deaths Office as per your locality.

Note: If DC is issued with QR & Bar codes and name of website, then download DC as and when required. But, if Bar Code is not printed, then keep ready 10/15 additional copies of DC duly attested by Secretary ZSB or any Gazetted officer for submission at multiple agencies.

Step-5: Apply to PDA (Pension Disbursing Authority/ Bank) to STOP Service Pension of ESM. Submit copies of DC, PPO and First page of Bank Passbook and copy of Widow's Aadhaar Card to bank.

Note: If ESM was getting pension from SPARSH, then, upload DC and intimate Death in SPARSH website (spash.defencepension.gov.in)- Click "service" module- Death reporting- Sub module "For Family".

Step-6: Apply to bank to Start Family Pension in favour of the widow.

If the ESM had a JN-PPO (Wife's Correct Name is written in PPO with Correct DOB in Aadhaar card and PPO) and his Pension Account was also jointly held with Wife, then, Bank will convert that joint Pension Account into Single account on Widow's Name and give family pension to her. Widow should submit a copy of PPO, Adhaar card, PAN Card and two passport size photos of her in the Bank to start her pension. Also she should submit Life Certificate to bank to get first time Pension.

Note: SPARSH pensioners should apply for starting FP in favour of widow through SPARSH website. When account becomes single in the name of widow, please submit FORM-A to bank to NOMINATE someone, who will be able to withdraw balance amount from that account after widow's death.

Step-7: Death to be informed to concerned **Records office** with supporting documents (DC/ PPO/ Widow Aadhaar card etc enclosed)/ mail to concerned Records. Pls take assistance from dependent ZSB.

Step-8: Apply for Funeral Grant or Demise Grant/ ADLRS (Assured Decent Last Rites Scheme) to respective offices.

- (a) Army Widows will apply for ADLRS to Army CSD Canteen and Stn HQ for ₹10000/- +₹7000/-(total ₹17000/-). Widows from Artillery Corps will get ₹20,000/from RAA (Regimental Artillery Associations).
- (b) Naval Widows will apply at CRSO Office (Hastings, Kolkata) for PRIDE Grant ₹30000/-.
- (c) AF Widows will apply to SI Office at Nearest AF Stn or IAFBA New Delhi to get GARIMA grant ₹10000/-.

Step-9: Apply for Widow Iden Card at respective ZSB once Family pension started under normal circumstances/ Name and DOB of widow in order as per PPO. Please Return ESM Iden Card and Dependent Iden Card of Wife (if issued) to respective ZSB. Write a simple application and attach a copy of Death Certificate and PPO.

Note: If there is NO JN-PPO, then No Widow Iden Card will be issued, till she gets her own PPO after Records proceedings/ Corrg PPO.

Step-10: Send Insurance Claim to AGI/NGI/AFGIS through ZSB duly countersigned.

Step-11: Air Force widows may apply for Family Assistance Scheme (FAS) from IAFBA through ZSB. You will get ₹1500-2800/- pm for 8yrs or lump sum amount, depending upon, which scheme is eligible.

Step-12: Army, Naval and IAF Widows (service deaths/ BC/ accidental deaths) may apply for Children Education Grants from DIAV, INBA and IAFBA respectively, if applicable and comes under merit.

Step-13: If deceased ESM was having DSP A/c, in case of Accidental death, widow can claim up to Rs. 30, 00,000/- from concerned bank branch.

- Step-14: Widows may apply for Children Education Grant/ PMSS etc online at KSB website. Pls take assistance from dependent ZSB.
- Step-15: Block Late ESM ECHS 64 KB Smart Card of ECHS online in ECHS website or deposit to the dependent ECHS Office and take receipt. ECHS Cards for wife and other family members will continue.
- Step-16: Apply for CSD Cards (General and Liquor) for Widow at dependent CSD Canteen Office with supporting documents (widow Iden card, DC, PPO etc). When new cards are received, return both CSD Cards of ESM at CSD Office.
- Step-17: Apply to Bank and Post Office to close all Single Accounts and all Fixed Deposits etc in the name of ESM and transfer amount into nominee's A/c. All joint accounts should be converted into single accounts.
- Step-18: Claim from LIC and other Insurance agencies, if applicable.
- Step-19: Intimate Assessment Officer of Income Tax Circle of ESM, about the death of ESM. Apply to IT department to surrender the PAN Number after four years.
- Step-20: Visit Aadhaar Card office for blocking Aadhaar card. Deactivate Adhaar Number of ESM by blocking Biometric authentication in Adhaar Website (https://uidai.gov.in).
- Step-21: Transfer all Equity shares/Mutual Funds/SIPs etc, in the name of ESM to the nominee's name and close his DEMAT A/c, if any.
- Step-22: Visit nearest Road Transport Office (RTO) to surrender Driving License of deceased ESM, if valid and applicable. Also, apply to RTO to transfer ownership of two/four wheeler vehicle on nominee's name.
- Step-23: Visit local Election Office and apply to cancel deceased ESM name from Voter's List by submitting Form No. 7 and Death Certificate.
- Step-24: Visit Nearest Ration office to surrender Ration card of deceased ESM.
- Step-25: Visit dependent Gas Agency, to change consumer name in issue voucher and Gas book.
- Step-23: If there is any loan pending on deceased ESM's name, same should be liquidated.
- Step-26: Transfer ownership of Gun/weapon after getting gun license. Keep the gun in Police Stn custody till then.

Step-27: If there is any police case or court cases pending against the deceased ESM, then submit Death Certificate to Police Stn/Court.

Step-28: Transfer ownership of Flat/House/property etc in the name of nominee. If not jointly registered, succession certificate or legal heir certificate may be required. Execute WILL of ESM, if any.

Step-29: Apply for change names of Electric Meter, Water meter, Society Charges, Cable TV, Telephone, Broadband, Property/House Tax etc.

Step-30: If the widow is looking for a job/ resettlement, submit your Biodata to AWWA office (FW)/ Veteran cell of Army/ AF/ INS Netaji for guidance as applicable.

Step-31: In case ESM had worked in any other organization post retirement, then contact his second office for various death benefits, second pension and job for widow etc.
