

And when my country asked me to serve, via a draft notice, did I run off to Canada? No, I went willingly and proudly served my country as a combat infantry soldier with the **4th Infantry Division in the Central Highlands of Vietnam for an entire year as a rifleman and 81mm mortarman.** I was honorably discharged from the U.S. Army on Jan. 14, 1971.

So what is my crime that my critics in both parties and the **lying pink rabbits of the liberal press** claim makes me unfit for public office? It is simply this: I told a reporter from the **Chicago Sun Times** after pestering me about it, that in my opinion, the **"Holocaust"** was a greatly overblown tale of tall tales, that anyone who makes the effort, can easily learn the truth about this issue.

This is a **tax-free benefit no other ethnic group or racial group is allowed.** If you are a survivor or a relative of a Communist gulag or prison survivor, you get nothing from Illinois or the U.S. government! **Only the Jews have devised a way to profit off the suffering of others - and that way is THE HOLOCAUST, first conceived in Communist-ruled Poland in 1947.**

In closing, my campaign is an attempt to wake our people up to the danger we are facing, and that is the **invasion of our country by illegal aliens from 141 foreign, non-white, non-Christian countries.** We simply cannot accept these millions of people without suffering a penalty to our nation – **the end of America as a Free, White, prosperous, civilized, sovereign nation.**
