This privacy policy will explain how Your Sport Solutions uses your personal data which we collect, handle and process.

# What data do we collect?

Your Sport Solutions collects the following data:

- Your name
- Your address
- Your email address
- Your telephone number
- CV/work history
- Any other work-related information you provide, for example, education or training

If you are a candidate and are selected to work for us, we will collect the following information:

- Passport or drivers license
- Date of Birth
- National Insurance Number
- DBS Information (if you need to undertake a DBS with us, we will collect 3 forms of ID)
- References
- Financial information

# How do we collect your data?

You directly provide Your Sport Solutions with most of the data we collect. We collect data and process data when you:

- Register your CV online or place an order for any of our services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.
- Contact us via email or phone

Your Sport Solutions may also receive your data indirectly from the following sources:

• Referrals from candidates through our refer a friend scheme.

# How will we use your data?

Your Sport Solutions collects your data so that we can:

- Match candidates with appropriate placements
- Undertake relevant security and DBS checks.
- Provide clients with candidate details
- Contact you relating to opportunities

- Update you on changes to our services
- Establish that you have the right to work
- Produce your contractual agreement
- Pay you once work has been undertaken

#### How do we store your data?

Your Sport Solutions securely stores your data on our databases in the United Kingdom. Your Sport Solutions will keep your personal data for no longer than is necessary.

You also have the right to request Your Sport Solutions to complete the information you believe is incomplete.

**The right to erasure** – You have the right to request that Your Sport Solutions erase your personal data, under certain conditions.

**The right to restrict processing** – You have the right to request that Your Sport Solutions restrict the processing of your personal data, under certain conditions. **The right to object to processing** – You have the right to object to Your Sport

Solutions' processing of your personal data, under certain conditions.

**The right to data portability** – You have the right to request that Your Sport Solutions transfer the data that we have collected to another organisation, or directly to you, under certain conditions.
