Hello Erin,

This is now beyond ridiculous and it is time that you grow up. You are making a fool out of yourself. You are angry because your free living (housing, medical, credit cards) and maid service (me) was taken away from you. There are pictures taken not only from the last 4 years but also how you lived with Ari in Tucson and in previous years when you were college. Fact of the matter is, you are a pig and I was your maid. You are so nasty on the inside that it has ruined the beautiful young woman that we see on the outside. John Landry adopted you, however you have turned out to be a product of your biological father Stephen Gude.

I am scared of you and what you will do to yourself just to prove that you have been a victim of which you have never been. Also, would you really want to have a police standby with Sophie present? Again we would like to pick up Sophie TODAY and when we drop her off, I will let Aunt Erin and Uncle Tiger bring her over to you. I will be more than 200 feet again.
