The Protective Order will be a disaster to you, Erin, as well as to Celia, and for Sophie, a tragedy.

My deepest prayer is for the Protective Order to be dropped and forgotten!!!!!! and for the two of you to take several deep breaths, then go to counselling/mediation, and Sophie be saved from being torn from her "Gummy" grandmother, her home, her room, pets Kia and Salem, etc. I want my daughter, Celia, to be spared from losing her child and grandchild, both of whom she loves, because of a wrong and emotional strong push or whatever. Even worse, Erin, with the Protective Order you will damage yourself with the lifelong burden of knowing your severely damaged or destroyed your own mother, and for what? For what, Erin???

Celia and Erin, I recognize that for a long time, the two of you have not gotten along living together. In the real world, there was no choice. It was a hurdle. Now, it is up to the two of you to work hard to acknowledge the problems and missteps, and to resolve to make the necessary changes. If you do so, the two of you will grow and move forward into a more mature and stronger and better relationship.

Celia, Erin, I want you to know that I am devastated by what is going on..and so are Gayle and Madeline. Our family is being destroyed for nothing. I have cried with tears thinking I about Sophie. PLEASE STOP the Protective Order, and rationally work out your problems!

Dear Momo,

Am I to understand, according to your email, that you feel the real tragedy here is that I have requested that a Judge order my mother to stay a certain distance away from Sophie and myself; NOT that she laid her hands on me in anger, in order to control me, and feel powerful over me?

Almost 2 months ago my daughter had to lecture yours on using her words and not her hands. A little over 2 weeks ago, your daughter approached me--in front of my daughter--and said, "I'm gonna fucking hit you." Then, she started shouting at Steven, "Steven, take Sophie inside! Take Sophie inside! Steven, take Sophie inside..." Over and over again, so that she could, "f*ing hit (me)."

Her "wrong and emotional strong push or whatever" injured me with force equivalent to me falling out of a tree--out of a tree! That's a force equivalent to 165lbs falling 10ft or so at an acceleration rate of 9.8m/s^s.

She did not like the situation, and chose to use her 'power' against me, and I was just standing there calm and unarmed. I took what she was saying to me, just like I have been for a very long time; just like Sophie has.

But me getting help, me *finding* protection from someone who honestly scares me, from someone who *hurt* me and threatened to do so in front of my daughter, *that* is the tragedy?

Let's spin this another way... in 20yrs, Sophie is in a relationship and her significant other reaches towards her face, rips her glasses off and throws them to the ground, injuring her as though she had fallen out of a tree--before pushing her to the ground when she doesn't do something he wants. Oh, but it's ok, because he loves her. She's not going to report it and get protection from him, because he loves her.

It's NOT ok, and that is not the message I want to send to my daughter. I made the mistake not reporting her father, but I have learned. My mother is not Ari, which actually makes it worse; even a Kindergartner knows that you keep your hands to yourself and use your words instead.

There is no more counseling; I have been asking her to go to counseling with me for OVER a year, and as recently as a couple of months ago (until right before she threatened to hit me the first time). She refused all along.

I will stand silent and take her words, and I have for years, but I will not just take her hits and roll over. She is my mother! And a Blackbelt, for goodness sake!! She should know better!!! She has the skills to disarm someone holding a knife, or a gun, or possibly even holding both to her simultaneously, and she chose to use that knowledge, that power, against me, with her granddaughter just barely inside the house, having been yelled at to get inside, and having witnessed her mother's physical safety threatened for a second and final time.

This has nothing to do with your legacy, and everything to do with my mother exercising poor judgment and exerting physical control over me when verbal control did not actualize to her full desire.

I will be very excited to see you tomorrow, but I will also be very sad, as this has few ways to play out, and none of them are winning--you are quite right about that. We've already lost. I am afraid of my mother, and all the Order Of Protection is, is the court saying that she needs to give Sophie and I space for at least a year, assuming she does not commit any other violent acts or threats in that year. This court battle, this is her. And this is where we all truly lose... either she will lie on the stand to save herself, this will get dirty but the OOP will be upheld, or, she perhaps she will take responsibility for her actions and drop the contest.

Momo, she hurt me. She put her hands on me in anger. She threatened me, twice, in Sophie's presence, and followed through once Sophie was just on the other side of a door a few feet away. She is a trained, lethal weapon, and I was unarmed, and non-threatening (with witnesses). She did not get what she wanted, so she decided to use physical coercion to force me to concede. It was premeditated. It could have been worse, but it should not have happened at all. I am still in pain. Pain from an injury equivalent to having fallen out of a tree. Pain inflicted upon me by the one person with whom I was supposed to always be safe. Emotional pain inflicted upon a 6yr who just doesn't understand and certainly doesn't need it, when she had her Gummy yelling horrible things at people she loves too.

I'm really sorry if you feel that my restraining order to prevent recurrence of this incident is causing our family to be destroyed, and tarnishing your legacy, but my OOP will go away after a year as long as she doesn't commit an act of violence, but how long will it be before the trauma of being attacked by my mother goes away?
