#### GENERAL USE INSTRUCTIONS

Shake product prior to use. Maintain agitation during mixing and application. This product can be mixed with a wide range of fertilizers and chemicals. A compatibility test should be performed prior to use. For best results, water-in the evening after application.

#### APPLICATION INSTRUCTIONS

C7 Venom can be applied to all species of cool and warm season turfgrass in the transition and tropical zones. The recommended application rate is ½ gallon / acre or 1.5 fl. oz. / 1000 ft<sup>2</sup> every 7 to 14 days as an additive to your current program. Dilution Rate is 50 to 109 gallons / acre or 1.15 to 2.5 gallons / 1000 ft<sup>2</sup>.

#### MIXING TIP

Blend contents to be sprayed through tank strainer basket to ensure proper dilution of material.

#### APPLICATION TIP

For best results, spray with either flat fan or hollow cone spray nozzles and remove in-line screens from nozzles to prevent clogging.

#### SPRING BERMUDAGRASS TRANSITION

For best results, the recommended application rate beginning in spring is ½ gallon / acre or 1.5 fl. oz. / 1000 ft<sup>2</sup> every 7 days until the bermudagrass has fully established.

#### SPECIAL CLEANING & STORAGE INSTRUCTIONS

Wash sprayer immediately after protocols so residual product does not dry in sprayer.  
Keep material out of extreme heat or cold during storage for any extended period.  
Store at room temperature above 50 F (10 C).
