They are a tandem application with equal rates of 2.5 fl. oz. to  $6 \text{ fl. oz.} / 1000 \text{ ft}^2$  every 7 to 14 days. **Recycled water rate** is  $6 \text{ fl. oz.} / 1000 \text{ ft}^2$  of each formula bi-weekly during the entire irrigation season. Dilution Rate is 50 to 109 gallons / acre or 1.15 to 2.5 gallons / 1000 ft<sup>2</sup>.

### APPLICATION & MIXING TIP

For best results, spray with either flat fan or hollow cone spray nozzles and remove in-line screens from nozzles to prevent clogging. Blend contents to be sprayed though tank strainer basket to ensure proper dilution of material.

# COASTAL AGRONOMIC PROGRAM

For best results, blend C&D with ammonium sulfate, potassium nitrate, ferrous sulfate, and manganese sulfate as needed, every 7 to 14 days.
