Grow-in & Establishment Rate is 5 fl. oz. / 1000 ft2 of each formula weekly after first mowing. Dilution Rate is 50 to 109 gallons / acre or 1.15 to 2.5 gallons / 1000 ft².

APPLICATION & MIXING TIP

For best results, spray with either flat fan or hollow cone spray nozzles and remove in-line screens from nozzles to prevent clogging. Blend contents to be sprayed though tank strainer basket to ensure proper dilution of material.

AERATION RECOVERY

Protocol recovery is accelerated with 5 fl. oz./ 1000 ft2 rate 7 days before and 7 days after aeration. Increase rate up to 10 fl. oz. / 1000 ft² as needed to recover from deep verticutting.

SPECIAL CLEANING & STORAGE INSTRUCTIONS

Wash sprayer immediately after protocols so residual product does not dry in sprayer. Keep material out of extreme heat or cold during storage for any extended period. Store at room temperature above 50 F (10 C).
