PLEASE REVIEW AND ASK YOURSELF EACH AND ALL OF THE FOLLOWING QUESTIONS BEFORE CONTACTING ME THIS DETERMINES YOUR ELIGIBILITY FOR US TO PROVIDE AND RUN A BACKGROUND CHECK ON YOU FOR A WEAPON IF ELIGIBLE, YOU DO NOT NEED TO CONTACT ME AND CAN PROCEED TO STEP TWO AND PURCHASE YOUR WEAPON
PLEASE READ STEP ONE AND TWO COMPLETELY TO UNDERSTAND THE PROCESS, TERMS AND CONDITIONS

- 1) Do you have a valid government ID?
- 2) Do you have a valid FOID card or valid ISP fooid account?
- 3) Is the weapon you are transferring or purchasing for you?
- 4) Are you over 18 transferring a rifle or over 21 transferring a pistol?
- 5) If approved will you picking up the weapon within 30 days of the application?

If ANY answer is no please contact us BEFORE buying a weapon

If ALL these answers are yes please continue the preliminary questionnaire

- 6) Are you a felon?
- 7) Is the weapon a NFA class 3 firearm or accessory?
- 8) Is the pistol, rifle or shotgun an AR style platform?
- 9) Does the firearm have a threaded barrel?
- 10) If a pistol does the magazine(s) have more than 15 rounds?
A pistol may be purchased with high capacity magazines but will not be transferred with the weapon.
More information in step 2.
- 11) If a rifle does the magazine have more than 10 rounds?
- 12) If a rifle or shotgun is it semi-automatic?
- 13) Is your weapon on the Illinois assault ban list?
- 14) If purchasing a handgun is your government ID out of state?
- 15) Is the weapon a gift or for someone else?

If ANY answer is YES please contact us BEFORE buying a weapon

If ALL these answers are NO please continue you are ELIGIBLE

- * Congratulations, you have passed the preliminary questionnaire and you are eligible to apply for a background check. There are other questions on the actual federal background check but those are the basics required to be answered before contacting us. All of those questions must be answered truthfully and all laws will be followed by us. At this point you are able to purchase a legal weapon for your state, choose us as the FFL, have the weapon shipped to us and we will perform a background check. The answers you have given DOES NOT guarantee an approved decision by the state only the eligibility of applying for one. Payment is due at the time of application and initial results are provided by the state within minutes. Results are provided to me not by me and I have no authority whatsoever to change, alter, expedite, sway or rush them in any way shape or form.
