Puppy Bill of Sale and Transfer Agreement

I. The Parties

Seller (Breeder): True Heart Cavaliers LLC

Buyer:

II. Description of Puppy

The Seller agrees to sell and transfer the following puppy to the Buyer:

- **Breed:** Cavalier King Charles Spaniel
- **Birth Date:**

III. Purchase Price and Payment

1. **Total Purchase Price:** \$3,000.00 USD

2. **Deposit:** A deposit of \$500.00 has been paid by the Buyer to hold the puppy.

- This deposit is credited toward the total purchase price.
- The deposit is Non-refundable (unless the Seller cannot provide the puppy due to illness or death).

3. **Balance Due:** The remaining balance of \$2,500.00 must be paid in full prior to or at the time of pickup/delivery.

IV. AKC Registration (Limited)

1. **Limited Registration:** This puppy is sold with AKC Limited Registration.
2. **Definition:** The Buyer understands that "Limited Registration" means the dog is registered with the American Kennel Club, but no litters produced by that dog are eligible for registration.
3. **Papers:** The Seller will provide the AKC registration application to the Buyer upon payment in full.
4. **Show Rights:** The dog is eligible to be entered in Rally, Obedience, Agility, and other performance events, but cannot be entered in Conformation shows (breed ring).

V. Spay/Neuter and Non-Breeding Agreement

1. Non-Breeding Clause: The Buyer agrees that this puppy is being sold solely as a companion/pet. Breeding of this dog is strictly prohibited.

2. Spay/Neuter Requirement: The Buyer agrees to have the dog spayed (female) or neutered (male) by a licensed veterinarian.

- **Window for Procedure:** The procedure must be performed between the ages of 12-18 months.

Note: Many breeders prefer waiting until growth plates close (12-18 months) for orthopedic health.

- **Proof of Procedure:** The Buyer must provide a veterinary certificate of spay/neuter to the Seller via email or mail within 30 days of the surgery.

3. Penalty for Breeding: If the dog is bred (intentionally or accidentally), or if the Buyer fails to spay/neuter the dog within the agreed timeframe:

- The Buyer agrees to pay the Seller a penalty fee of \$5,000.00
- The Buyer agrees to return the dog and any offspring to the Seller immediately without financial compensation.
- The Seller retains the right to pursue legal action to enforce this clause.

VI. Health Guarantee

1. Short-Term Health (72 Hours): The Seller guarantees the puppy is in good health at the time of delivery. The Buyer has 72 hours (3 days) to have the puppy examined by a licensed veterinarian.

- If the puppy is found to have a life-threatening illness within this window, the Buyer may return the puppy for a full refund or a replacement puppy (if available), provided a veterinary report is supplied.
- This does not cover parasites (worms, giardia, coccidia, ringworm), which are common in puppies, or stress-related issues.

2. Genetic Health Warranty: The Seller guarantees this puppy to be free of known life-threatening hereditary defects for a period of 12 months.

- If a hereditary defect is diagnosed that severely impacts the quality of life, the Seller will offer a replacement puppy from the next available litter. Buyer must provide an official written diagnosis from a licensed veterinarian.

VII. Buyer Responsibilities

The Buyer agrees to the following care requirements:

1. **Housing:** The dog will reside indoors as a family member and will not be kept strictly in a kennel, outdoors, or on a chain.
2. **Veterinary Care:** The Buyer will keep vaccinations, deworming, and heartworm/flea prevention up to date.
3. **Training:** The Buyer agrees to provide proper socialization and training to ensure the dog is a good canine citizen.

VIII. Right of First Refusal (Return Policy)

If, at any time during the dog's life, the Buyer is unable to keep the dog, the dog must be returned to the Seller.

1. The Buyer agrees never to surrender this dog to a shelter, humane society, or rescue organization.
2. The Buyer agrees not to sell or give the dog away to a third party without the Seller's written consent.

No refund will be issued for a return after the initial 72-hour health window (unless otherwise agreed upon by the Seller).

IX. Signatures

By signing below, both parties acknowledge that they have read, understood, and agree to the terms of this contract. This contract is legally binding.
