

# Affidavit of Fact

## Religious Affidavit on Honorary Consulate Assignment

1. I am Hashim Ali Jabar OdoKhan-El, born Quinn Ryan Foster, a natural born Indigenous (Ab)Original Moor, a Moorish American descendant of Morocco born in America, propria persona, protected under the Moroccan American Treaty of Peace and Friendship [28 June 1786], the U.S. Constitution, and the Divine Constitution and Bylaws of The Zion Church- Entity #6101674 November 12<sup>th</sup>, 1875 Philadelphia County, Pennsylvania.
2. I have no disabilities, which would prevent me from making this affidavit.
3. I am a manifestation from the Creator Most High. I am a Moorish-American National, descendant of Elohim (Genesis 1:1).
4. I am not a legal person, or legal fiction. I am not a Citizen governed under naturalization or immigrations, not a "14" Amendment person or a federal U.S. Citizen.
5. I am not wanted, or under indictment for any crime in Ohio or abroad under common law.
6. This affidavit was not made under threat, duress, and coercion and without deception for purposes of evasion. This is a true and accurate record of my information.
7. The Priesthood of Rev. Dr. Isaiah Henri Harrison Moore and Elizabeth B. Irvin established 1880, codified in 2021, is non-tax obligated Religious Order, Priesthood, Society and Body Politic; Aboriginal & Indigenous Band No. AA222141; including blood line family, spouses, and children.
8. The following contains information found "on the record"- Case No.2020 BR 24, in the Board of Revision of Montgomery County, Ohio 451 West Third Street, Third Floor, Dayton, Ohio, 45402, (937) 496-3389. Any claims, suits, charges, and or calls for mediation and or arbitration against any member of the Priesthood of Rev. Dr. Isaiah Henri Harrison Moore and Elizabeth B. 9. The location referred to as 2426 Jerome Ave Dayton, Ohio is the Allodial Aboriginal/ Indigenous property and Divine Religious Holy Site of a family of Moorish-American Nationals and Clerics, and also home to the Zion Church of the Evangelical Association, the Zionst Temple of 1875 for Orphans and Widows. The said property is fully and totally owned by the heirs of *Thelma M. Foster Life Estate Deed No. 04-061133 0001, Washitaw County AFAM, Montgomery County, Ohio Republic, North America* and is Non-Taxable land, see Ohio Revised Code ; (See Ohio Revised Code Chapter 5709, 5709.07 Exemption of schools, churches, and colleges, 3377.12 Tax exemption, 5713.07 Exempted real estate, 5709.12 Exemption of property used for public or charitable purposes, [5709.01 Taxable property entered on general tax list and duplicate.](#))
10. It is the divine inalienable right of each human being to have and practice his or her own personal religion, and that inalienable right is protected by the *First Amendment* of the Constitution of The United States of America, stating: “Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.”;
11. *Article 18: Freedom of Religion or Belief* Art of the Universal Declaration of Human Rights (UDHR) says we all have the right to our own beliefs, to have a religion, have no religion, or to change it.
12. The ten commandments of the Torah instruct us to “to honor thy father and mother”, (Exodus 20:12). The Priesthood of Rev. Dr. Isaiah Henri Harrison Moore and Elizabeth B. Irvin honors our forefathers and foremothers by following in the clerical tradition and assisting in supporting orphans and widows.
13. Pursuant to Article 68 of the Vienna Convention on Consular Relations (VCCR), the United States receives honorary consular officers.
14. On the date of January 15, 2021, on behalf of the Zion Church of the Evangelical Association, I opened an Honorary Consulate privately at 2929 Arch Street Suite 1700- #2139 Philadelphia, Pennsylvania [19104], for the purposes of promoting travel, tourism, and trade and commerce between the Kingdom of Shabazz and nations, businesses, corporations, and others of the world. Philadelphia County, Pennsylvania was the receiving state, Zion Church of the Evangelical Association also known as The Zionst Temple of 1875 for Orphans and Widows, also known as the Kingdom of Shabazz was the sending state.
15. In April of 2021 I opened a private office and Honorary Consulate at 4600 Powder Mill Road, Beltsville, Maryland [ 20705] for the purposes of promoting travel, tourism, and trade and commerce between the Kingdom of Shabazz (the Zion Church of the Evangelical Association also known as the

Zionst Temple of 1875 for Orphans and Widows) and nations, businesses, corporations, organizations, institutions, and others of the world. Prince George's County, Maryland was the receiving state, Zion Church of the Evangelical Association also known as The Zionst Temple of 1875 for Orphans and Widows, also known as the Kingdom of Shabazz was the sending state. The broader Washington D.C. metropolitan area (or Washitaw D.C.) were also beneficiaries of the sending state's Honorary Consulate due to the geographic distance or closeness in proximity to the U.S. White House, the U.S. Capital, the United States seat of government, and especially to Embassy Row.

16. Embassy Row is the informal name for a section of Northwest Washington, D.C., with a high concentration of embassies, diplomatic missions, and diplomatic residences. It spans Massachusetts Avenue N.W. between 18th and 35th street, bounded by Scott Circle to the south and the United States Naval Observatory to the north; the term is often applied to nearby streets and neighborhoods that also host diplomatic buildings.

Embassy Row in Washington DC refers to a part of the city where many of the foreign embassies are located, along Massachusetts Avenue extending from Dupont Circle toward the National Cathedral.

Washington, DC has more than 175 foreign embassies, residences, chanceries, and diplomatic missions. Less than half of the embassies of Washington DC are actually located along Embassy Row. About a dozen embassies are located along a four block stretch of New Hampshire Avenue off Dupont Circle. Another dozen embassies are located in a cluster closer to Connecticut Avenue.

Of the 177 diplomatic missions in the city, the majority are located on or near Embassy Row, including those of Italy, Australia, India, Greece, Egypt, Ireland, Japan, and the United Kingdom. Due to the large number of well-preserved Gilded Age estates and townhouses, many of which house diplomatic missions or dignitaries, Embassy Row has been protected as part of the Massachusetts Avenue Historic District. Its historic and multicultural character has also made the area a center of tourism and local cultural life.

17. An honorary consulate or honorary consul is a person who is appointed to act in the interests of a country's citizens in another country. Honorary consuls differ from career consuls in several ways. They are not expected to perform their consular duties on a full-time basis and they are usually unpaid or receive only nominal salaries. Most honorary consuls work in other businesses or jobs while completing their consular duties on a part-time basis in their spare time. They generally live and work in large cities in the receiving countries that do not have embassies of the countries that they are representing, and their jobs involve strengthening goodwill and ties between the two countries while facilitating investments and trade. Honorary consuls receive special badges reflecting their esteemed statuses, and the appointments carry all of the benefits that career consuls also receive. Although the main objectives of a Honorary Consul are developing relations

and promote trade, tourism and cultural relations. Their other role is; safe guarding the interest of the Sending State its properties and citizens.

18. An honorary consulate is a non-traditional diplomat, who is not paid for their services. Honorary Consuls are typically business professionals of different varieties that can facilitate multiple and deep engagements with political bodies, commercial organizations, nationals located abroad and citizens of receiving states. Their engagements can take place on different levels, including political, commercial and cultural. Honorary consuls play an important role in the international relations. While honorary consuls cannot replace traditional diplomats, they can facilitate multiple and deep engagements with political bodies, commercial organizations, nationals located abroad and citizens of receiving states. Their engagements can take place on different levels, including political, commercial, and cultural.
19. These Honorary Consuls are given a much larger mandate, they may issue Visa and often have Power of Attorney to represent the sending State in many, and sometimes all matters important to the Sending State.
20. The smallest nations in the world can have a well-established network of Honorary Consuls around the world.
21. Two main elements to an honorary consul's work include: assisting nationals abroad and representing trade interests. Members of the public are often unaware of an honorary consul's role until there is a crisis or natural disaster. Most of their work is done behind the scenes, where they make a difference for people and businesses.
22. Honorary consuls create unique economic opportunities for sending nation companies. They open doors for the business community and facilitate visits. They maintain close ties with the local community.
23. Honorary Consulates may carry or present credentials similar to diplomatic passports to members of the receiving states. A diplomatic passport is a special type of passport that is issued to people who will travel internationally on official state business. The Zion Church of the Evangelical Association Zion Church of the Evangelical Association also known as The Zionst Temple of 1875 for Orphans and Widows, also known as the Kingdom of Shabazz issues Clergy Credentials.
24. The benefits according to people who serve as honorary consuls are outlined in Art. 71 of the Vienna Convention on Consular Relations and Optional Protocols. People who are honorary consuls receive special license plates for their vehicles that designate their statuses. They are allowed to fly

flags on their cars, and they cannot receive parking tickets. Honorary consuls also enjoy diplomatic immunity, which means that their offices and homes cannot be searched by law enforcement officers. Because the offices and homes are considered to be the inviolate territory of the sending countries, they are not subject to searches by law enforcement officers or military personnel. Honorary consuls also do not have to pay property taxes on their homes or the value-added taxes if the countries in which they reside charge them for goods for their homes or offices. Finally, when people are traveling on official state business, they are able to pass through the quick immigration lanes and not have their belongings searched in airports. The Vienna Convention on Diplomatic Relations has several parts describing this protection:

- a. Diplomatic properties (Embassies, Consulates and Honorary Consulates are inviolable, meaning; never to be broken, infringed, or dishonored.
- b. Diplomatic vehicles should be recognizable and are also inviolable.
- c. Diplomatic mail, correspondence, and communication (phone) are inviolable.
- d. Despite the changing role and growing importance of Honorary Consuls, especially those of small states the public, often public servants and sometimes members of parliament and ministers are not or not enough aware of the duties and the protection Honorary Consuls deserve.

25. Honorary consuls get an opportunity to promote commercial and trade ties and enjoy an added social recognition. They also have access to senior government officials and the global diplomatic community.

26. John J. Moore first became an itinerant preacher and received a license to do so in Philadelphia County, Pennsylvania.

27. Resolution HR75 was passed in 1933 recognizing the existence and religious rights of a Moorish American Society.

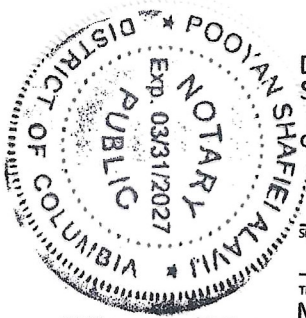
