

4. I am not a legal person, or legal fiction. I am not a Citizen governed under naturalization or immigrations, not a "14" Amendment person or a federal U.S. Citizen.
5. I am not wanted, or under indictment for any crime in Ohio or abroad under common law.
6. This affidavit was not made under threat, duress, and coercion and without deception for purposes of evasion. THIS IS A TRUE AND ACCURATE RECORD OF MY INFORMATION.

The said property has been improperly classified due to a lack of necessary information; 2426 Jerome Ave is the Aboriginal/ Indigenous property of a family of Moorish-American Nationals and Clerics built in 1953 by our grandfather Hercules Foster. The said is a family church, temple, shrine, and ecclesiastical county (parish). The said property is Non-Taxable land, see Ohio Revised Code;

Chapter 5709, 5709.07 Exemption of schools, churches, and colleges, 3377.12 Tax exemption, 5713.07 Exempted real estate, 5709.12 Exemption of property used for public or charitable purposes, 5709.01 Taxable property entered on general tax list and duplicate.

I, Hashim Ali Jabar, do invoke the Inalienable rights of the heirs of Thelma M. Foster to have and practice a religion (Ecclesiastical Law Exodus 20:12 and U.S. Constitution First Amendment), "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances".

**The Heritage House**, (The House that Hercules Built) is the official residence and workplace of the Premier (Prime Minister) of the Zion Church of the Evangelical Association also known as Zionst Temple of the Ecclesiastical Association also known as the Kingdom of Shabazz. It is located at 2426 Jerome Ave Dayton, Ohio Republic,[45417] North America and has been the residence of every Premier since Hercules Clarence Foster in 1953. It is considered the national church for Muurs, Moors, African

Americans, Latino/Hispanics of North America and a shrine dedicated to Moors and the Moorish Egyptian Saint Maurice. The Heritage House is a Holy and Historical Site that honors an ancient Moabite family that traces their lineage back to Moab (current day Jordan). It was ecclesiastically blessed in 1953 blessed by Rev Dr. Isaiah Moore, father of Thelma M. Foster.

The Heritage House is the Ecclesiastical Administrative District, Parish, and Diocese of the Zionst Temple of the Ecclesiastical Association that honors ArchBishop Thelma Moore-Foster (T. Mari Moor) Matriarch of "the House that Hercules Built" Dayton, Montgomery county, Ohio 1953. The home was blessed as holy by Dean Dr. Isiah Henry Harrison Moore in 1953, when he visited his daughter and son-in-law Hercules Clarence Moore at the temple after it's completion when he quoted scripture, told to our Chief Rabbi Moses, to the family as he entered and removed his shoes, Exodus 3:5 take over your shoes Moses, the ground that you stand on is holy. The house is the family seat of a Royal Priesthood, a Moorish American dynasty of clerics, from the Washitaw Empire, French and Spanish Kingdom/ Empire (Capetian Dynasty, House of Capet- French and Spanish Kingdom; also the Powhatan Confederacy, Pocahontas, her father Chief Powhatan.

It is an effigy mound (a mound in the shape of an animal) representing a snake with a curled tail. Nearby are three burial mounds. Visiting the Serpent Mound is a part of our familial traditions passed down by our ancestors. We regularly make pilgrimages to our mound sites across the America's and Canada.



**KNOW ALL MEN AND WOMEN BY THESE PRESENTS:**

Irvin P. Foster, herein reference to as PRINCIPAL, in the County of Montgomery, Maryland of sound mind, appoints the living man known as Hashim Jabar aka Quinn Ryan Foster; a peaceful, non-belligerent, and non-combatant party, as his true and lawful ATTORNEY IN FACT, specifically regarding the Life Estate of Thelma M. Foster at 2426 Jerome Avenue Dayton, Ohio.

Any and all powers of ATTORNEY IN FACT - NON-ADVERSE, NON-BELLIGERENT, NON-COMBATANT PARTY does supersede any and all former Power of Attorney powers, and furthermore current Powers cures all previous signatures given by principal, In the principal's name, and for the principal's use and benefit, said ATTORNEY IN FACT *has full and complete authorization* (specifically regarding the Life Estate of Thelma M. 
