This puppy is being sold on a non-breeding contract. The puppy mentioned above must be spayed/neutered before she/he turns 1 year old. Once the puppy is spayed/neutered the buyer is to provide the breeder with veterinarian proof of this being done. If the puppy is not spayed/neutered before she/he turns 1 year old then we will assume this puppy was bought for breeding purposes and you will be charged an additional \$2,500 that must be paid for immediately, the buyer agrees to pay the breeder this \$2,500 and agrees to pay any court and lawyers fees that the breeder endures.

At the time of picking up the puppy mentioned above he/she was active, playful and healthy. This puppy is health guaranteed until she/he is 1 year old of any fatal genetic/hereditary health issues. We do not cover any vet bills. Payments are non-refundable. If the puppy is found to have a fatal genetic/hereditary health issue then a replacement puppy of same value will be given when available. Vet proof will need to be given showing the fatal genetic/hereditary issue the puppy has. The breeder is allowed to get a second option done by their vet. We do not cover any parasites/viruses like worms, fleas, coccidia, girardia, parvo, etc. as these can be picked up anywhere. We do not cover hips as they are not genetic. The puppy is not to visit any public places like dog parks, pet stores, group training, etc before the puppy has been fully vaccinated as the puppy is at greater risk of picking up deadly viruses. The buyer agrees to keep the puppy on NuVet plus supplement for the first year of the puppies life.

The puppy/dog mentioned above must not be sold/adopted to anyone for any reason at any time during his/her life. If the buyer can not keep the puppy/dog then the puppy/dog is to be returned to the breeder with no refund. The breeder has the option to put a percentage of the money given for the puppy/dog towards a future puppy if the buyer decides to get one at a later time.
