

Warranty statement for
MARINE MOORING LINE VERMIN SHIELD

Foothills Products, Inc. warrants to Buyer for a period of 6 months from the date of purchase that the **OFFBOARD®** MARINE MOORING LINE VERMIN SHIELD product will be free from defects in material and workmanship. If, within said warranty period said product is found, by Foothills Products, Inc. following its' examination, to be defective in material or workmanship, Foothills Products, Inc. sole obligation under this warranty will be to repair or replace such defective product at its option and expense excluding freight charges. Foothills Products, Inc. does not warrant any products, accessories, or components not manufactured by Foothills Products, Inc., but to the extent possible agrees to provide Buyer with the benefits of the manufacturer's warranty, if any. Foothills Products, Inc. shall not be liable for any damage to or wear of products caused in whole or part by abnormal conditions, improper application, improper use, or other causes external to the Foothills Products, Inc. product.

THE FOREGOING WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, WHETHER, EXPRESS, IMPLIED, OR STATUTORY INCLUDING BUT NOT BY WAY OF LIMITATION ANY WARRANTIES OF MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE.

In the event Buyer claims that Foothills Products, Inc. has breached any of its obligations, whether in warranty or otherwise, Foothills Products, Inc. may request and require return of the product and refund of the Buyer's purchase price upon Foothills Products, Inc. receipt of the returned product with proof of purchase. If Foothills Products, Inc. so requests the return of the product, the product shall be redelivered to Foothills Products, Inc. in accordance with Foothills Products, Inc. instructions.

In the event Foothills Products, Inc. elects to require return of the product, Foothills Products, Inc. shall absolutely have no further obligation to Buyer under this warranty or otherwise except to refund such purchase price upon redelivery of the product to Foothills Products, Inc. with proof of purchase.

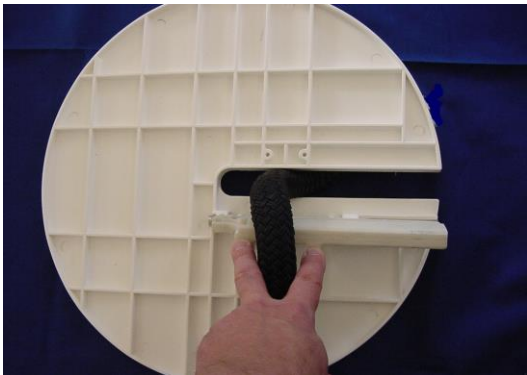
Instructions for Use

The OFFBOARD™ Vermin Shield is easy to use.

Initial Setup – There is no special set-up for these Shields. They are already set for one inch mooring line.

Day-to-day Operation

Place the shield so that the smooth side faces the shore or the dock. Using the finger grips, open the door.



Insert the mooring line through the slot until the rope is in the center hole. Make sure that the rope is all the way into the center hole.

Release the door and insure that it is fully closed. **A snug fit is expected and you may need to gently force the door closed. This action squeezes the mooring line so the space between the Shield and the line is closed.**

Holding the mooring line in the palm of the hand, place the thumb on the handle of the door and press until the door is fully closed.

Once the door is closed, the mooring line should look like the picture below



The shield is now on the mooring line and ready to be deployed.

Instructions for Center Insert

If your mooring lines are less than one inch, use an insert to reduce the size of the center hole to ensure a tight fit.

The following are instructions to adjust its size.

This package holds a set of four inserts for a 15 inch shield. There is one of each for 1/2, 5/8, 3/4, and 7/8 inch mooring line. Select the one that matches the size of your mooring lines. Keep unused inserts for possible future use.

After selecting the right size, open the spring door and place the insert in the end of the door. It is designed so that it goes in only one way.



The fit is intended to be snug.

Due to various sizes of ropes and their age, it might be necessary to select the next smaller or larger size insert.



Make sure that the insert is fully seated in the door as shown in this picture. Use the stainless steel screw provided and place it into the retaining hole until it is all the way in. Do not over tighten.



Close the door and the shield is ready for use.

NOTE: Make sure that the shield is over the water and does not rub the boat or any land objects.

If you lose the screw: It is a commercially available at any hardware store The size is a Stainless Steel #6x1/2 inch.
