Q5 Wild Turkey Hunting:

The Wild Turkey Management Plan provides guidance to the Commission on managing wild turkey populations.

The Commission has observed evidence of declining turkey populations in 15 of 23 WMUs. In response, as per the guidelines established by the Wild Turkey Management Plan, the PGC has recommended the fall turkey hunting season be reduced in 14 WMUs and closed in 1 WMU, including the elimination of the 3 day Thanksgiving season statewide.


Also, the Commission has determined that the elimination of rifles during fall turkey season may aid in recovering turkey populations.

Survey data indicates that 14% of Pennsylvania's fall turkey hunters use a rifle. Harvests reported taken with rifles comprise 33% of the total fall turkey harvest statewide.

The Commission observed that the elimination of rifles during the fall turkey season could reduce fall harvest by as much as 20%.

Assuming successful execution of these response plans, the PGC anticipates that recent fall turkey season length reductions could eventually be reversed, and more hunting opportunities returned.

Q8 Whitetail Deer Hunting:

The PGC is proposing to amend regulations to authorize unlimited over-the-counter sales of antlerless licenses starting on the second Monday in September in any WMU that has not sold out of doe tags, until tags are sold out. This is being done to ensure the antlerless licenses allocated in support of deer management are used to the fullest extent possible. WMUs that typically sell out before the end of round 3 of sales will not be affected by this change.

Q9 The PGC has recently upgraded the automated point of sale system used to purchase licenses and permits.

With this upgrade, they now have the technology to adequately and efficiently issue doe licenses directly at point of sale - over the counter and online.

This change requires legislation to remove the current "pink envelope" process which utilizes County Treasurers, taking \$1 from each license for the County Treasurer's office.

Legislation (HB 207) has been introduced that would allow the process to be changed.



Q12 The prohibition of semi-automatic rifles for hunting was removed in 2015, and the PGC now has the authority to regulate their use.

Semi-automatic rifles that meet specific criteria have been permitted for hunting small game and furbearers for the past two years, and semi-automatic shotguns were approved for use statewide since the 2018-19 seasons.

Semi-automatic rifles remain prohibited for big game in Pennsylvania by PGC regulation.

Proposals for the inclusion of these sporting arms have proposed a limited magazine capacity of a maximum of 4 rounds, which would make the use of popular products like those in the photograph legal in Pennsylvania, while excluding the use of any firearm utilizing a 30 round high-capacity magazines.





Q13 Does your club host any of these types of shooting events?*




Q14 Does your club support any of these pro-gun organizations (affiliated membership/ cash donations)?

Q15 Is your club a trout cooperator?










Q16 Does your club hold trout rodeos?






Q17 Do you feel your club has a good relationship with the Pennsylvania Fish & Boat Commission?




