GENERAL INSTRUCTIONS FOR CLUBS:

- CLUBS may submit state dues and a copy of the completed Club Affiliation sheet directly to the state office by February 1. (State dues must be paid by March 1 to be eligible to vote on issues brought before the March General Session.)
- Submit County and Division Dues directly to your county and division. Include a copy of the Club Affiliation form with payment. (Contact <u>susan@pfsc.org</u> if you need contact details.)
- All Clubs must provide at least one valid e-mail contact for the club, as this is the timeliest and most effective way to communicate. The club contact must be someone who will read and share the info with their club's membership.
