## STATE ORGANIZATION AFFILIATION SHEETS & INSTRUCTIONS

Attached are the PFSC State Organization affiliation sheets to be used by all PFSC-affiliated state organizations. Make additional copies as needed. (**Dues rates chart attached.**)

### GENERAL INSTRUCTIONS FOR STATE ORGS:

- STATE ORGS submit dues and a copy of the completed State Org Affiliation sheet directly to the state office by February 1. (Dues must be paid by March 1 to be eligible to attend and vote on issues brought before the March General Session.)
- **Mailing Address:** Please provide the address where you want official notifications mailed. This can be the delegate or a designated officer.
- **All Organizations must** provide at least **one valid e-mail contact**, as this is the timeliest and most effective way to communicate news and important updates. The contact must be someone who will read and share the info with their club's membership.
- **Voting Rights:** Your voice matters! Your vote is based on 10% of your organization's reported membership numbers. (1,000 members = 100 votes 500 members = 50 votes)

# Dues Structure & Rate Chart

## Club Affiliation Dues

<u>Number of Members</u>	<u>Rate</u>
10-19	\$50
20-29	\$80
30-39	\$110
40-49	\$140
50-59	\$170
60-69	\$200
70-79	\$230
80-89	\$260
90-149	\$290
150+	\$290 + \$1 for each member over 149
<b>609+</b>	<b>\$750 cap!</b>

### Examples:

- If your club has 200 members, you pay \$341
  - 200-149=51
  - 51x\$1=\$51
  - \$290+\$51=\$341
- If your club has 500 members, you pay \$641
- If your club has 609+ members, you pay \$750

## Individual Membership Rebate Program for Clubs, Counties, Divisions & Statewide Orgs:

For each Individual membership your group collects for PFSC, you may keep \$5 and forward the balance (\$30 for regular IM and \$15 for EM) to the state.

Note: Any payments made directly to PFSC will not result in a payment back to a club or group, so you must physically collect the payment and take the rebate out before submitting the balance to the state.

## Statewide Organizations

**Board Seat with Board Voting Privileges and General Club Voting Privileges: \$1,000**  
**Board Seat without Board Voting Privileges - General Club Voting Privileges Only: \$ 850**  
**No Board Seat - General Club Voting Privileges Only: Dues based on club affiliation rates with a \$750 cap**
