**RE: 2022 PFSC DUES SHEET & INSTRUCTIONS**

### GENERAL INSTRUCTIONS FOR STATE ORGS:

- **STATE ORGS** submit **dues** and a copy of the completed **State Org Affiliation** sheet directly to the state office by February 1. (Dues must be paid by March 1 to be eligible to attend and vote on issues brought before the March General Session.)
- **All Organizations must** provide at least **one valid e-mail contact** for the organization, as this is the timeliest and most effective way to communicate. The contact must be someone who will read and share the info with the org's membership.

# 2022 Dues Structure & Rate Chart

**Rates Effective January 1, 2022**

<u><b>Club Affiliation Dues</b></u>	
<u><b>Number of Members</b></u>	<u><b>Rate</b></u>
10-19	\$50
20-29	\$80
30-39	\$110
40-49	\$140
50-59	\$170
60-69	\$200
70-79	\$230
80-89	\$260
90-149	\$290
150+	\$290 + \$1 for each member over 149
<b>609+</b>	<b>\$750 cap!</b>

**Examples:**

- If your club has 200 members, you pay \$341
  - 200-149=51
  - 51x\$1=\$51
  - \$290+\$51=\$341
- If your club has 500 members, you pay \$641
- If your club has 609+ members, you pay \$750

<u><b>Individual Memberships</b></u>	
Individual Member	\$ 35
E-Member*	\$ 20
(*All correspondence via e-mail, including publication.)	
Next Generation Member (Under 21)	\$ 10
Life Member	\$500
Life Member Upgrade (Current Life Members)	\$200

**Individual Membership Rebate Program for Clubs, Counties, Divisions & Statewide Orgs:**

For each Individual membership your group collects for PFSC, you may keep \$5 and forward the balance (\$30 for regular IM and \$15 for EM) to the state.

Note: Any payments made directly to PFSC will not result in a payment back to a club or group, so you must physically collect the payment and take the rebate out before submitting the balance to the state.

<u><b>Statewide Organization Dues Rates</b></u>	
Statewide organizations shall be any bona fide statewide conservation organization whose mission is consistent with that of the Federation. Statewide organizations in good standing may elect a Delegate to represent them on the PFSC Board & at General Sessions based on their level of affiliation.	
<b>Board Seat with board voting privileges and general club voting privileges:</b>	<b>\$1,000</b>
<b>Board Seat with No board voting privileges, general club voting privileges only:</b>	<b>\$ 850</b>
<b>No Board Seat -general club voting privileges only:</b>	Dues based on club affiliation rates with a <b>\$750 cap</b>
