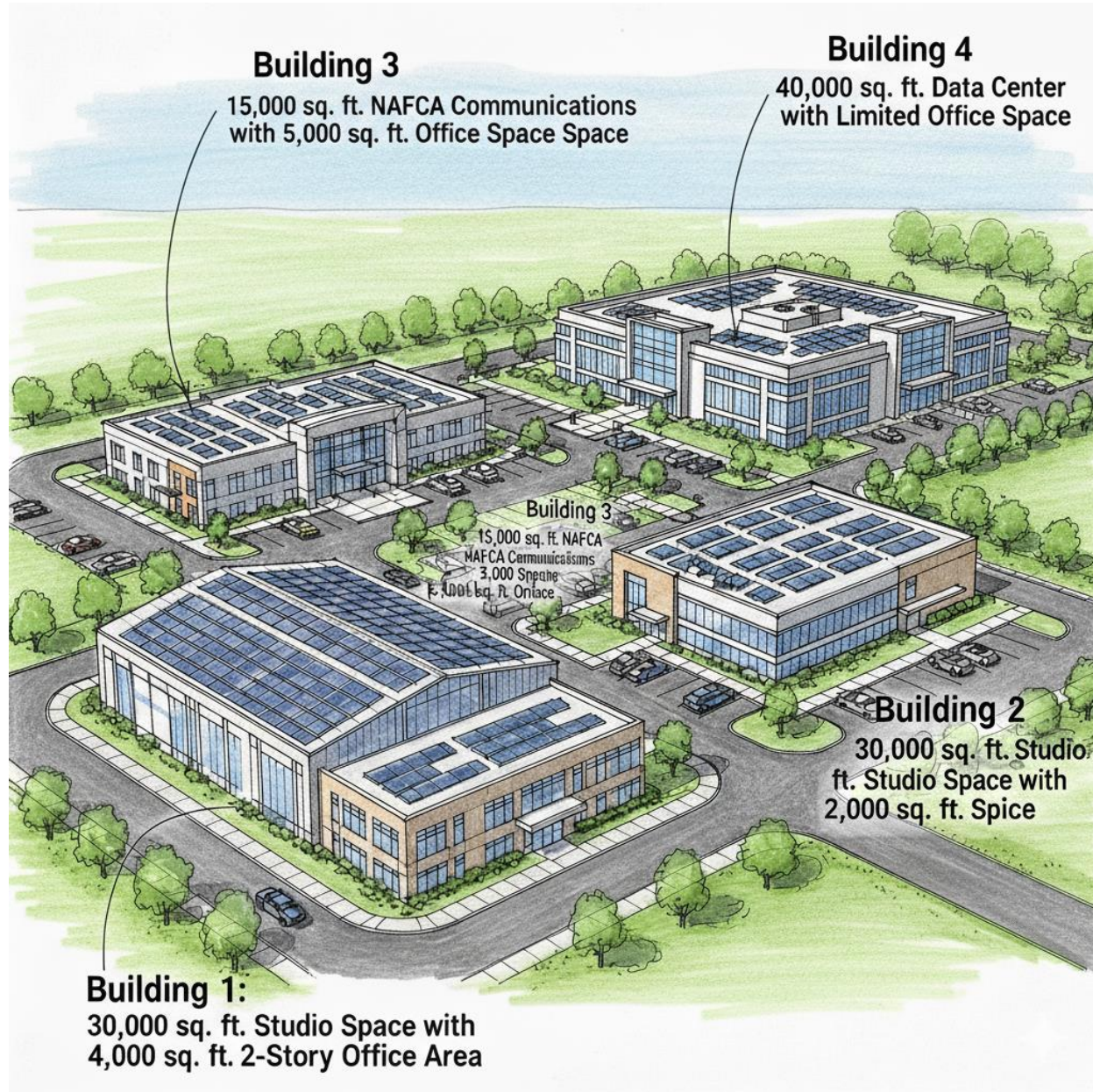
Abstract

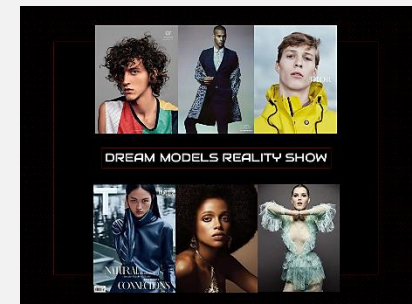
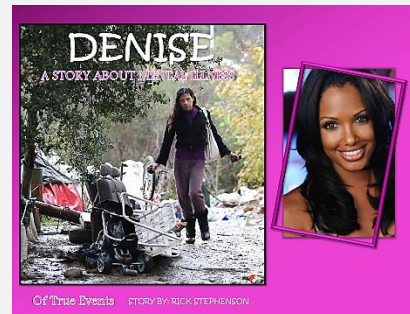


Project Overview

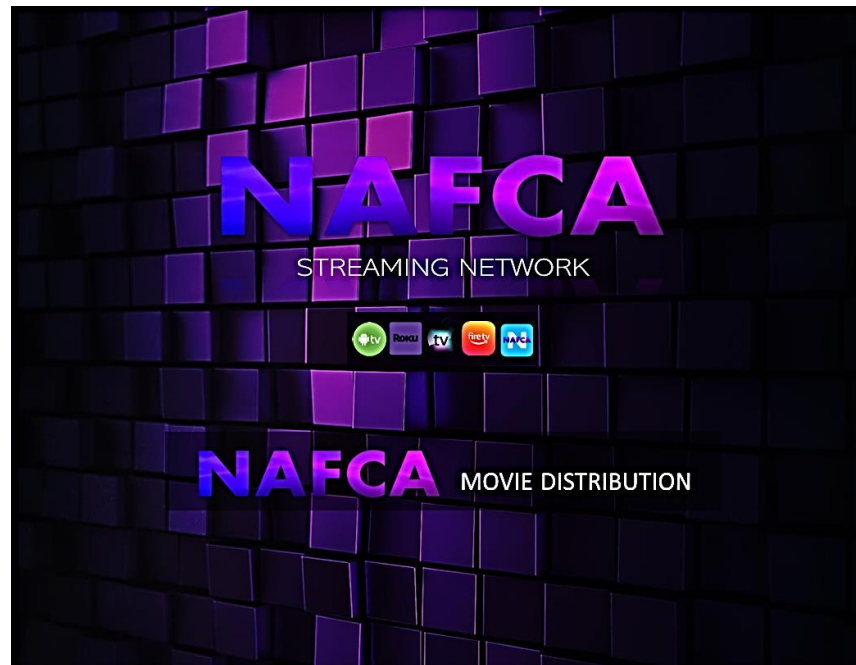
55 Nations is a fully integrated media and entertainment company with a strong foundation built on decades of industry experience. Our core business verticals include:

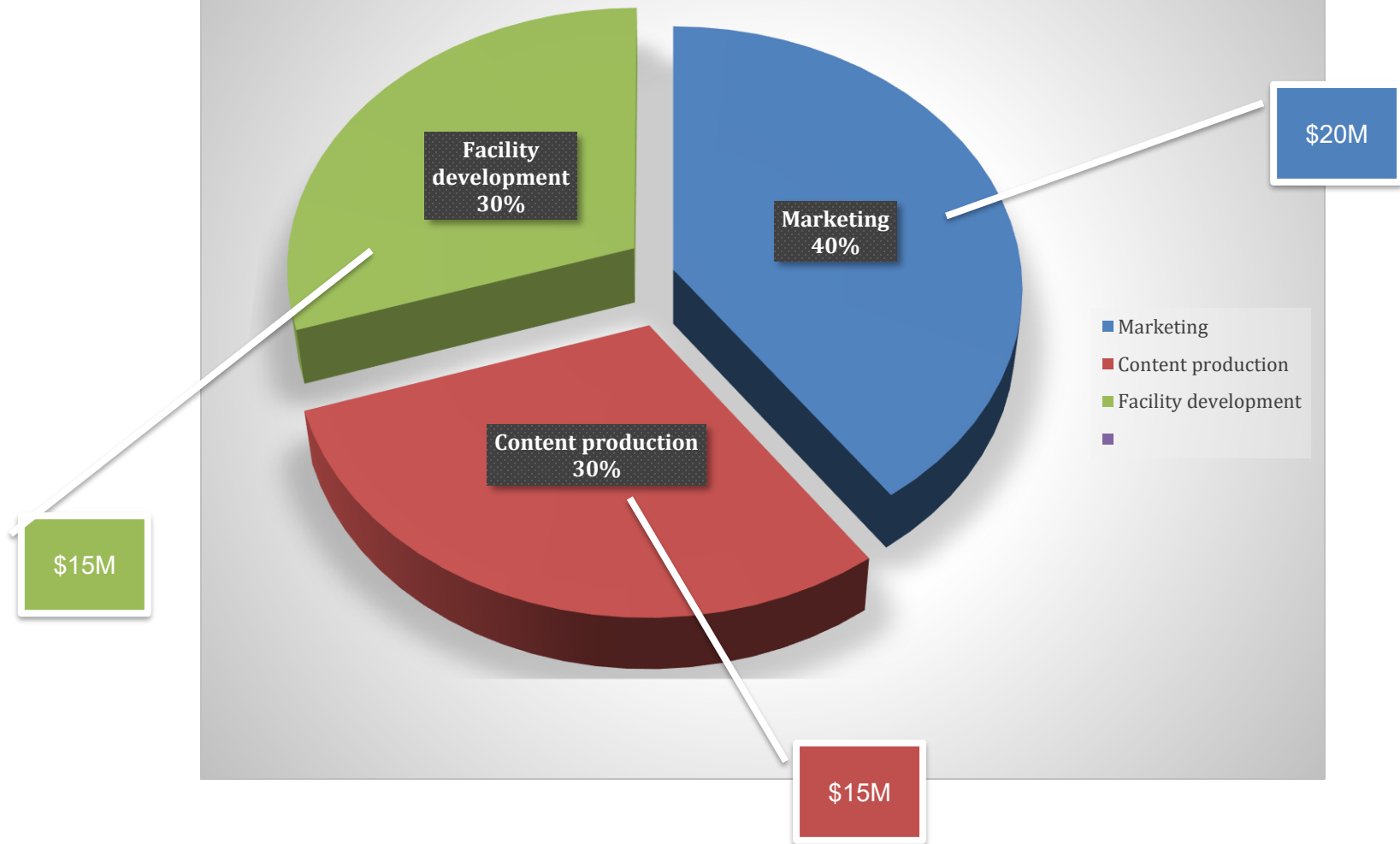
The 55 Nations Utility Token (\$55NUT)

Use of Funds

55 Nations are seeking to raise **\$50,000,000** through the token sale to accomplish the following key objectives:

- **Marketing and Promotion (40% - \$20M):** A significant portion of the funds will be allocated to robust, global marketing campaigns for our initial slate of five movies and three fashion lines. This is critical to ensure a successful launch and strong market presence.
- **Content Production (30% - \$15M):** This capital will be used to finance the production of new movies and reality shows, ensuring a continuous pipeline of high-quality content. Our goal is to take this content to all major streaming platforms to maximize reach and revenue.
- **Facility Development (30% - \$15M):** We will build four state-of-the-art facilities totaling 125,000 square feet. This will include office space for our operations and modern studio space for production. By strategically locating our production house in the Atlanta area, we can take advantage of the state's 30% film and television tax credit, which will provide an additional **\$4,500,000** in funding to our cash flow.
