## Permanent Jewelry Release and Waiver Agreement

### 1. Consent to Procedure

I, the undersigned client, hereby consent to receive a custom-fitted piece of permanent jewelry (including, but not limited to, a bracelet, necklace, or anklet) applied by an authorized representative of Maison Mulki.

I understand that "permanent jewelry" means the jewelry is custom-sized and welded onto my body, typically at the wrist, ankle, or neck, without a clasp. This process is designed to be semi-permanent, meaning it requires being cut off for removal.

### 2. Assumption of Risk and Waiver of Liability

I acknowledge that I have been fully informed of the following risks associated with the permanent jewelry process and ongoing wear:

- **Welding/Application Process:** I understand that a micro-welder will be used to bond the two ends of the jewelry chain. While the process is generally safe, I acknowledge the risk of minor, temporary skin irritation or, in extremely rare cases, a superficial burn if the jewelry or skin is not properly protected. I agree to keep my hand/body steady and follow all instructions given by the Maison Mulki representative during the welding process.
- **Allergic Reactions:** I am responsible for informing Maison Mulki of any known metal allergies (e.g., gold, silver, nickel) before the procedure. I understand that Maison Mulki uses high-quality materials (e.g., 14k gold-filled, sterling silver, or solid gold), but I accept the risk of potential skin reactions or sensitivity occurring from contact with the metal, which may not be known beforehand.
- **Medical Devices:** I confirm that I DO NOT have a pacemaker or other electronic implant. The magnetic field of a micro-welder can interfere with these devices. If I have any concerns, I have consulted with a medical professional prior to this appointment.
- **Injury/Damage:** I understand that, due to the lack of a clasp, the jewelry may catch or snag on objects. I accept responsibility for any potential injury to myself or damage to the jewelry, clothing, or property that may occur as a result of the jewelry breaking, stretching, or being snagged.

In consideration of receiving this service, I agree to release, waive, and forever discharge Maison Mulki, its employees, agents, and representatives from any and all claims, liabilities, demands, actions, or causes of action arising from any injury, damage, loss, or expense that I may incur as a result of the permanent jewelry application or its subsequent wear, except in the case of gross negligence or willful misconduct by Maison Mulki.

### 3. Care and Removal Policy

1. Aftercare: I acknowledge that I have received and understand the recommended aftercare instructions, including cleaning the jewelry and avoiding undue stress on the chain.

2. Removal: I understand that permanent jewelry must be removed by cutting the chain, usually at the jump ring. I accept that if I require an MRI, X-ray, or surgery, the jewelry MUST be removed beforehand, and this is my sole responsibility.

3. Durability & Repairs: I understand that permanent jewelry is durable but NOT INDESTRUCTIBLE. It may break due to force, stretching, or snagging.

- Initial Repair Window (First 30 Days): If the original weld breaks within 30 days of application, Maison Mulki will attempt to re-weld it at no charge. The client must present the full chain.

- Beyond 30 Days or Lost Chain: Maison Mulki is not responsible for chains that break after 30 days or chains that are lost. Re-welds after 30 days are subject to a \$15 re-welding fee. If the chain is lost, a replacement must be purchased at the current market price.
