Job Description

Role and Responsibilities

CSU Coordinator:

- Provide administrative/clinical oversight and day-to-day management of the CSU.
- Assists residents in gaining needed access to medical, social, education, and other support services within and outside the agency.
- Maintain CSU in a safe, healthy, and sanitary condition per relevant statutes and regulations.
- Coordinate intake and admission procedures for entry into the CSU.
- Prepare and maintain necessary reports, collect required paperwork, and documentation for residents, and organize data collection procedures.
- Coordination of purchasing supplies, and groceries, and other needed items for day-to-day operation of the CSU.
- Coordinate CSU staff training program.
- Schedule and supervise CSU residential staff.
- Coordinate and supervise submission of monthly billing registers.
- Other duties as assigned by Director of Crisis Services

Acute Care Team Clinician

- Provide individual, group, family and consultative services within framework of Acute Care Team.
- Provide service coordination for an assigned group of Acute Care Team clients.
- Participate in client-centered comprehensive assessment of Acute Care Team clients.
- Consult with community agencies and families to maintain coordination of treatment process.
- Provide on-call crisis intervention services related to Acute Care Team.
- Document client progress to maintain a permanent record of client activity according to established methods and procedures.
- Participate in daily crisis staffing/rounds.
- Provision of psychoeducational programming.



- Assist/educate clients towards the development of independent activities of daily living.
- Supervision of other staff requiring supervision for licensure/certification.
- Other duties as assigned by Director of Crisis Services. .

Qualifications and Education Requirements

- Master's degree in human services field.
- Public speaking and training skills preferred.
- Ability to communicate well in verbal/written formats.
- Qualified Mental Health Professional preferred.
- Experience as a supervisor preferred

Special Requirements

- Capability of responding to crises in the community in locales which may not be handicapped accessible.
