COMPREHEND'S DUI PROGRAM

Comprehend's DUI Program has been certified by the Kentucky Cabinet for Health & Family Services since 1992 and is operated under an Alcohol & Other Drug Entity (AODE) license. Comprehend's DUI program is also the only CARF (Commission on Accreditation of Rehabilitation Facilities) accredited program in the Buffalo Trace area. Our DUI program provides assessment, referral, education and treatment for individuals who have been convicted of Driving Under the Influence

HOW TO ENROLL

- Enrollment follows arrest & conviction of a DUI
- Participants may register at one of our 4 outpatient offices.

- DUI assessment consists of completing the Kentucky DUI Test & assessment by a Certified DUI assessor
- Following your assessment, DUI education, treatment or a combination of both may be required



DUI EDUCATION

- Requirement for DUI Education class is determined during assessment
- The DUI Education class curriculum -" Prime for Life" was developed by the Prevention Research Institute
- The class is 20 hours long and has to be taught over the course of several days within a month
- The cost of the class is \$250

PROGRAM COMPLETION

- Once education and/or treatment is successfully completed, as well as all fees paid in full, a completion notice is sent to the participant, court, and the Kentucky Department of Transportation
- Drug screenings may be required as part of the DUI program
