<ul style="list-style-type: none"> The YTC shall provide community outreach and education to referral agencies such as courts, DCBS, schools, etc. and inform them about the availability of SUD and co-occurring treatment services for youth and their families, in order in increase awareness of youth SUD and co-occurring SUD and mental health disorders, available services, and how to make an appropriate referral for services. The YTC shall provide implementation support (e.g., training, coaching, technical assistance) to behavioral health staff across the CMHC (i.e., clinicians, targeted case managers, peer support specialists, prevention specialists, and others) in evidence-based, developmentally-appropriate services and supports (i.e., screening, assessment, treatment, and recovery) specific to youth with or at-risk of developing SUD and co-occurring SUD and mental health disorders. The YTC shall collaborate with and support staff within children's services, substance use services, regional prevention centers, and other CMHC programs that have serve individuals with or at-risk of developing SUD and co-occurring SUD and mental health disorders, youth, and families.
