STAFF SERGEANT . DUTTON, -6156, United States Air Force, 201st Mission Support Squadron, was arraigned at Joint Base Andrews NAF Washington, Maryland, on the following offenses at a court-martial convened by this headquarters.

CHARGE: Article 120 Plea: NG. Finding: NG

SPECIFICATION 1: Did, at or near Cabot, Arkansas, between on or about 31 October 2010 and on or about 11 May 2011, engage in a lewd act, to wit: touching with his hand the genitals of G.S.T., a child who had not attained the age of 16 years. Plea: NG. Finding: NG.

SPECIFICATION 2: Did, within the Commonwealth of Virginia, between on or about 1 March 2011 and on or about 31 May 2011, engage in indecent conduct in the physical presence of M.L.D., a child under 16 years of age, by exposing his genitals and masturbating, with the intent to gratify his sexual desire. Plea: NG. Finding: NG.

SPECIFICATION 3: Did, within the Commonwealth of Virginia, between on or about 1 March 2011 and on or about 31 May 2011, engage in indecent conduct in the physical presence of M.E.D., a child under 16 years of age, by exposing his genitals and masturbating, with the intent to gratify his sexual desire. Plea: NG. Finding: NG.

SENTENCE

The findings were announced by military judge on 22 June 2018.
