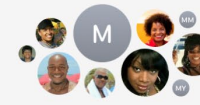


Text Messaging with the Morris Family

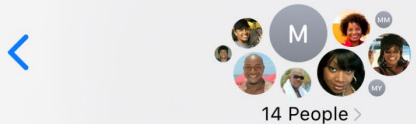
Vann's Lawyer will set a Contradictory and Evidentiary court hearing for Gin & Pop if they do not answer the following two legal questions:

As the Morris Family Land Administrator, Evangelo wanted to understand the Land's Former, Current, and Future growth postures

Point 1: This Satellite Imagery by Mannar Consulting shows how the Tree population of the land was relatively unchanged through 30 years from 1998 - 2018. Between 2005 – 2022.

Point 2: This Flood topography shows how the natural ravine and wetland that runs through the Morris Family Land will expand over the next 30 years. In other words, future use of the land will have less potential than the past use of the land due to the expanding ravine.

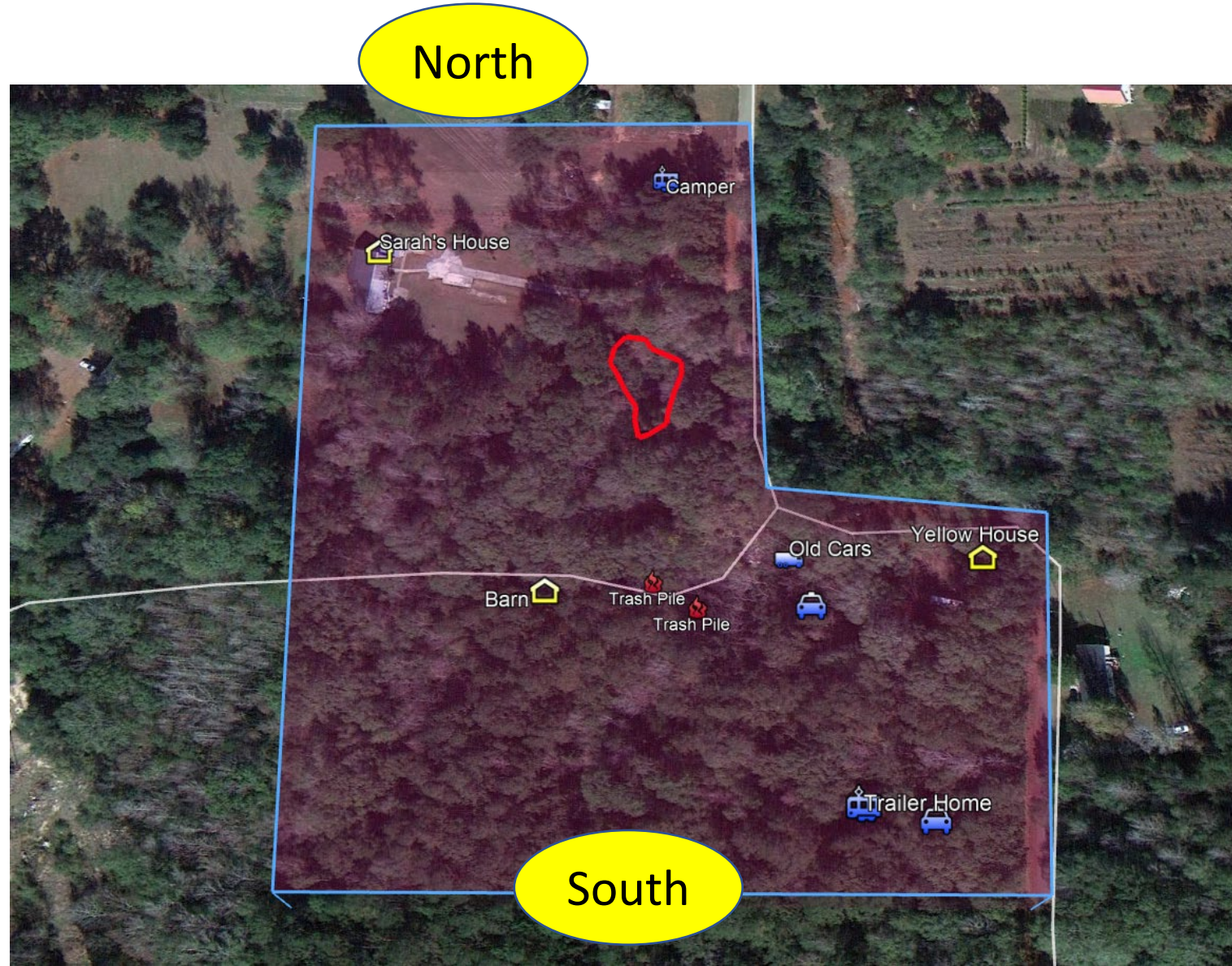
