



## **Boarding Contract**

This Boarding Contract ("Agreement") is made this \_\_\_\_ day of \_\_\_\_\_, 20 \_\_\_\_' by and between The Barking Lot, Glenwood (TBLG) and \_\_\_\_\_ (hereinafter known as "Pet Owner"). WHEREAS, TBLG wishes to provide pet boarding services and the Pet Owner wishes to accept such services on the terms and under the conditions described below; The Parties intend to be legally bound, herby agree as follows:

1. Prices for Services are detailed in our Service and Price Guide. Payment in full for all services is required at the time that the Pet(s) is/are picked up. A deposit may be required at the time of drop-off and/or when the boarding reservation is scheduled. Prices are subject to change at any time without notice; however will not change during a boarding period.
2. TBLG reserves the right to not accept any pet into the boarding program for any reason. All rules of the facility are subject to change at the sole discretion of TBLG.
3. Pets are boarded in kennels and will be left unattended overnight; however monitoring will be done periodically in the evening hours
4. Should there be a medical emergency of any kind; Pet Owner gives TBLG permission to place the Pet in the Veterinary Clinic of their choice listed on the Registration Form. If said Veterinary Clinic cannot be reached the Veterinary Clinic of choice by TBLG will be used, which is listed below. The Pet Owner agrees to pay any and all charges incurred for the treatment of the pet (s) in full at the time of the pet(s) pick up.
5. Pet Owners agree to hold TBLG its members, owners, directors, officers, agents, employees and lessors of the premises, harmless from any and all claims for loss or injury (including legal fees) which may be alleged to have been caused directly or indirectly to any person or thing by the act of the pet, and the Pet Owner personally assumes all responsibility and liability for any such claim(s).
6. Pet Owner understands that while TBLG takes all reasonable steps to avoid communicable diseases, there is still a risk of acquiring a communicable disease while in our boarding program. In the event that the pet(s) contracts such disease while in our care the Pet Owner assumes all the risks and accepts the responsibility for the cost of all treatments. Pet Owners further agrees to hold the owners and staff of TBLG harmless for expenses incurred for such treatment. (i.e. While there is a vaccine for kennel cough, it is similar to a human flu vaccine in that it does not protect against every strain of kennel cough out there. There are many different strains of kennel cough. Even though the Pet is vaccinated, there is still a risk of them contracting this illness.)
7. Pet Owners agree that TBLG is not responsible for the damage of any belongings, such as blankets, toys, beds or anything that is brought by the Pet Owner with the Pet.

8. Pet Owner certifies that he/she is the actual owner of the pet(s), or is the duly authorized agent of the actual owner whose name is entered above.
9. Pet Owner represents that the pet is free of any infectious disease and has been vaccinated with all the required vaccinations as outlined in the Requirements for Boarding. Pet Owner represents that the pet is also free of contagious parasitic problems, whether internal or external (including Fleas), and is free from any contagious skin disorder. Pet Owner understands that pet(s) will be treated for any parasitic problems by TBL,G and/or Veterinary Clinic of choice by TBL,G which is listed below understands that the Pet Owner is responsible for the charges of the treatment.
10. Pet Owner is aware that there is inherent risk of illness and injury when dealing with animal(s).
11. Pet Owner understands that if the pet(s) is/are not picked up within 5 days of the agreed upon pick-up date, a certified letter will be sent to the address provided by the Pet Owner regarding the abandonment of the animal. Should the animal(s) not be removed from TBL,G within the specific time, Pet Owner relinquishes all claims to the animal(s); however shall not be relieved of the contractual liability of any treatment, boarding or care provided.
12. Pet Owner represents that the information provided on all of the forms signed and submitted to TBL,G, including but not limited to the Boarding Registration Form, The Consent to Treat Form, Social Media Form, Medication Form, is true and that TBL,G can rely on the accuracy of the said information.
13. By Signing the form the Pet Owner states that he/she has read and understands the Requirements for Boarding at TBL,G.
