Over the past twenty years, the Outlaws have performed many honorable duties on behalf of the Guitrau family. On a continual basis, they honored Catherine Brown Guitrau with flowers on her birthday, and currently place flowers on the graves of Edgar Paul and Catherine Guitrau. Other noteworthy gifts over the years have been reclining chairs, televisions, thoughtful notes and proclamations for sick and ailing Guitrau members and friends.

In 1993, recognizing the aging process, the original Outlaw's amended their corporate charter to allow other people married to Guitrau blood the right to join the Outlaws. This "right to membership" is conditional on a blood test confirming no Guitrau blood runs in your veins and the all-important payment of dues. At their annual meetings, their corporate physician, Dr. Blood, performs the necessary tests for admission. In addition, an original Outlaw must act as your sponsor. Since 1994, fourteen additional people have joined the Outlaws and form the branch "Outlaws II." The Outlaws II continue the honorable and charitable work of the group of serving the Guitrau family and are instrumental in the continuation of the Guitrau family reunion.

Of the original Outlaws, Parker Gabriel and Jack Allen are deceased as of this publication.

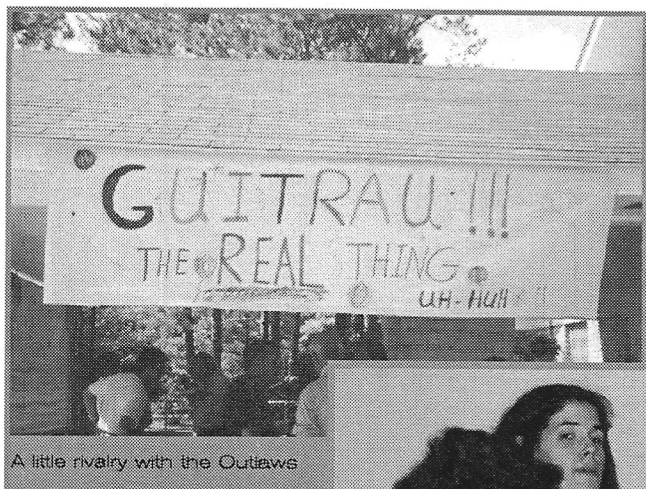

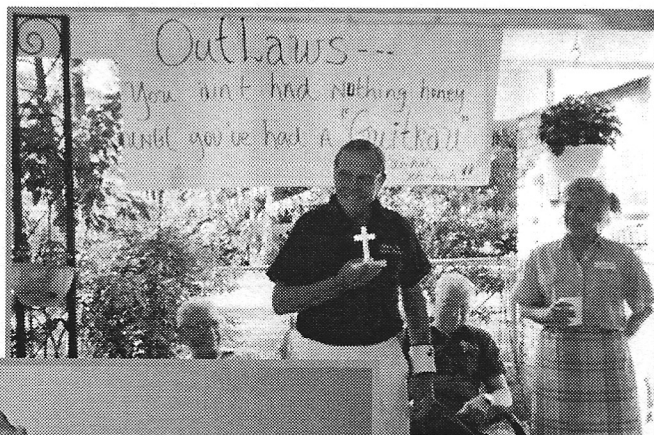
