NSRA Official Rule Book – 2025

MEMBERSHIP –Page 7 (Original By-Law Chg. Approved by General Membership Ballot 2025 – Amended by Executive Board 11.2025)

#8 – Any judge wanting to work the NSRA Finals must judge two (2) first-approved rodeos. *Any contract personnel who purchases a NSRA card and works one (1) first approved rodeo will have their name on the Year-End Awards Ballot. AND*

POINT AWARD STANDINGS, PRIZES and CHAMPIONSHIPS – Page 17

#11 – In all events, only finals contestants will be eligible to vote for selecting the rodeo stock that will be used at the finals in their respective events. All members will vote on year end personnel (i.e. timers, bullfighter, judges and announcer). Finals personnel will be hired by Executive Board. *To be eligible to work the NSRA Finals, judges must judge two (2) first-approved rodeos, other contract personnel must work (1) first-approved rodeo during the season.* Stock of the Finals will be chosen at the Finals.

MEMBERSHIP –Page 7-8 (Approved by Executive Board 11.2025)

#9 – Executive Board Members receive a free membership each year if they attend one-half of the meetings for that year. *Event Directors receive a free membership each year if they attend 2 meetings.* Failure to meet these guidelines results in being billed for full membership dues.

RODEO COMMITTEE AND NSRA APPROVED RODEOS – Page 13 (Approved by Executive Board 09.2025)

#7 – All contestants will be assessed a \$27 office charge per contestant per rodeo. Of this office charge, \$13 will remain with the committee, \$11 will be remitted to the NSRA for finals awards and the central entry system, and \$3 will be paid to the judges.

GENERAL TIMED EVENT RULES – Page 28 (Approved by General Membership Discussion/Ballot 2025) –

#24 (**New Rule**/**Note**) – Rule regarding the use of extra animals in cases of escape, injury, missed times or barrier fouls during performances and finals will be addressed thru a ground rule at certain rodeos. Be sure to check the entry information for the details at each rodeo.

GENERAL TIMED EVENT RULES – Page 28 (Approved by General Membership Ballot 2025) –

#25 (**New Rule**) – It will be the judge's responsibility to find at least 1, if not 2 liners for the tie down and breakaway roping. Failure to do so results in a \$50 fine for each judge.

RANCH BRONCS – Page 26 (Approved by General Membership Ballot 2025) –

#13 (**New Rule**) – At any first approved/sanctioned NSRA rodeo, a re-ride will be required at the time of the draw. Failure to draw a re-ride at the time of the draw, will result in a \$150 fine, assessed to the stock contractor.

LADIES BARREL RACING – Page 34 (Approved by General Membership Ballot 2025) –

#8 – Remove the sentence – There will be a limit of 10 barrel racers.....change to say: *A rodeo/committee can take as many barrel racers as they wish in a performance but there will be a mandatory tractor rake at either 5 if 10 runners in a performance or after 6 if taking 12 in performance or 5 if taking 15. Same drag number will apply in slack. Also, suggested to tractor drag arena before barrels start.*
