Comes Now, Elijah Shane Codner, Petitioner in Proper Person, with this 28 U.S.C. § 2241 **Petition for Writ of Habeas Corpus** for the Court to review the State's claim [in Case # 24003151CF10A in the 17th Circuit - Broward County Florida] and determine whether or not the lower court has lawful authority and jurisdiction to hold or order Petitioner into custody without proper consent; and states the following:

Jurisdiction

This Court has original jurisdiction to hear nationally important cases involving sovereigns and ministers according to Article 3, Section 2 of the Constitution of the United States and the first Amendment to petition the government for redress of grievance.

Brief Statement of Case

Petitioner is not the same person as described on the State's Information document (see Exhibits 1- 2):

- 1. Petitioner was unlawfully arrested and falsely charged.
- 2. Petitioner was held in jail for over 30 days without first appearance or arraignment.
- 3. The trial court appointed the Public Defender to legally represent Petitioner without proper consent and authority.
- 4. Petitioner is currently being held involuntarily (without proper consent) at Larkin Community Hospital.

History

Petitioner was unlawfully taken into custody on 3-19-2024 by the Broward County Sheriff in Fort Lauderdale, Florida. Petitioner was falsely charged by the Assistant State Attorney for Broward County on 4-19-2024. Petitioner was held in jail for over 30 days without first appearance or arraignment. Petitioner file a Demand to Prove Jurisdiction with the trial court on 4-24-2024. Petitioner was then immediately sent to Larkin Community Hospital Behavioral Health Services in Hollywood, Florida on 4-24-2024 without any hearings, motions or prior evaluations.

Conclusion

Petitioner's Constitutional rights were violated and he now seeks redress/relief from this Court. Let this Court order that the Body be brought before it within 3 days of this Lawful and Legal Notice or be release from the State's custody with the Noted remedy.
