**You must be current in CPR in order to attend First Aid. CPR renewal requires only day one.**

**CPR:** Participants in this course will receive American Red Cross Adult, Infant and Child CPR certification, valid for 2 years from date of completion, effective Jan 1, 2011. Updated ARC 2011 basic emergency procedures and techniques for cardiopulmonary resuscitation, choking and heart attacks are provided. (AED-Optional). The instructional vehicles used in this course include video, a participant + CHAR(39) + s workbook, role play with mannequins, and lecture, and are administered by an American Red Cross certified instructor.

**9:00 AM to 12:00 PM (Unless Indicated)**

**FIRST AID:** Participants in this course will receive American Red Cross Community First Aid and Safety certification, valid for 2 years from date of completion, effective January 1, 2011. Updated ARC 2011 basic emergency responses to bleeding, shock, burns, muscle, bone, joint, head & spine injuries, bites, stings, and sudden illness are provided. The instructional vehicles used in this course include video, first aid kits, role play, and lecture, and is administered by an American Red Cross certified instructor. Community/ Standard CPR is a prerequisite for enrollment in this course. Recertification is required every 2 years effective Jan. 1, 2011.
