**JENNIFER BAITY, LCSW, LAADC** is a licensed clinical social worker and licensed advanced alcohol and drug counselor. She is the Program Director at the Mental Health Rehabilitation Center at Zuckerberg San Francisco General Hospital. She provides staff and intern supervision and training; provides individual, group, and family treatment for adults with serious and persistent mental illness who also have problematic substance use histories; and co-developed the co-occurring disorders (dual diagnosis) program at the San Francisco Behavioral Health Center. She has provided in-depth training to clinicians providing services to youth and adults since 1991 and regularly trains staff in mental health and substance abuse programs throughout the San Francisco Bay Area and beyond. She specializes in training on diagnosis and treatment of individuals with co-occurring mental health and substance use conditions and motivational interviewing.

Help your clients develop motivation to change problem behaviors (e.g. substance abuse/dependence). Motivational interviewing is a client-centered, directive method for enhancing intrinsic motivation to change by exploring and resolving ambivalence. The two day workshop includes Beginning, Intermediate and Advanced Motivational Interviewing as well as an overview of Stages of Change.
