- 1) Leif called the meeting to order at 6:35pm.

- 3) The financial report was given by Cherie. Time period November 30, 2023 - January 25, 2024.
- 4) Discussion concerning renewal of BFCC Hall cleaning contract with Jackie Composto. Mindy made a motion to have Tiffany sign the annual contract with this third party vendor, seconded by Sherrie. Motion adopted by unanimous consent.

- 10) Black Forest Festival discussion. Tiffany discussed several aspects of the event and the lack of volunteers to assist with the event. Insurance and liability concerns were also discussed. Mindy made a motion to downsize the event and remove the parade from the festival, Leif seconded. Adopted by unanimous consent.
