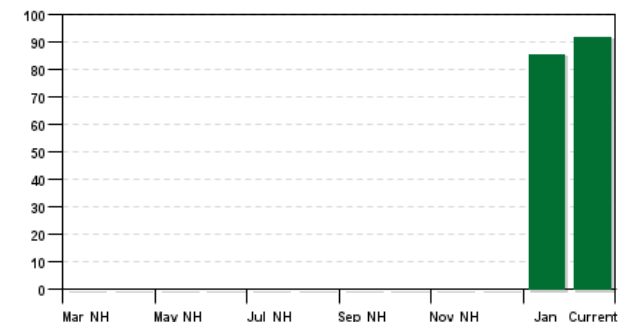

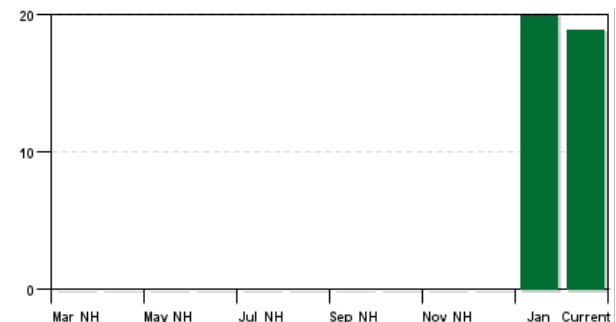
The following graph contains the CREDIT SCORE for the last 12 months.
