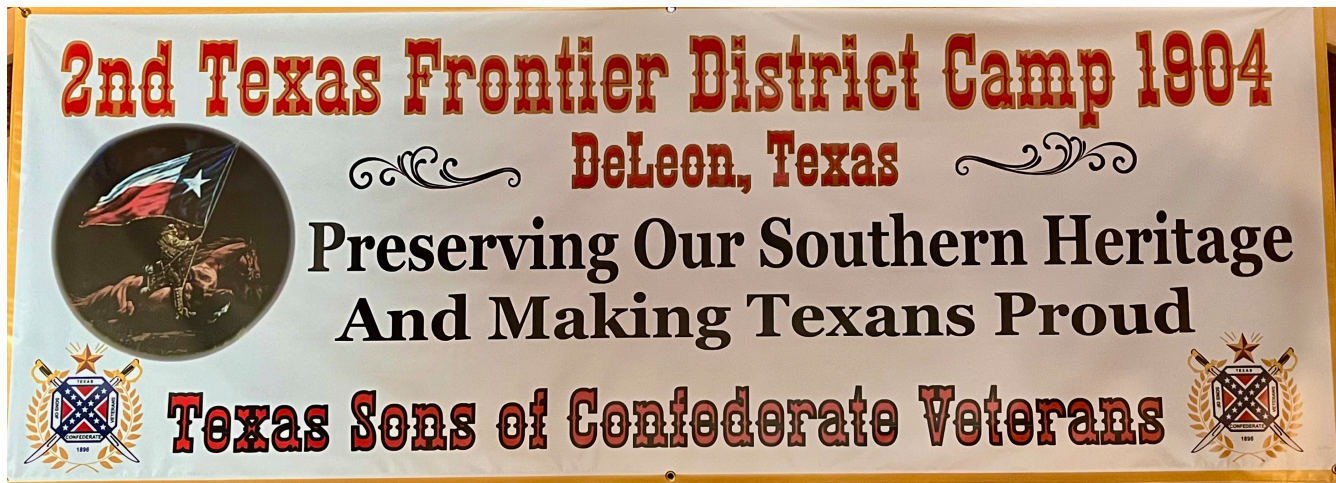

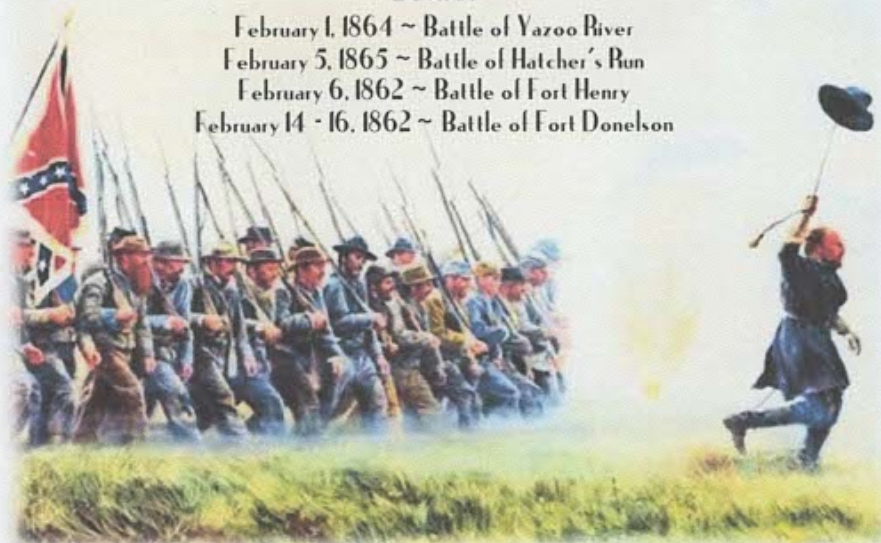
February in Confederate History

Birthdates

- February 2, 1803 ~ General Albert Sidney Johnston 
- February 3, 1807 ~ General Joseph E. Johnston
- February 6, 1833 ~ Major General James Ewell Brown "JEB" Stuart
- February 6, 1834 ~ Major General William Dorsey Pender
- February 11, 1812 ~ Vice President Alexander Hamilton Stephens
- February 18, 1817 ~ Brigadier General Lewis A. Armistead

- February 1, 1864 ~ Battle of Yazoo River
- February 5, 1865 ~ Battle of Hatcher's Run
- February 6, 1862 ~ Battle of Fort Henry
- February 14 - 16, 1862 ~ Battle of Fort Donelson



High Water Mark of the Confederacy

On July 3rd at the Battle of Gettysburg, Armistead was mortally wounded while leading his brigade in Pickett's Charge. Armistead led from the front, waving his hat from the tip of his saber and urging his men to "Remember what you are fighting for – your homes, your friends, your sweethearts!" He reached the stone wall at the "Angle" which served as the charge's objective. The brigade got farther in the charge than any other, an event known as the HIGH WATER MARK OF THE CONFEDERACY but was overwhelmed by federals. Shot three times just after crossing the wall, Armistead died 2 days later.

General Lee wrote in his report, "Brigadier-Generals Armistead, Barksdale, Garnett and Semmes died as they had lived, discharging the highest duties of patriots with devotion that never faltered and courage that shrank from no danger."

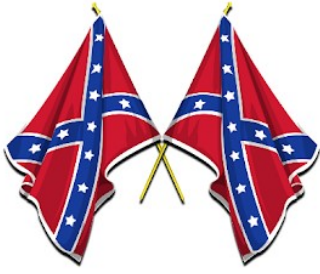
