7PM Paul Hutcheson offered the blessing and invocation.

7:30 Meeting called to order. Pledges US, Texas and CSA Reading of the Charge Program by Dave Guise: "Truth about the Pledge"

Business Section

Current Adjutant Eddie Cox declared a quorum IS achieved.

Eddie Cox submits Treasurer 's report: \$2,781.55

January 2024 Minutes stand approved.

Swearing in of new member: Harley Tyler

Commander calls for Officer reports:

1st Lt. Commander-Dave Guise - Announced Steve Bondy moved to AZ and new 2nd Lt will be needed.

2nd Lt. Commander- see new business

3rd Lt. Commander-Charles Ditmore: Cemetery Flags ordered, received and ready for distribution tonight. Some delivered to members.

OCR-Becky Bussey - Not present-Brenda Guise announced Black Rose Ceremony March 9 by request. UDC donated book for June Silent Auction.

Events-Dave Guise: all reported above. Eddie Cox added new Event April 26 in Goldthwaite. BBQ cook-off.

Membership & Recruitment- nothing at this time

Programs-March-"History of the Comanche County Square by Eddie Cox

Flags-Tommy Alford-: All in good shape

Cemetary-Eddie Cox.- Need to set a workday soon. reminds all to put flags out **Newsletter-Brenda Guise-** request ancestor birth month

Old Business: Motion by Dave Guise to move meetings to Hwy6 Cafe in DeLeon, 2nd by Mason Spikes. Discussion began with Eddie Cox opposing. stating concern for storage of flags/banners. Stating he would resign from Color Guard if the camp moved to DeLeon. Eddie also reported that Camp1904 had no contract with the Comanche Mercantile so the "\$40" in question is not required. Next Charles Ditmore spoke in opposition saying he paid the \$40 out of his pocket and planned to continue. Tommy Alford injected that the Camp should put out a kitty jar for everyone to contribute. Charles D. continued by saying 1904 never paid the \$40 out of Camp funds. He added in years past the Camp always had sandwiches and that was fine till the women became involved and made it a competition against each other. He said he felt these "meals" were not necessary. Dave Guise spoke in favor of the move stating he felt the "DeLeon" camp should move back to it's Charter town- Hwy6 Cafe offered no charges, no set up or clean up and food from a menu. Commander Hutcheson asked for any other meeting sites-none offered. He then called for Vote to move to Hwy6 Cafe in DeLeon.

3 in favor 4 Against. Motion Failed.

New Business: Replacement of Steve Bondy as 2nd Lt. Mason Spikes nominated himself, 2nd by Dave Guise. Unanimous vote in favor.

Eddie Cox stated the Comanche Museum event for April 20th needed 4 volunteers. Jim Harvey spoke concerning the lack of gun raffle sales. Reminding everyone this is funding of the 2025 Reunion. March in History



Confederate Flag Day

On March 04, 1861, the First National Flag of the Confederate States of America (known as the "Stars and Bars") was revealed and raised over the original Confederate Capitol at Montgomery, Alabama.

The following description of events comes from the Montgomery Weekly Advertiser of March 06, 1861:

"The fourth day of March was an eventful day in the Provisional Capitol of the Confederate States of America...At half past three PM...; the Flag of the Confederate States of America was flung out to the breeze from the staff on the Capitol and as it's proud folds gradually unclosed, it seemed to wave defiance to the Northern wind that came rushing down from the Potomac..."

"A large concourse of spectators had assembled on Capitol Hill, and Miss L.C.T. Tyler, one of the fair descendants of the Old Dominion, and a granddaughter of the venerable Ex-President of the late United States, had been selected to perform the principal part upon this occasion.

When the time had arrived for raising the banner, Miss Tyler steadily, and with her heart throbbing with patriotic emotion, elevated the banner to the summit of the staff. Cannon thundered forth a salute, the vast assemblage rent the air with shouts of welcome, and the people of the South had for the first time a view of the Southern Flag."

I salute the Confederate Flag with affection, reverence, and undying devotional for the cause in which it stands.
