**\*\*If your application is accepted, you will need to provide the following within 10 days of receiving the acceptance email:\*\***

- Proof of Commercial Liability Insurance for \$1 million per occurrence, naming Coopersburg Farmers Market and Coopersburg Borough as additionally insured.

- Copies of any applicable permits and licenses.

**A non-refundable deposit of \$25 is required and will be included in your total fee.**

**- Each appearance will incur a \$75 charge, this includes the deposit; WE DO NOT TAKE A PERCENTAGE OF YOUR SALES.**

**Remainder can be paid the day of the market.**

**Please note: On the day of the market, you can start setting up as early as 8:45am. You MUST be set up and ready to sell products/items no later than 9:55am, the market will open promptly at 10am.**

**Acceptance into the market after 10 am will not be permitted**

**No vendors are allowed to leave early. If you sell out of all products, you must remain at the market until 1 PM.**

Therefore, if you have a larger menu, please select your best-selling items and limit your offerings to a maximum of 10 choices..**
